



The OBCE is currently providing support to volunteer committees of chiropractic physicians serving on seed panels, a nominal panel and a Delphi panel to continue development of the Educational Manual for Evidence Based-Chiropractic (EMEBC) at a cost of approximately 3% of OBCE's total budget. The EMEBC is intended to be a series of systematically developed statements which may assist practitioners and patients in making appropriate health decisions. Updated standards of practice also result from high levels of evidence and professional consensus.

Currently, the OBCE has authority in Oregon Revised Chapter 684 to recover costs associated with the investigation and proceedings against a licensed chiropractic physician that result in a final disciplinary order. A previous Legislature determined it appropriate that the respondent licensee bear at least some of the cost of disciplinary proceedings.

Some members of the Oregon State Bar are seeking legislation in the 2005 Oregon Legislature to repeal cost recovery provisions for all state licensing boards with this authority. They have proposed that the cost should be entirely borne by the regulatory agency (funded by license fees). They argue the current law may be a barrier to the respondent licensee/doctor utilizing their rights to a proper defense and contested case hearing. The OBCE has recovered a portion of costs in some cases.
