Appeal Procedures*

DLCD ACKNOWLEDGMENT or DEADLINE TO APPEAL: April 13, 2007

This amendment was submitted to DLCD for review 45 days prior to adoption. Pursuant to ORS 197.830 (2)(b) only persons who participated in the local government proceedings leading to adoption of the amendment are eligible to appeal this decision to the Land Use Board of Appeals (LUBA).

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

*NOTE: THE APPEAL DEADLINE IS BASED UPON THE DATE THE DECISION WAS MAILED BY LOCAL GOVERNMENT. A DECISION MAY HAVE

BEEN MAILED TO YOU ON A DIFFERENT DATE THAN IT WAS MAILED TO DLCD. AS A RESULT YOUR APPEAL DEADLINE MAY BE EARLIER

THAN THE ABOVE DATE SPECIFIED.

- 5. The deadline to appeal will be extended if you submit this notice of adoption within five working days of the final decision. Appeals to LUBA may be filed within TWENTY-ONE (21) days of the date, the "Notice of Adoption" is sent to DLCD.
- 6. In addition to sending the "Notice of Adoption" to DLCD, you must notify persons who participated in the local hearing and requested notice of the final decision.

ORDINANCE NO. 07-825-O

AN ORDINANCE Rezoning 0.7 acres near the intersection of Suncrest Road with Highway 99 from Highway Central Business District (CBH) to High-Density Residential (RM-22)

The City of Talent ordains as follows:

Section 1. COMPREHENSIVE PLAN AMENDMENT

The Land Use Map designation of the property labeled as "Parcel 2" in Exhibit A is changed from Commercial to High-Density Residential.

Section 2. REZONE

The zoning designation of the property labeled as "Parcel 2" in Exhibit B is changed from Central Business Highway District (CBH) to Residential-Multiple-Family-High-Density (RM-22).

Section 3. ZONING MAP AMENDMENT

The Zoning Map of the City of Talent shall be amended by the City Planner and be endorsed by the Mayor with the number of this Ordinance.

Section 4. EFFECTIVE DATE

Under the provisions of the Talent Charter of July 1998, Chapter VIII, Section 33, this ordinance shall take effect 30 days following adoption.
