## DLCD ACKNOWLEDGMENT or DEADLINE TO APPEAL: February 7, 2008

This amendment was submitted to DLCD for review prior to adoption with less than the required 45-day notice. Pursuant to ORS 197.830 (2)(b) only persons who participated in the local government proceedings leading to adoption of the amendment are eligible to appeal this decision to the Land Use Board of Appeals (LUBA).

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

\*NOTE: THE APPEAL DEADLINE IS BASED UPON THE DATE THE DECISION WAS MAILED BY LOCAL GOVERNMENT. A DECISION MAY HAVE BEEN MAILED TO YOU ON A DIFFERENT DATE THAN IT WAS MAILED TO DLCD. AS A RESULT YOUR APPEAL DEADLINE MAY BE EARLIER THAN THE DATE SPECIFIED ABOVE.

## ORDINANCE NO. 07-641-0

AN ORDINANCE RE-ZONING PROPERTY LOCATED AT 1950 NINTH STREET, COLUMBIA CITY, OREGON, IDENTIFIED ON THE COLUMBIA COUNTY TAX MAPS AS 5128-024 TAX LOT 201.

The City of Columbia City ordains as follows:

Section 1: The real property owned by Wayne and Joan Marie Navolynski, located at 1950 Ninth Street, Columbia City, identified on the Columbia County Tax Maps as 5128-024 Tax Lot 201, and described in Exhibit "A" attached hereto and incorporated herein, was previously annexed to the City of Columbia City and incorrectly zoned R-1, Residential Low Density at the time of the annexation

<u>Section 2:</u> Pursuant to Columbia City Development Code 7.145.070, and consistent with the adopted Comprehensive Plan and Zoning Map, the property described in Section 1 above is hereby re-zoned from R-1, Low Density Residential to R-2, Moderate Density Residential.

<u>Section 3:</u> In support of the above, the City Council hereby adopts the findings, conclusions and recommendations contained in the staff report dated November 6, 2007, regarding the re-zoning of the property.

**Section 4:** The effective date of this re-zoning shall be 30 days after the date of adoption of this ordinance.
