If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). ORDINANCE NO. 2974 CITY OF COTTAGE GROVE

AN ORDINANCE AMENDING SECTION 5.1.500(A)(4) OF TITLE 14 OF THE COTTAGE GROVE MUNICIPAL CODE

THE CITY OF COTTAGE GROVE ORDAINS AS FOLLOWS:

- Purpose. The purpose of this ordinance is to amend Section Section 1. 5.1.500(A)(4) of Title 14 of the Cottage Grove Development Code to clarify that Class C Variances may not be approved for 'maximum density'.
- Procedural Compliance. This amendment is in compliance with Section 14.4.7 of the Municipal Code of the City of Cottage Grove and is based upon the City Council's determination, after a Planning Commission public hearing and recommendation, that this amendment is a proper implementation of the comprehensive land use plan and, therefore, is in the public interest for the health, safety and welfare of the residents of the City of Cottage Grove.
- Amendment. Section 5.1.500(A)(4) of Title 14 of the Cottage Section 3. Grove Municipal Code is amended to read as follows:

"A. **Applicability**

- 4. A variance shall not be approved that would vary the "permitted uses" or "prohibited uses" or "maximum density" of a land use district (Article 2).
- Effectiveness. This ordinance shall be effective 30 days of Section 4. adoption pursuant to the City Charter and prior to acknowledgement pursuant to ORS 197.625(3)(a).
