Appeal Procedures*

DLCD ACKNOWLEDGMENT or DEADLINE TO APPEAL: Monday, August 03, 2009

This amendment was submitted to DLCD for review prior to adoption

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

*<u>NOTE:</u> THE APPEAL DEADLINE IS BASED UPON THE DATE THE DECISION WAS MAILED BY LOCAL GOVERNMENT. A DECISION MAY HAVE BEEN MAILED TO YOU ON A DIFFERENT DATE THAT IT WAS MAILED TO DLCD. AS A RESULT, YOUR APPEAL DEADLINE MAY BE EARLIER THAN THE ABOVE DATE SPECIFIED.

City of Rufus Ordinance # An Ordinance Amending the Comprehensive Plan/Zoning Map to Redesignate Certain Tax Lots in the City as Residential 10 and Residential 5 and Declaring An Emergency

Findings of Fact:


- 1. John Schmidt of Gorge Vista LLC Inc. requested a Comprehensive Plan/Zoning Map Amendment to rezone 130 acres of property they own in the City of Rufus from Residential Agricultural (RA) to R-10 and 5 acres of R-10 to R-5 to allow for the development of a subdivision.
- 2. The property is legally described as Section 6, Township 2 North, Range 17 East, Tax Lots 2500 & 2100, Sherman County, Oregon.
- 3. The proper notices, including notice to DLCD, notice to adjoining property owners, and notice in the local newspaper were posted by the Sherman County Planning Staff.
- 4. The Rufus City Council conducted a public hearing on May 13, 2009 to consider the proposed map redesignation.
- 5. John Schmidt spoke as a proponent to the project. No opponents were heard.
- 6. At the conclusion of the public hearing, the City Council moved unanimously to approve the proposed amendment.

NOW, THEREFORE, the City of Rufus hereby ordains that:


- 1. Section 6, Township 2 North, Range 17 East, Tax Lot 2500 of which 31 acres be rezoned to R-10 and Tax Lot 2100 of which 100 acres be rezoned to R-10 and 5 acres to be rezoned to R-5.
- 3. Inasmuch as the health, general welfare, and economic well being of the County is dependent upon getting this facility up and in operation as quickly as possible, an emergency is hereby deemed to exist and this ordinance shall become in full force and effect upon its passage by the City Council.
