This amendment was not submitted to DLCD for review prior to adoption pursuant to OAR 660-18-060, the Director or any person is eligible to appeal this action to LUBA under ORS 197.830 to 197.845.

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

*NOTE: The Acknowledgment or Appeal Deadline is based upon the date the decision was mailed by local

government. A decision may have been mailed to you on a different date than it was mailed to DLCD. As a result, your appeal deadline may be earlier than the above date specified. <u>NO LUBA</u> Notification to the jurisdiction of an appeal by the deadline, this Plan Amendment is acknowledged.

The City of Brookings ordains as follows:

<u>Section 1.Ordinance Identified.</u> This ordinance adds Section 17.172.090, Subdivision Replat, to Chapter 17.172, Land Divisions, of Brookings Municipal Code Title 17, Land Development Code.

Section 2. Adds Section 17.172.090, Section 17.172.090, Subdivision Replat, is added to read as follows:

Chapter 17.172 LAND DIVISIONS

17.172.090, Subdivision Replat. The act of replatting shall allow the reconfiguration of lots and public easements within a recorded plat. A replat shall comply with all applicable subdivision standards as found in 17.172.070, BMC. Staff will advise the applicant concerning the required materials and criteria to be addressed based on the specific proposal.

<u>Background/Discussion</u>: Reconfiguring a recorded subdivision is called a "replat" in survey law. It can be as simple as creating two lots out of one or involve a significant reconfiguring of several lots and streets. Appropriate subdivision standards apply depending on the complexity of the proposal. The City's Code presently has no language addressing this type of application.

The proposed draft language is:

"17.172.090 Subdivision Replat. The act of replatting shall allow the reconfiguration of lots and public easements within a recorded plat. A replat shall comply with all applicable subdivision standards as found in 17.172.070, BMC. Staff will advise the applicant concerning the required materials and criteria to be addressed based on the specific proposal."

Previously the subdivision standards and fee were used to process a replat. On March 14, 2011, the City Council adopted a new fee for replats. It is a "cost recovery" fee. If the proposal is a simple lot split the base fee is approximately the same as a partition fee. If the proposal is a more complicated reconfiguration the fee charged will reflect the true costs of processing that specific application. This results in equitable costs for the applicant.

The Planning Commission reviewed this draft language and recommended approval.

The draft language proposed is as follows:

"17.172.090 Subdivision Replat. The act of replatting shall allow the reconfiguration of lots and public easements within a recorded plat. A replat shall comply with all applicable subdivision standards as found in 17.172.070, BMC. Staff will advise the applicant concerning the required materials and criteria to be addressed based on the specific proposal."

Previously the subdivision standards and fee were used to process a replat. On March 14, 2011, the City Council adopted a new fee for replats. It is a "cost recovery" fee. If the proposal is a simple lot split the base fee is approximately the same as a partition fee. If the proposal is a more complicated reconfiguration the fee charged will reflect the true costs of processing that specific application. This results in equitable costs for the applicant.
