DLCD ACKNOWLEDGMENT or DEADLINE TO APPEAL: Thursday, May 24, 2012

This amendment was submitted to DLCD for review prior to adoption pursuant to ORS 197.830(2)(b) only persons who participated in the local government proceedings leading to adoption of the amendment are eligible to appeal this decision to the Land Use Board of Appeals (LUBA).

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

- *<u>NOTE:</u> The Acknowledgment or Appeal Deadline is based upon the date the decision was mailed by local government. A decision may have been mailed to you on a different date than it was mailed to DLCD. As a result, your appeal deadline may be earlier than the above date specified. <u>NO LUBA</u> Notification to the jurisdiction of an appeal by the deadline, this Plan Amendment is acknowledged.

- 5. Deadline to appeals to LUBA is calculated twenty-one (21) days from the receipt (postmark date) by DLCD of the adoption (<u>ORS 197.830 to 197.845</u>).

ORDINANCE NO. 4584

AN ORDINANCE AMENDING ORDINANCE NO. 2050, THE DEVELOPMENT CODE, TO CORRECT MINOR ERRORS IN THE TEXT, INCLUDING FORMATTING, AND TO MAKE CHANGES IN THE CODE TO MAKE IT MORE INTERNALLY CONSISTENT AND EASIER TO UNDERSTAND AND APPLY. (TA 2011-0004)

- WHEREAS. in October 2011, City staff submitted a proposed Omnibus text amendment to the Development Code to address minor errors and inconsistencies and to codify recent Director's Interpretations; and
- the Planning Commission conducted a public hearing on March 7, 2011, to WHEREAS, consider the proposed amendment, considered the submitted staff report and exhibits, and voted to recommend that the City Council adopt the proposed amendments to the Development Code as is summarized in Land Use Order No. 2280: and
- WHEREAS, no appeal of the Planning Commission recommendation was filed with the City; and
- the Council adopts and incorporates Land Use Order No. 2204 as to the WHEREAS applicable criteria and findings for the following; now, therefore,
