This amendment was submitted to DLCD for review prior to adoption. Pursuant to ORS 197.830(2)(b) only persons who participated in the local government proceedings leading to adoption of the amendment are eligible to appeal this decision to the Land Use Board of Appeals (LUBA).

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

WHEREAS, on May 12, 2009, at a duly noticed public hearing the City Council voted unanimously to initiate an amendment to the text of the Donald Development Ordinance to create a new Employment Industrial zone and an amendment to the text of the Donald Comprehensive Plan's Industrial Lands Policy (Planning File – Case No. 09-1); and

WHEREAS, on May 19, 2009 the Planning Commission conducted a duly noticed public hearing regarding Planning File – Case No. 09-1, an application by the City of Donald regarding an amendment to the text of the Donald Development Ordinance and an amendment to the text of the Donald Comprehensive Plan, at which time the public was given a full opportunity to be present and heard on the matter.
