Appeal Procedures\*

### DLCD ACKNOWLEDGMENT or DEADLINE TO APPEAL: May 23, 2007

This amendment was submitted to DLCD for review 45 days prior to adoption. Pursuant to ORS 197.830 (2)(b) only persons who participated in the local government proceedings leading to adoption of the amendment are eligible to appeal this decision to the Land Use Board of Appeals (LUBA).

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

THE APPEAL DEADLINE IS BASED UPON THE DATE THE DECISION WAS MAILED BY LOCAL GOVERNMENT. A DECISION MAY HAVE BEEN MAILED TO YOU ON A DIFFERENT DATE THAN IT WAS MAILED TO DLCD. AS A RESULT YOUR APPEAL DEADLINE MAY BE EARLIER THAN THE ABOVE DATE SPECIFIED.

This matter coming regularly before the Board of County Commissioners, and it appearing that Troy Tracy made application for a Comprehensive Plan amendment and zone change on property described as T2S, R3E, Section 35, W.M., Tax Lot 1200, located approximately .41 miles northeast from the intersection of Springwater Road and Eaden Road on the north and west side of Eaden Road; and

It further appearing that planning staff, by its report dated March 13, 2007, recommended denial of the application; and

It further appearing that the Planning Commission, at its March 19, 2007 meeting, recommended approval of the application; and

It further appearing that after appropriate notice a public hearing was held before the Board of County Commissioners on April 18, 2007, at which testimony and evidence were presented, and that a preliminary decision was made by the Board on April 18, 2007;

Based upon the evidence and testimony presented, this Board makes the following findings and conclusions:

- 1. The applicant requests approval of a Comprehensive Plan map amendment from Agriculture to Forest and zone change from EFU to AG/F.
- 2. Both the property itself and the surrounding area contain a mixture of agriculture and forest uses such that the AG/F zone is appropriate.
- 3. This application meets all relevant criteria in the Statewide Goals and administrative rules, the Comprehensive Plan and the Zoning and Development Ordinance.
