Appeal Procedures*

DLCD ACKNOWLEDGMENT or DEADLINE TO APPEAL: Thursday, May 26, 2011

This amendment was submitted to DLCD for review prior to adoption pursuant to ORS 197.830(2)(b) only persons who participated in the local government proceedings leading to adoption of the amendment are eligible to appeal this decision to the Land Use Board of Appeals (LUBA).

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

*NOTE: The Acknowledgment or Appeal Deadline is based upon the date the decision was mailed by local

government. A decision may have been mailed to you on a different date than it was mailed to DLCD. As a result, your appeal deadline may be earlier than the above date specified. No LUBA Notification to the jurisdiction of an appeal by the deadline, this Plan Amendment is acknowledged.

WHEREAS, Cody Hindman submitted an application to include 10 acres (part of Twp. 1N, Range 40 EWM, Tax Lot 5900) on the County Basalt Aggregate Inventory as a non-significant site;

WHEREAS, the Union County Planning Commission advertised and held a public hearing on March 28, 2011 and made a recommendation to approve the identified site;

WHEREAS, the Union County Board of Commissioners advertised and held a public hearing on April 20, 2011;

WHEREAS, the applicant has submitted evidence basalt rock is present on the subject property.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS, COUNTY OF UNION, STATE OF OREGON:

SECTION 1: UNION COUNTY LAND USE PLAN

The Union County Land Use Plan Supplement - June 1984, page 37, is amended to include the following described property as a non-significant Goal 5 site in a Timber/Grazing Plan Classification for inventoried basalt sites in Table AS:

Twp. 1N, Range 40 EWM, Section 28, NE ¼, Tax Lot 5900 (about 10.0 acres- see attached map)

SECTION 2: SUPPORTING FINDINGS

This Ordinance is passed and adopted with the supporting findings included in Attachment "A".



Attachment "A"

- 1. Union County Zoning, Partition & Subdivision Ordinance (UCZPSO) Section 23.05 identifies standards which must be satisfied in order to gain Plan Amendment approval.
- 2. OAR 660-023-0180 (4) & (6) identify criteria which must be satisfied in order to gain Plan Amendment approval for a non-significant aggregate site to be listed on a County's land use plan inventory.
- 3. The subject property is in an A-4 Timber Grazing Zone.
- 4. The subject property is accessed by Chumos Road which is a County Road with a 60 foot right-of-way width and graveled surface.
- 5. The applicants are requesting 10.0 acres of their 1,074.12 total acres be placed on the County Basalt Aggregate Inventory as a non-significant site.
- 6. The subject property is being used for timber production and livestock grazing.
- 7 The subject property has been used for limited aggregate extraction operations in the past.
- 8. The subject property is in the Elgin School District but outside of any rural fire protection district.
- 9. The applicants have satisfied UCZPSO Section 23.05 based on their "Exhibit C" submitted with the application.
- 10. The applicants have satisfied OAR 660-023-0180 (4), (5)(f) & (6) based on their "Exhibit C" submitted with the application.

Approval Condition

 The applicants shall not mine more than 500,000 tons of material from this location for the life of the aggregate site.
