- 6. Ketchum Rural Fire Department needs a new fire station to meet growing needs.
- 7. Water Tender for Ketchum Rural Fire Department.
- 8. Type III/IV Engine for Ketchum Rural Fire Department.
- 9. Emergency Back-up Generators for both Ketchum Rural Fire Department stations.
- 10.30,000 gallon cistern in the Triumph area out East Fork Road.
- 11. Mobile Data Computers on all emergency vehicles in Blaine County.
- 12. Continue to purchase narrow banded UHF radios for communication.
