DLCD ACKNOWLEDGMENT or DEADLINE TO APPEAL: Monday, January 28, 2013

This amendment was submitted to DLCD for review prior to adoption pursuant to ORS 197.830(2)(b) only persons who participated in the local government proceedings leading to adoption of the amendment are eligible to appeal this decision to the Land Use Board of Appeals (LUBA).

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

*NOTE: The Acknowledgment or Appeal Deadline is based upon the date the decision was mailed by local government. A decision may have been mailed to you on a different date than it was mailed to DLCD. As a result, your appeal deadline may be earlier than the above date specified. NO LUBA

ORDINANCE NO. 12-867-0

AN ORDINANCE FOR A ZONE CHANGE OF 5.66 ACRES FROM HIGHWAY CENTRAL BUSINESS DISTRICT (CBH) TO COMMERCIAL HIGHWAY (CH), FOR PROPERTY ALONG VALLEY VIEW ROAD, PREVIOUSLY OCCUPIED BY THE TALENT WAL-MART AND DECLARING AN EMERGENCY.

WHEREAS: The City Council finds the proposed zone change (zoning map amendment) is consistent with the City's Comprehensive Plan and identified Commercial designation.

WHEREAS: The City Council finds the proposed rezoning is consistent with the existing zoning for the majority of the tract and corrects a split-zoned property and building condition making it possible for alternative commercial uses to be considered.

WHEREAS: The City Council finds that proposed rezoning was duly noticed, including a noticed hearing by the Talent Planning Commission on October 25th, 2012.

WHEREAS: The City Council finds that the applicant held a neighborhood meeting, as required under TMC 8-3M.190 B., on August 5th, 2012 as evidenced in the record.

THE CITY OF TALENT ORDAINS AS FOLLOWS:

SECTION 1. REZONING: That the zoning designation of Tax Lot 1900, Jackson County Map Number 381W-23D, as shown on the map labeled as Exhibit 4, attached, be changed from Highway Central Business District (CBH) to Commercial Highway (CH).

SECTION 2. That the proposed rezoning as described herein has been advertised and publically noticed in accordance with Section 8-3M. Article 1 of the Talent Zoning Ordinance.


SECTION 3. Under the provisions of the Talent Charter of July 1998, Chapter VIII, Section 33, the provisions of this ordinance shall take effect 30 days after adoption.


SECTION 4. Emergency Clause. The earliest imposition of the provisions of this ordinance is necessary to preserve the peace, health, welfare and safety of the public. Accordingly, an emergency is declared, and this ordinance will take effect immediately upon its passage by the Council and approval by the Mayor.
