Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). WHEREAS, the Oregon Department of Transportation submitted an application to include a 20.89 acre aggregate site (Twp. 2S, Range 37 EWM, Section 36, Tax Lot 900) on the County's Basalt Aggregate Inventory as a significant site and change the current A-4 Timber Grazing Zone to a Surface Mining Zone;

WHEREAS, DLCD was given 45 days notice prior to the first evidentiary hearing;

WHEREAS, the Union County Planning Commission advertised and held a public hearing on January 28, 2013 and made a recommendation to conditionally approve the application;

WHEREAS, The Planning Commission recommended modifying the boundaries of the aggregate site to be added to the County's Basalt Aggregate Inventory and Surface Mining Zone to include about 8.0 acres (Planning Dept. Attachment "A") in order to reduce impacts to neighboring properties from noise, dust and blasting;

WHEREAS, the Union County Board of Commissioners advertised and held a public hearing on February 6, 2013.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS, COUNTY OF UNION, STATE OF OREGON:

SECTION 1: UNION COUNTY LAND USE PLAN

The Union County Land Use Plan Supplement - June 1984 is amended to include approximately 8 acres (part of Twp. 2S, Range 37 EWM, Section 36, Tax Lot 900) as shown on the attached map (Planning Dept. Attachment "A") as a significant Goal 5 site in a Timber Grazing Plan Classification for inventoried basalt sites in Table AS.

SECTION 2: LAND USE PLAN/ZONING MAP

The Union County Land Use Plan/Zoning Map is amended to change the 8 acres shown on Planning Dept. Attachment "A", attached and affixed hereto and made a part of this

ordinance, from an A-4 Timber-Grazing Use Zone to a Surface Mining Zone with an associated expansion for the Surface Mining Impact Area Overlay Zone extending  $\frac{1}{2}$  mile from the expansion area.

An emergency is hereby declared to make this ordinance immediately effective because of ODOT's major I-84 reconstruction project slated to begin early in the 2013 construction season.




