Appeal Procedures*

DLCD ACKNOWLEDGMENT or DEADLINE TO APPEAL: November 16, 2007

This amendment was submitted to DLCD for review 45 days prior to adoption. Pursuant to ORS 197.830 (2)(b) only persons who participated in the local government proceedings leading to adoption of the amendment are eligible to appeal this decision to the Land Use Board of Appeals (LUBA).

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

***NOTE: THE APPEAL DEADLINE IS BASED UPON THE DATE THE DECISION WAS MAILED BY LOCAL GOVERNMENT. A DECISION MAY HAVE BEEN MAILED TO YOU ON A DIFFERENT DATE THAN IT WAS MAILED TO DLCD. AS A RESULT YOUR APPEAL DEADLINE MAY BE EARLIER THAN THE ABOVE DATE SPECIFIED.**

ORDINANCE NUMBER 1247-07

AN ORDINANCE RELATED TO APPLYING THE MIXED USE COMMERCIAL OVERLAY DISTRICT (MUCOD) DESIGNATION TO TWO PARCELS CURRENTLY DESIGNATED GENERAL COMMERCIAL (CG) AT 18067 AND 18075 SW LOWER BOONES FERRY ROAD; AMENDING TDC 57.040 (PTA-07-04).

WHEREAS upon the application of Trammel Crow Residential (TCR) Pacific NW Acquisitions LP and the property owner Parkland Development, LLC, a public hearing was held before the City Council of the City of Tualatin on October 8, 2007, related to applying the Mixed Use Commercial Overlay District (MUCOD) designation to two parcels currently designated General Commercial (CG) at 18067 and 18075 SW Lower Boones Ferry Road (Tax Map 2S1 13DC, Tax Lots 1800 and 1900); and amending TDC Chapter 57 – MUCOD Section 57.040 (PTA-07-04); and

WHEREAS notice of public hearing was given as required under the Tualatin Community Plan by publication on September 20, 2007, in The Times, a newspaper of general circulation within the City, which is evidenced by the Affidavit of Publication marked "Exhibit A," attached and incorporated by this reference; and by posting a copy of the notice in two public and conspicuous places within the City, which is evidenced by the Affidavit of Posting marked "Exhibit B," attached and incorporated by this reference; and

WHEREAS a notice of public hearing was given as required by mailing to affected property owners, which is evidenced by the Affidavit of Mailing marked "Exhibit C," attached and incorporated by this reference; and

WHEREAS the Council conducted a public hearing on October 8, 2007, and heard and considered the testimony and evidence presented by the City staff and those appearing at the public hearing; and

WHEREAS after the conclusion of the public hearing the Council vote resulted in approval of the application, with revisions, by a vote of 6-0-1, with Councilor Boryska not participating; and

WHEREAS based upon the evidence and testimony heard and considered by the Council and especially the City staff report, the Council makes and adopts as its Findings of Fact the findings and analysis in the staff report attached as "Exhibit D," which are incorporated by this reference; and

WHEREAS based upon the foregoing Findings of Fact, the City Council finds that it is in the best interest of the residents and inhabitants of the City and the public; the public interest will be served by adopting the amendment at this time; and the amendment conforms with the Tualatin Community Plan; and therefore, the Tualatin Development Code should be amended. Therefore,

THE CITY OF TUALATIN ORDAINS AS FOLLOWS:

Section 1. TDC 57.040 is amended to read as follows:

Section 57.040 Application of the Mixed Use Commercial Overlay District (MUCOD).

(1) The MUCOD is applied to:

- (a) The Durham Quarry Site (see Fig. 57-2).
- (b) Tax Lot 1300 on Assessor's Map 2S1 13DC within the Durham Quarry Area (see Fig. 57-1).
- (c) Tax Lots 1800 and 1900 on Assessor's Map 2S1 13DC within the Durham Quarry Area (see Fig. 57-1).

(2) In the future, the MUCOD may be applied to additional tax lots within the Durham Quarry Area (see Fig. 57-1) through the Plan Text Amendment application process. The City or another applicant would propose amending Subsection (1), above, to apply the MUCOD to additional lands in Fig. 57-1.

(3) When the MUCOD is applied to the Durham Quarry Site, or in the future to the Durham Quarry Area, where TDC Chapter 57 does not include a particular regulation or standard, the existing regulation or standard from TDC Chapter 54, 73, or elsewhere in the TDC shall apply.
