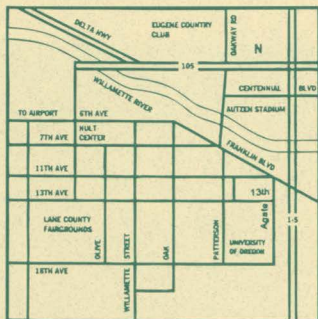

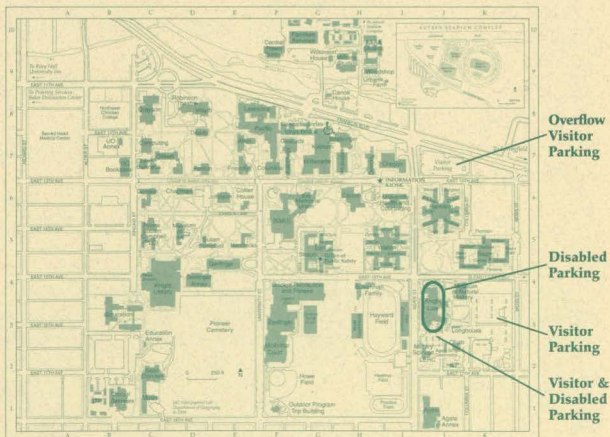

RECEPTION INFORMATION

From the Hult Center, take 7th Ave. to Franklin Blvd.; Franklin Blvd. to Agate Street; turn right onto Agate, left onto 17th; left on Columbia, and enter the parking lot. For overflow parking, turn left on 13th from Agate and enter the parking lot. The map below illustrates how to get to either parking lot on the University of Oregon campus.
