DLCD ACKNOWLEDGMENT or DEADLINE TO APPEAL: September 6, 2007

This amendment was submitted to DLCD for review 45 days prior to adoption. Pursuant to ORS 197.830 (2)(b) only persons who participated in the local government proceedings leading to adoption of the amendment are eligible to appeal this decision to the Land Use Board of Appeals (LUBA).

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

ORDER OF RECOMMENDATION

I. NATURE OF THE APPLICATION

This matter comes before the Lafayette City Council on the application of the City of Lafayette to update the "Capital Improvement Project Costs" of the adopted Transportation System Plan (TSP). Specific amending language is attached as Exhibit "A" of this Ordinance.

II. PUBLIC HEARING

A. Planning Commission Action

A public hearing was duly held on this application before the Lafayette Planning Commission on July 19, 2007. At that hearing, City Planning File 07-06-16 was made a part of the record. Notice of the hearing was published consistent with the requirements in Section 3.202 of the Lafayette Zoning and Development Ordinance. No objection was raised as to jurisdiction, conflicts of interest, or to evidence or testimony presented at the hearing.

At the conclusion of the hearing, the Planning Commission deliberated on the issue and approved an Order, recommending the City Council adopts the proposed amendments to the adopted Transportation System Plan. The Commission found the proposed changes consistent with the applicable decision criteria.

B. City Council Action

A public hearing was duly held on this application before the Lafayette City Council on July 26, 2007. At that hearing, City Planning File 07-06-16 was made a part of the record. Notice of the hearing was published consistent with the requirements in Section 3.202 of the Lafayette Zoning and Development Ordinance. No objection was raised as to jurisdiction, conflicts of interest, or to evidence or testimony presented at the hearing.

At the conclusion of the hearing, the City Council deliberated on the issue and accepted the Planning Commission's recommendation, finding the proposal to be consistent with the

applicable decision criteria. The City Council directed staff to prepare the adoption Ordinance

III. FINDINGS OF FACT-GENERAL

The Lafayette City Council, after careful consideration of the testimony and evidence in the record, adopts the following General Findings of Fact:

- A. The applicant is the City of Lafayette.
- B. The proposed amendments will update the "Capital Improvement Project Costs" of the adopted Transportation System Plan. The revised material is contained in Exhibit "A" of this Ordinance.
- C. Approval or denial of the request will be based on compliance with Oregon Administrative Rule 660-12 (Transportation Planning Rule).

IV. APPLICATION SUMMARY

- A. Statewide Land Use Planning Goal 12 establishes the objectives regarding transportation planning. The policy objectives contained in Goal 12 are implemented through the Transportation Planning Rule (TPR) [OAR 660-12-000 through 070]. The TPR commits all levels of government to the development of a coordinated statewide transportation planning program. Each jurisdiction must prepare and adopt a Transportation System Plan and implementing regulations.
- B. The City adopted a Transportation System Plan (TSP) in 2001 and incorporated the document in the City's Planning Atlas. The TSP contained findings and information on traffic, street classifications and conditions, traffic hazards, rail systems, airports, public transit, pedestrian and bicycle issues. With this information the TSP identified long-range transportation needs, including necessary amendments to the Comprehensive Plan and Development Ordinance.
- C. Consistent with State law, the TSP also included a list of capitol improvements necessary to meet long-range transportation needs. These involved both street improvements as well as pedestrian and bicycle projects. Each project included an estimated cost.
- D. The application before the Council is to amend the TSP by updating the development costs for each identified project. This action <u>does not</u> include any new projects. The update is necessary to ensure proposed system development charges are adequate to meet anticipated development costs. The new development costs are included as Exhibit "A" of this Ordinance.
- E. The Planning Commission reviewed this application at their July 19, 2007 meeting. It was the decision of the Planning Commission to recommend City Council Ordinance 592

approval of the amendment. For the record, the Department of Land Conservation and Development was notified of the amendment and did not oppose the application.

V. AMENDMENT - LAFAYETTE PLANNING ATLAS

- A. Section 3.101.04 of the Development Ordinance states that an amendment to laws or policies is subject to the procedural process for Type IV actions. This type of action must be initiated by City staff, Planning Commission, or City Council. This action is initiated by City staff to ensure current and accurate cost information for proposed system development charges. Section 3.207 requires hearings to be held before both the Commission and Council, with the Commission having an advisory role and the final decision rendered by the Council.
- B. The TSP was adopted as part of the Planning Atlas. As part of the original adoption, the Commission and Council found the TSP reflected the available information and facts concerning transportation system issues for the City. The information is based on applicable data from numerous sources as well as field research and as a series of public workshops. Based on this information, the City concluded the material was an accurate representation of the community=s transportation system, including physical improvements and related long-range planning issues. This conclusion was supported by the Department of Land Conservation and Development as well as the Oregon Department of Transportation in the final adoption of the Transportation system Plan.
- C. The proposed revisions merely reflect updated and current cost estimates to complete the projects. There are no new projects added to the list and projects that were completed or currently under construction (e.g., Madison Street Bridge) were removed from the list. The projects continue to address the identified long-term transportation planning issues in the community. Therefore, as there are no changes save the actual cost estimates, the findings and conclusions contained in the original decision are clearly applicable to this request and effectively incorporated within these findings.

VI. CONCLUSION

The City Council concludes the proposed amendments to the Transportation System Plan contained in Exhibit "A" of this Ordinance are consistent with the applicable decision criteria.
