Appeal Procedures*

DLCD ACKNOWLEDGMENT or DEADLINE TO APPEAL: January 24, 2007

This amendment was submitted to DLCD for review 45 days prior to adoption. Pursuant to ORS 197.830 (2)(b) only persons who participated in the local government proceedings leading to adoption of the amendment are eligible to appeal this decision to the Land Use Board of Appeals (LUBA).

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

*NOTE:

THE APPEAL DEADLINE IS BASED UPON THE DATE THE DECISION WAS MAILED BY LOCAL GOVERNMENT. A DECISION MAY HAVE BEEN MAILED TO YOU ON A DIFFERENT DATE THAN IT WAS MAILED TO DLCD. AS A RESULT YOUR APPEAL DEADLINE MAY BE EARLIER THAN THE ABOVE DATE SPECIFIED.

- 5. The deadline to appeal will not be extended if you submit this notice of adoption within five working days of the final decision. Appeals to LUBA may be filed within TWENTY-ONE (21) days of the date, the "Notice of Adoption" is sent to DLCD.
- 6. In addition to sending the "Notice of Adoption" to DLCD, you must notify persons who participated in the local hearing and requested notice of the final decision.

COMMON COUNCIL OF THE CITY OF MALIN, OREGON An Oregon Municipal Corporation

(AN ORDINANCE AMENDING SECTIONS 152.011 AND 152.024 OF THE LAND USE AND DEVELOPMENT CODE FOR THE CITY OF MALIN; AND DECLARING AN EMERGENCY)

ORDINANCE NO. 308

WHEREAS, at a Public Hearing before the Malin Planning Commission on November 28, 2006, the Commission recommended changing the "R5" Zone designation to "R2" in Sections 152.011 and 152.024 of the city's Land Use and Development Ordinance; NOW THEREFORE;

THE CITY OF MALIN ORDAINS AS FOLLOWS:

Section 1. Section 152.011 will be amended by changing Rural Residential designations "R5" to "R2".

Section 2. Section 152.024 will be amended by changing the title from Residential zone "R5" to Residential Zone "R2". Change line 2 of the section under USES from: enlarged, or moved and land hereafter used in the "R" residential zone shall to: enlarged, or moved and land hereafter used in Residential Zone "R2" shall. Change Subsection (4) D from: Lot Area: "Minimum five (5) Acres" to: Minimum two (2) Acres.

Section 3. Emergency. Whereas, the peace, safety, and general welfare of the citizens of Malin, Oregon, are involved in the enactment of this ordinance, and in order to properly safeguard the same, there is and exists the necessity and emergency for immediate regulation. An emergency is hereby declared to exist and this ordinance shall be in full force and effect from and after the date of its passage.

Passed by the Common Council of the City of Malin, Oregon, on this 12th day of December 2006.
