The Department of Land Conservation and Development (DLCD) received the attached notice of adoption. A copy of the adopted plan amendment is available for review at the DLCD office in Salem and the local government office.

Appeal Procedures*

DLCD ACKNOWLEDGMENT or DEADLINE TO APPEAL: November 13, 2007

This amendment was submitted to DLCD for review 45 days prior to adoption. Pursuant to ORS 197.830 (2)(b) only persons who participated in the local government proceedings leading to adoption of the amendment are eligible to appeal this decision to the Land Use Board of Appeals (LUBA).

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

***NOTE: THE APPEAL DEADLINE IS BASED UPON THE DATE THE DECISION WAS MAILED BY LOCAL GOVERNMENT. A DECISION MAY HAVE BEEN MAILED TO YOU ON A DIFFERENT DATE THAN IT WAS MAILED TO DLCD. AS A RESULT YOUR APPEAL DEADLINE MAY BE EARLIER THAN THE ABOVE DATE SPECIFIED.**

**CITY OF PHILOMATH
ORDINANCE NO. 745**

AN ORDINANCE AMENDING THE PHILOMATH COMPREHENSIVE PLAN MAP AND AMENDING THE PHILOMATH ZONING MAP TO CHANGE THE DESIGNATION FOR PROPERTY LOCATED AT PHILOMATH FARM LOTS BLOCK 28 LOT 120, AND MODIFYING ORDINANCE #720.

WHEREAS, the owner of that certain property located at Philomath Farm Lots Block 28 Lot 120, commonly known as 126 S. 11th Street, within the City of Philomath has proposed to change the Comprehensive Plan Designation for the property from Industrial to Commercial and the zone from Light Industrial to General Commercial; and

WHEREAS, Ordinance #720 adopted and approved the Philomath Comprehensive Plan Map and the Philomath Zoning Map; and

WHEREAS, the City Council of the City of Philomath held a duly noticed public hearing on the proposed Comprehensive Plan and zone change; and

WHEREAS, the Planning Commission of the City of Philomath had recommended that the City Council approve the proposed Comprehensive Plan and zone change; and

WHEREAS, following the public hearing, the City Council deliberated and found that the proposed changes met the required criteria and approved the proposed changes; now therefore:

THE CITY OF PHILOMATH ORDAINS AS FOLLOWS:

Section 1: The City of Philomath Comprehensive Plan Map, adopted through Ordinance #720, as amended, shall be amended so that the property located at Philomath Farm Lots Block 28 Lot 120, commonly known as 126 S. 11th Street, formerly designated as "Industrial" will be designated as "Commercial".

Section 2: The City of Philomath Zoning Map, adopted through Ordinance #720, as amended, shall be amended so that the property located at Philomath Farm Lots Block 28 Lot 120, commonly known as 126 S. 11th Street, formerly zoned "Light Industrial" will be zoned as "Central Commercial".

Section 3: The Planning Official shall make such changes to the City of Philomath Comprehensive Plan Map and the City of Philomath Zoning Map as are required to implement this amending ordinance.

Section 4: The Planning Official shall keep a record of this amendment in a place convenient to the public to memorialize this amending ordinance.
