Appeal Procedures*

DLCD ACKNOWLEDGMENT or DEADLINE TO APPEAL: March 4, 2008

This amendment was submitted to DLCD for review prior to adoption with less than the required 45day notice. Pursuant to ORS 197.830 (2)(b) only persons who participated in the local government proceedings leading to adoption of the amendment are eligible to appeal this decision to the Land



Use Board of Appeals (LUBA).

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

*NOTE: THE APPEAL DEADLINE IS BASED UPON THE DATE THE DECISION WAS MAILED BY LOCAL GOVERNMENT. A DECISION MAY HAVE BEEN MAILED TO YOU ON A DIFFERENT DATE THAN IT WAS MAILED TO DLCD. AS A RESULT YOUR APPEAL DEADLINE MAY BE EARLIER THAN THE DATE SPECIFIED ABOVE.

ORDINANCE NO. 3281

AN ORDINANCE DECLARING THE COMPREHENSIVE PLAN MAP AMENDMENT AND CONCURRENT ZONE CHANGE OF PROPERTY OWNED BY L&H LUMBER COMPANY, LOCATED AT 859 W LOOKINGGLASS RD.

WHEREAS, the Roseburg Urban Area Comprehensive Plan was adopted by the City Council in Ordinance No. 2345, effective on July 1, 1982, and re-adopted in Ordinance No. 2980 on December 9, 1996; and

WHEREAS, the Roseburg Land Use and Development Ordinance No. 2363, as originally adopted July 1, 1984, and re-adopted in Ordinance No. 2981 on December 9, 1996, establishes procedures for hearing Comprehensive Plan Amendment applications; and

WHEREAS, the Planning Commission received the application (File Nos. CPA-07-7 and ZC-07-8) and held a Quasi-Judicial public hearing after due and timely notice.

WHEREAS, the Planning Commission has adopted Findings of Fact supporting its recommendation that the applicant's request be granted; and

NOW, THEREFORE, THE CITY OF ROSEBURG ORDAINS AS FOLLOWS:

SECTION 1. The City Council hereby takes official notice of the Planning Commission Findings of Fact and Decision dated April 2, 2007, recommending the request be granted without conditions and providing details supporting approved as required by Sections 6,150.2 3.38.100 including:

- The Amendment complies with the Statewide Planning Goals adopted by the Land а. Conservation and Development Commission, pursuant to ORS 197.240, or as revised pursuant to ORS 197.245.
- The Amendment complies with applicable policies of the Comprehensive Plan; b.
- There is a public need for a change of the kind in question; and, C.
- d. Such a need will be best served by changing the Plan designation of the particular piece of property in questions as compared with other available property.
 - The rezoning conforms with the Roseburg Urban Area Comprehensive Plan e.
 - The site is suitable to the zone change with respect to the public health, safety, and f, welfare of the surrounding area

SECTION 2. The City Council hereby amends the Roseburg Comprehensive Plan Map and Zoning Map on the area shown on the map labeled Exhibit "A," which is attached hereto and made part of this ordinance.
