Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). 

- 2. Zoning Map Amendment. The City of Monument Zoning Map is hereby Amended to change the zone of the subject property and that subject property is Thereby rezoned from City Residential 1 (R1) to City Commercial (C-1) as set Forth in Exhibit "A" attached hereto.
- 3. <u>Emergency.</u> This Ordinance being necessary for the immediate preservation Of the public welfare, an emergency is declared to exist and this ordinance takes Effect on its passage.
- 4. Record. The City Recorder shall submit to the record of this matter, Local File #2008-001, a copy of this Ordinance signed by the Mayor and City Recorder and shall cause this record to be preserved as Required by State Law.

DECISION ON ACTION 2008-LOCAL FILE # 001: Approval of a proposed action by the City of Monument for **Comprehensive Plan Amendment and Rezone**, of 287 Third Street. The subject property is NE of HWY 402, South of North Street, and West of Third Street. This approval results in the Rezone of 287 Third Street from a residential zone to a commercial zone. This action also amended the City's Comprehensive Land Use Plan Map to change the classification of the subject property from residentially to commercially zoned land. The applicant and property owner is Jerry Boyer.

Dear Participant or Affected Agency:

City of Monument records indicate that you were either a participant, or an Agency with an interest in the land use hearing related to the above reference matter and are therefore entitled to notice of this decision.

The City of Monument had scheduled this matter for hearing on December 9, 2008; however, due to a lack of quorum the City Council continued the matter to a date, time and place certain, and therefore heard the above referenced request at its regularly scheduled/Public Hearing meeting on December 16, 2008, approving the matter. This action is an appealable decision. The Monument Municipal Code requires appeal of a City Council Decision to go directly to the Oregon Land use Board of Appeals (LUBA). ORS 197.830 provides for appeal to the Land Use Board of Appeals (LUBA). Such appeal must be initiated by filing a "Notice of Intent" to appeal a decision within twenty-one (21) days after the date the decision becomes final at the local level; in this case, the notice of decision shall serve as the initiating date. The Notice of Intent to appeal must be filed with LUBA by contacting its office at 550 Capitol Street NO, Suite 235, Salem, OR

97301-2552; Telephone # (503) 373-1265. The beginning date for the 21-day appeal period is the date of this "Notice of Decision", December 19, 2008.

ORDER in the **APPROVAL** of Land Use Action **2008-Local File # 001**, filed by the City of Monument to amend the City's Comprehensive Plan Map and zoning map by changing the zoning at 287 Third Street from a residential zone to a commercial zone.

WHEREAS:

This matter came before the Monument City Council as an application for amendment of the Monument Comprehensive Plan Map and Zoning Map in accordance with the City of Monument's Municipal Code, Oregon Revised Statute and Oregon Administrative Rule provisions for a Post Acknoledgement Comprehensive Plan Map and Zoning Map Amendment. The application sought approval for an amendment of the Comprehensive Plan Map and Zoning Map through an application submitted by Mr. Jerry Boyer.

Hearings were held before the City Council on December 16, 2008, as matters duly set upon the agendas of its specialized meeting after giving the required Measure # 56 notice to all property owners.

At the public hearing on said application evidence and testimony in the form of oral testimony was solicited by the Council. The hearings were conducted according to the rules of procedure and conduct of hearings on land use matters, as set forth in the Monument Municipal Code and in Oregon Administrative Rule.

At the conclusion of the December 16, 2008, public hearing, the City Council, upon a motion duly made and seconded, voted to approve the request as set forth above and proposed in the Application # 2008-Local File # 001 based on decision criteria, findings of fact and conclusions of law as set forth in his order and in Exhibit 1 attached hereto and included herein by this reference. At the January 13, 2009, Regular City Council meeting, did also adopt Ordinance # 2008-A on the first reading.

FINDINGS OF FACT:

- 1) 287 Third Street is surrounded on most sides by commercially zoned property.
- 2) The city has enough remaining residentially zoned property.
- 3) The proposal will not significantly affect transportation facilites.
- 4) The proposal is allowed by the City of Monument's Comprehensive Plan, Zoning Ordinance and applicable State Law if all decision criteria and standards are Met, and the Council determines that those are met.

CONCLUSION OF LAW

- 1. The burden of proof is upon the applicant in proving the proposal fully complies with applicable Code criteria, Oregon State Statues and Oregon Administrative Rules.
- 2. The City Council finds that Exhibit 1, and exhibits attached thereto, and evidence and testimony presented at the hearings, address relevant comprehensive plan policies, standards of Municipal Code, Statewide Planning Goals, Oregon Revised Statute and Oregon Administrative Rules sufficiently to support the burden of proof needed to approve the proposed amendment.

NOW THEREFORE LET IT HEREBY BE ORDERED that application # 2008-Local File # 001, for amendment of Comprehensive Plan Map and Zoning Map, filed by the City of Monument, be **APPROVED**:


