Appeal Procedures*

DLCD ACKNOWLEDGMENT or DEADLINE TO APPEAL: Thursday, October 29, 2009

This amendment was submitted to DLCD for review prior to adoption with less than the required 45-day notice. Pursuant to ORS 197.830(2)(b) only persons who participated in the local government proceedings leading to adoption of the amendment are eligible to appeal this decision to the Land Use Board of Appeals (LUBA).

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

- 6. In addition to sending the Notice of Adoption to DLCD, you must notify persons who participated in the local hearing and requested notice of the final decision.

FINAL ORDER

WHEREAS, Klamath County, applicant, requested approval of a legislative amendment of the COMPREHENSIVE LAND USE PLAN MAP from Residential (R) to Commercial (C); and a CHANGE OF ZONE from Rural Residential (R-5) to Transportation Commercial (CT) on ± 0.33 acres; and

WHEREAS, the subject property is described as Tax Lots 02400, 02500, a portion of 02700, and a vacated public road in Section 21CB of Township 27 South, Range 8 East Willamette Meridian and identified as Tax Accounts R751760, R751779, and R585138; and,

WHEREAS, the Klamath County Planning Department provided proper notice of a public hearing held on June 23, 2009 before the Klamath County Planning Commission and Board of County Commissioners; and

WHEREAS, based on testimony entered and consideration of the whole record, including the proposed Findings of Fact identified in the Staff Report, the Klamath County Planning Commission concluded the application was in conformance with Articles 47 and 48 of the Klamath County Land Development Code and Comprehensive Plan, and forwarded a unanimous recommendation of Approval for Planning File CLUP/ZC 4-09 to the Board of County Commissioners; and

WHEREAS, based on testimony entered and consideration of the whole record, including the proposed Findings of Fact identified in the Staff Report, the Board of County Commissioners APPROVED Planning File CLUP/ZC 4-09, without conditions.

NOW, THEREFORE, THE BOARD OF COMMISSONERS OF KLAMATH COUNTY ORDERS AS FOLLOWS:

The Klamath County Comprehensive Land Use Plan Map is amended to include:

TOWNSHIP 27 South, RANGE 08 East, SECTION 21CB, TAX LOTS 02400, 02500, and a portion of 02700, as a Commercial (C) designation; and,

The Klamath County Zoning Map is amended to include:

TOWNSHIP 27 South, RANGE 08 East, SECTION 21CB, TAX LOTS 02400, 02500, and a portion of 02700, as a Commercial Transportation (CT) designation.
