This amendment was submitted to DLCD for review prior to adoption. Pursuant to ORS 197.830(2)(b) only persons who participated in the local government proceedings leading to adoption of the amendment are eligible to appeal this decision to the Land Use Board of Appeals (LUBA).

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

#### IN THE MATTER OF FILE NUMBER CLUP/ZC 16-07

FINAL ORDER

WHEREAS, Donald Rajnus, applicant, requested approval of a quasi-judicial amendment of the COMPREHENSIVE LAND USE PLAN MAP from Forestry (F) to Non-Resource (NR); and a CHANGE OF ZONE from Forestry Range (FR) to Non-Resource (NR) on 2000± acres; and

WHEREAS, the subject property is described as Tax Lots 06001, 06002, 06300, 00801, and 00100, in Sections 24, 25, 26, 35, and 36 of Township 40 South, Range 11 East Willamette Meridian and identified as Tax Accounts R875527, R877854, R891370, R804142, R875528, and 875527; and,

WHEREAS, the Klamath County Planning Department provided proper notice of a public hearing held on April 28, 2009 before the Klamath County Planning Commission and Board of County Commissioners; and

WHEREAS, approximately 1000 acres of the subject properties are within the Low-Medium Deer Winter Range; and

WHEREAS, a Limited Use Overlay was imposed, which restricts lot sizes within the Low-Medium Deer Winter Range to 160 acres and lot sizes outside the Low-Medium Deer Winter Range to a minimum of 20 acres; and

WHEREAS, the Limited Use Overlay would also restrict any future development on each lot to no more than one dwelling; and

WHEREAS, based on testimony entered and consideration of the whole record, including the proposed Findings of Fact identified in the Staff Report, the Klamath County Planning Commission concluded the application was in conformance with Articles 47 and 48 of the Klamath County Land Development Code and Comprehensive Plan, and forwarded a unanimous recommendation of Approval with conditions for Planning File CLUP/ZC 16-07 to the Board of County Commissioners; and

WHEREAS, based on testimony entered and consideration of the whole record, including the proposed Findings of Fact identified in the Staff Report, the Board of County Commissioners APPROVED Planning File CLUP/ZC 16-07, with conditions.

#### NOW, THEREFORE, THE BOARD OF COMMISSONERS OF KLAMATH COUNTY **ORDERS AS FOLLOWS:**

#### The Klamath County Comprehensive Land Use Plan Map is amended to include:

TOWNSHIP 40 South, RANGE 11 East, SECTIONS 24, 25, 26, 35, and 36, TAX LOTS 06001, 06002, 06300, 00801, and 00100, as a Non-Resource (NR) designation; and,

#### The Klamath County Zoning Map is amended to include:

TOWNSHIP 40 South, RANGE 11 East, SECTIONS 24, 25, 26, 35, and 36, TAX LOTS 06001, 06002, 06300, 00801, and 00100, as a Non-Resource (NR) designation, subject to the following conditions:

- 1. A Limited Use Overlay is adopted in conjunction with this application in accordance with KCLDC Article 59.8. The Limited Use Overlay will limit any future land division within the Low-Medium Deer Winter Range to 160 acres in size and 20 acres outside of the Deer Winter Range. Development on each lot will be no more than one (1) house per lot.
- 2. Further amendment of the zoning site below the 20 acre minimum will require removal of this Limited Use Overlay through a public hearing process and will be subject to an Exception process.
