Appeal Procedures\*

DLCD ACKNOWLEDGMENT or DEADLINE TO APPEAL: Thursday, July 29, 2010

This amendment was submitted to DLCD for review prior to adoption pursuant to ORS 197.830(2)(b) only persons who participated in the local government proceedings leading to adoption of the amendment are eligible to appeal this decision to the Land Use Board of Appeals (LUBA).

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

- \*<u>NOTE:</u> The Acknowledgment or Appeal Deadline is based upon the date the decision was mailed by local government. A decision may have been mailed to you on a different date than it was mailed to DLCD. **ORDINANCE 44.82** 

**WHEREAS,** the Klamath County Board of Commissioners has the authority to create, amend, modify, or repeal county law or code by Ordinance; and

**WHEREAS,** the Klamath County Board of Commissioners has the authority and desires to amend the Comprehensive Plan; and

WHEREAS, the Klamath County Interim Planning Director was directed by Final Order (CLUP/ZC 1-10) signed by the Board of County Commissioners to draft for signature an Ordinance; and

**WHEREAS**, an Ordinance was drafted for the purpose of amending the City of Chiloquin urban growth boundary as requested by the applicant/landowner.

#### NOW, THEREFORE, THE BOARD OF COMMISSIONERS OF KLAMATH COUNTY ORDERS BY ORDINANCE AS FOLLOWS:

1. The Klamath County Comprehensive Plan - General Land Use Plan Map and Zoning Map are amended by including the following property within the urban growth boundary of the City of Chiloquin.



# BEFORE THE KLAMATH COUNTY BOARD OF COMMISSIONERS

#### IN THE MATTER OF FILE NUMBER CLUP/ZC 1-10

FINAL ORDER

WHEREAS, Peter M. Bourdet, applicant, represented by Adkins Consulting Engineers, Inc., requested approval of an urban growth boundary amendment for the City of Chiloquin by adding approximately 7.69 acres of private property (Melitas) and 3.43 acres of Highway 97 right-of-way; and

WHEREAS, the subject property is described in attached Exhibit A (Tax Lots 700 & 701, in Section 33 of Township 34 South, Range 07 East Willamette Meridian); and,

WHEREAS, the Klamath County Planning Department provided proper notice of a public hearing held on February 23, 2010 before the Klamath County Planning Commission and Board of County Commissioners; and

WHEREAS, the applicant submitted said request for the urban growth boundary amendment in due form for consideration; and

WHEREAS, based on testimony entered and consideration of the whole record, including the proposed Findings of Fact identified in the Staff Report, the Klamath County Planning Commission concluded the application was in conformance with State Law, Klamath County Land Development Code and Comprehensive Plan, and forwarded a unanimous recommendation of Approval for Planning File CLUP/ZC 1-10 to the Board of County Commissioners; and

WHEREAS, based on testimony entered and after consideration of the whole record; and, with a unanimous recommendation from the Klamath County Planning Commission the Klamath County Board of Commissioners acting within their authority, agreed with Staff's Findings of Fact and unanimously APPROVED Planning File CLUP/ZC 1-10.

NOW, THEREFORE, THE KLAMATH COUNTY BOARD OF COMMISSIONERS ORDER AS FOLLOWS:

The Klamath County Interim Planning Director shall draft for adoption by the Board of County Commissioners an ordinance amending the Klamath County Comprehensive Plan - General Land Use Plan Map and Zoning Map to show that the following properties are included within the urban growth boundary of the City of Chiloquin:


