DLCD ACKNOWLEDGMENT or DEADLINE TO APPEAL: Friday, October 05, 2012

This amendment was submitted to DLCD for review prior to adoption pursuant to ORS 197.830(2)(b) only persons who participated in the local government proceedings leading to adoption of the amendment are eligible to appeal this decision to the Land Use Board of Appeals (LUBA).

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

- *<u>NOTE:</u> The Acknowledgment or Appeal Deadline is based upon the date the decision was mailed by local government. A decision may have been mailed to you on a different date than it was mailed to DLCD. As a result, your appeal deadline may be earlier than the above date specified. <u>NO LUBA</u> Notification to the jurisdiction of an appeal by the deadline, this Plan Amendment is acknowledged.

NOTICE OF DECISION

This is official notice of action taken by the City of Happy Valley Planning Commission at a public hearing on September 13, 2012, with regard to an application for a Comprehensive Plan Map/Zoning Map Amendment (File No. CPA-03-12/LDC-03-12) on properties located in the southwest quadrant of the intersection of SE Highway 212 and SE Highway 224. The subject properties are described as Clackamas County Assessor Map Nos. 22E12D: Tax Lots 900, 980, and 990.

The subject application proposed a Comprehensive Plan Map/Zoning Map Amendment, to change the existing Comprehensive Plan designation and land use zone on the subject site from a Clackamas County Comprehensive Plan designation of "Medium Density Residential" and a zoning district of "Future Urban 10-acre District" to a City of Happy Valley Comprehensive Plan designation/zoning district of "Community Commercial Center".

At the public hearing, the Planning Commission voted to approve CPA-03-12/LDC-03-12 based upon submitted information, public testimony, and deliberations of the Planning Commission. Copies of the original Staff Report for CPA-03-12/LDC-03-12 are available upon request.

This action by the Planning Commission is not subject to an appeal and is deemed final, per the provisions of Section 16.61.050 of Title 16 (Land Development Code) of the City of Happy Valley Municipal Code

Final Conditions of Approval for CPA-03-12/LDC-03-12 (As approved by the Planning Commission on 9-11-12)

- 1. The City shall amend the Comprehensive Plan/Zoning Map for the subject site to reflect a CCC designation/zoning over its entirety.
- 2. Any future development of the subject site shall be limited to a "trip cap" as described in Exhibit 2. The new development will not be allowed to generate any more than 409 daily and 42 p.m. peak hour trips.

Pursuant to Happy Valley Land Development Code §16.61.040 the City provided notice of a public hearing before the Planning Commission. An affidavit of the notice of hearing is a part of the record. The staff report was prepared and available to the public seven (7) days prior to the public hearing as required by state law.

After providing notice and a staff report, the Planning Commission conducted an evidentiary hearing providing an opportunity to submit oral testimony and written evidence. The approval criteria for the application for a Comprehensive Plan Map/Zoning Map Amendment are provided in the applicable Statewide Planning Goals; applicable sections of OAR Chapter 660, Division 12; applicable City of Happy Valley Comprehensive Plan Policies; and, applicable sections of the City of Happy Valley Municipal Code - Title 16 (Land Development Code), including Chapters 16.23 (Commercial and Employment Districts); 16.61 (Types of Review Procedures); 16.63 (Land Divisions and Property Line Adjustments); and 16.67 (Comprehensive Plan Map, Specific Area Plans, Land Use District Map and Text Amendments). After discussion and deliberation, the Planning Commission voted to approve the "Nature's Country Store" Comprehensive Plan Map/Zoning Map Amendment – File No. CPA-03-12/LDC-03-12.

I. DESCRIPTION OF THE APPLICATION

The City of Happy Valley has proposed an application requesting a Comprehensive Plan Map/Zoning Map Amendment, effectively changing the City's Comprehensive Plan designation and land use zone on the subject site from a Clackamas County Comprehensive Plan designation of "Medium Density Residential" (MDR) and a zoning district of "Future Urban 10-acre District" (FU-10) to a City of Happy Valley Comprehensive Plan designation/zoning district of "Community Commercial Center" (CCC). The three properties that are the subject of this proposal are located in the southwest quadrant of the intersection of SE Highway 212 and SE Highway 224 and are currently the site of "Nature's Country Store", a 4,000 square-foot market that primarily sells produce and other agricultural products. The subject properties can be further described as Clackamas County Assessor Map Numbers 22E12D: Tax Lots 900, 980, and 990.

The City provided notice of the proposed application to all affected governmental entities, and has crafted specific conditions of approval detailing the requirements and conformance with regulations provided by said entities.

II. ADOPTION OF FINDINGS

The Planning Commission specifically adopts the findings within the September 11, 2012 staff report in support of this order approving the "Nature's Country Store" Comprehensive Plan Map/Zoning Map Amendment File Number CPA-03-12/LDC-03-12.

III. ORDER






City of Happy Valley 15252 SE HWY 224
