This amendment was not submitted to DLCD for review prior to adoption pursuant to OAR 660-18-060, the Director or any person is eligible to appeal this action to LUBA under ORS 197.830 to 197.845.

If you wish to appeal, you must file a notice of intent to appeal with the Land Use Board of Appeals (LUBA) no later than 21 days from the date the decision was mailed to you by the local government. If you have questions, check with the local government to determine the appeal deadline. Copies of the notice of intent to appeal must be served upon the local government and others who received written notice of the final decision from the local government. The notice of intent to appeal must be served and filed in the form and manner prescribed by LUBA, (OAR Chapter 661, Division 10). Please call LUBA at 503-373-1265, if you have questions about appeal procedures.

\*NOTE: The Acknowledgment or Appeal Deadline is based upon the date the decision was mailed by local

government. A decision may have been mailed to you on a different date than it was mailed to DLCD. As a result, your appeal deadline may be earlier than the above date specified. No LUBA Notification to the jurisdiction of an appeal by the deadline, this Plan Amendment is acknowledged.

# ORDINANCE No. 2013-06-02

An Ordinance repealing in its entirety Chapter 151 (Zoning Code), Section 151.179 (Planning Commission) of the Banks Code of Ordinances, and adopting a new Section 32.30 (Planning Commission) in Chapter 32 (City Organizations), of the Banks Code of Ordinances, and amending the qualifications for Planning Commissioners

The City Council of the City of Banks finds as follows:

WHEREAS, the City of Banks plans and zones all land within its corporate boundaries pursuant to ORS chapters 197 and 227; and

WHEREAS, the City of Banks created and adopted Section 151.179 of the Banks Code of Ordinances (BCO) in which it established the Banks Planning Commission, scope of authority and qualifications for membership on the Planning Commission pursuant to the authority granted to it by ORS 227.010 to 227.120; and

WHEREAS, the City Council now sees fit to revise the membership and qualifications of the Planning Commission to make it easier to fill vacant positions on the Planning Commission with people that either live, own property or run a business within the City or within the City's Urban Growth Area, but still reside within Washington County; and

WHEREAS, the City Council also desires to remove the general provisions related to the Planning Commission from the Zoning Code and establish them in a new section in Chapter 32 (City Organizations) of the Banks Code of Ordinances; and

WHEREAS, the City Council held a duly noticed public hearing on this proposed revision to the Banks Code of Ordinances at its regular meeting on 5 11 13, at which time it accepted public testimony on the proposal that is attached to this Ordinance as Exhibit 1, and incorporated herein by this reference.

NOW THEREFORE, based on the foregoing Findings, the Banks City Council Ordains as follows:

<u>Section 1 – Repeal.</u> The City Council hereby repeals in its entirety Chapter 151 (Zoning Code), Section 151.179 (Planning Commission) of the Banks Code of Ordinances.

<u>Section 2 – Adoption</u>. The City Council adopts Chapter 32 (City Organizations), Section 32.30 (Planning Commission) set forth in <u>Exhibit 1</u>, attached hereto and by this reference made a part hereof, as part of the Banks Code of Ordinances. This ordinance becomes effective 30 days after passage.

### 32.30 PLANNING COMMISSION.

- (A) The Planning Commission shall consist of 7 voting members, at least five of whom shall reside within the City to be eligible to serve. The remaining two voting members of the Planning Commission shall meet at least one of the following sets of conditions:
  - 1. Reside upon or own real property or own a business within the City of Banks and live within Washington County; or
  - 2. Reside upon or own real property or own a business within the Banks Urban Growth Boundary and live within Washington County; or
  - 3. Reside upon or own real property or own a business within the designated Banks Urban Reserve Area and live within Washington County;

Voting Members shall meet these requirements at the time of nomination, appointment and throughout their tenure on the Planning Commission. All members of the Planning Commission holding office on the effective date of this 2013 ordinance shall be entitled to continue to serve-out the duration of their current term, but shall comply with the requirements of this section to be eligible for any subsequent term on the Planning Commission.

- (B) Planning Commission members are appointed for a term of 3 years. No person shall hold appointment as a member of the Planning Commission for more than 2 full consecutive terms, but any person may be appointed again to the Planning Commission after an interval of 3 months.
- (C) No more than 2 voting members shall be engaged principally in the buying, selling or developing of real estate for profit as individuals, or be members of any partnership, or officers or employees of any corporation, that is engaged principally in the buying, selling or developing of real estate for profit. No more than 2 voting members shall be engaged in the same kind of business trade or profession, as determined by the City Council.
- (D) The Planning Commission will make decisions on land use plans and policies and their implementation, including land use applications. A representative from the Commission shall provide minutes of their last meeting and give a report on any decisions and activities to the City Council at the Council's monthly meeting. A notice for a candidate application to be a member of the Planning Commission shall be posted at City Hall and 2 or more other locations within the city. Application forms shall be made available at City Hall. All completed applications shall be submitted to the City Recorder and kept on file at City Hall. All the Mayor's appointments may be interviewed at the City Council's discretion prior to the City Council's confirmation vote.
- (E) The Planning Commission shall elect a Chairperson and Vice-Chairperson, who shall hold office at the pleasure of the Commission. The Commission shall appoint a Secretary who need not be a member of the Commission. The Secretary shall keep an accurate record of all Commission proceedings.
- (F) The Planning Commission shall meet at least once a month, at a time and place to be fixed by the Commission. All Commission meetings shall be open to the public. A notice and agenda of upcoming Commission meetings shall be posted at least 24 hours prior to the meeting at City Hall and at the other places as may be determined by the Commission.
