





Hoyman's Swimmers Hold

With a triumph over Idaho in a dual meet just as *Old Oregon* went to press, the Oregon swimming team established a record of not having lost a dual meet for four years.

Congratulations from all sides have poured in on Swimming Coach Mike Hoyman for his remarkable record since he has taken over the Oregon paddlers. Old timers hail the accomplishment as the best sports record any Oregon team has ever made.

The Duck swim stars have won two northern division swimming meets in a row and are now engaged in trying to raise the mark to three. Results of this meet and a list of the many records piled up during the past four years will be published in the next *Old Oregon*.

March 20 Hoyman's lads splashed to a 39 to 36 victory over Washington's Huskies in a meet at Seattle. Jim Hurd, veteran free style ace, stole the show as the Webfoots won six of nine events. Hurd established a new northwest intercollegiate record in the 100-yard free style, also won the 50-yard free style, and was a member of Oregon's 440-yard relay team which shattered the northwest mark. His teammates in the last record were Jim Smith, Len Scroggins, and Harold Sexton.

Spring Sports Reign Now

With basketball just a memory, Oregon's athletic eyes have turned to the outdoor world of spring sports. Base-

ball, track, tennis, and golf are the new kings, and freshman and varsity hopefuls are striving for positions on teams in all four.

Hobby Hobson had hardly time to catch his breath after the basketball finale before opening baseball practice. Oregon is likely to be a contender for the northern division crown, won last spring by Washington State, despite the fact that several men counted upon for help did not return to school.

CHAMPS IN PICTURE

On the cover this month we have some of the members of Oregon's famous swimming team which has piled up a record of no losses during the past four years. They are from left to right, Jim Hurd, Harold Sexton, Charles Reed, Bob Chilton, and Coach Mike Hoyman.

The pitching burden will fall heavily on the shoulders of Bill Sayles, sophomore right-hander from Washington high of Portland. Sayles, member of last year's Olympic nine, is considered one of the most promising young hurriers in the northwest.

Oregon's infield has taken on a sophomore hue. Leading graduates from the ranks of John Warren's freshmen are Gale Smith, first base; Jack Gordon, shortstop, and Ford Mullen, third base. All are likely to win starting spots. John Lewis, regular shortstop for two seasons, is back for a final fling. Lettermen outfielders are Ralph Amato and Andy Hurney.

Colonel Bill Hayward is not too optimistic over prospects for his track team, but he has George Varoff, the world's number one pole vaulter, as a nucleus for what may be a capable squad. Frank "Squeak" Lloyd and Captain Sam McCaughey are leading veterans reporting again.

Varsity and freshman golf will be coached this season by Sid Milligan, captain of the varsity team. Resignation of Tom Stoddard left the coaching position open, and Athletic Manager Anse Cornell appointed Milligan, number one man last year.

Paul Washke, tennis coach, had his racquetcoers out early and an elimination tournament was to select varsity and freshman teams for the most strenuous Webfoot schedules in years.





Hoopmen Lose Playoff

Oregon's most successful basketball team since 1927 reached the end of its trail at Pullman March 20, when it fell before Washington State in a final playoff game for the northern division championship, 42 to 25.

The Webfoots, who tied with Washington and Washington State at the top of the heap with 11 wins and five defeats, drew a bye in the playoff. Washington State came from behind to edge out Washington at Seattle, 36 to 33, which left the final reckoning in the hands of Oregon and Washington State, two teams which had watched Washington and Oregon State completely monopolize the championship picture for a decade.

It was Washington State's first title, and the Cougars earned it. Howard Hobson's Webfoots, led by slim Wally Johansen, piled up an 11-to-3 lead in the first eight minutes of play at Pullman, but the fighting Cougars quickly erased that advantage with a vicious offensive drive which carried them to a tie at 11-all and a 16-to-15 edge at half-time.

The second half was a nightmare for

Oregon. Big Ivar Nelson, Washington State center, consistently took the tip-off, and Captain Bill Dahlke and his Cougar mates poured in field goal after field goal. Oregon didn't score from the field until Purdy hit a long one after 11 minutes of the half. The Webfoot field goal total for the entire closing period was two.

Despite loss of a chance to meet Stanford at McArthur court in a playoff for the Pacific coast title, the Ducks, during the season, far exceeded hopes of their stoutest supporters. Coach Hobson started with a group of sophomores and reserves and indications, at best, pointed to a season no better than average. But the sophomores—Wally Johansen, Bob Anet, Slim Wintermute, and Laddie Gale—came through. So did the reserves—John Lewis, Bill Courtney, Ken Purdy, and Ray Jewell. So did the one 1936 regular—Dave Silver.

The Ducks were the hardest-driving, hardest-fighting team in the northern division. All but Lewis, Purdy, and Courtney will return next year, and fans have reason to hope for big things then.

Joe Gordon, former Webfoot baseball star is clicking in good style for the New York Yankees. The New York Herald-Tribune for March 14 carried a story on how he had been shifted to second and was teaming in great style with Frank Crosetti. The writer said Gordon is ticketed for Newark and eventually to move up and fill Tony Lazzeri's shoes. He said, "This young, pleasant infielder . . . is stepping into the limelight . . . He's quiet but he has a lot of personality, and he looks as if he might one day be a good ball player."

Slim Wintermute and Dave Silver were in third and fourth positions respectively in the high scoring department of the northern division basketball conference. They trailed Ivar Nelson, WSC, and Ed Loverich, Washington. Nelson had 156, Loverich 136, Wintermute 133, and Silver 121.

Hundreds Visit Campus

While students were home for spring vacation, more than 300 visitors poured in to the campus from various sections of the state to attend the annual commonwealth conference, the convention of the League of Oregon Cities, and the Commercial Secretaries conference.

Power was the theme song of the commonwealth conference as experts discussed various ways of dealing with the Bonneville project. E. H. Foley, Jr., designated the official representative of the national power policy committee appointed by President Roosevelt, was the headlined speaker as he told the story as his board sees it.

"Power must be made available to the greatest number of consumers at the lowest possible cost," he said. "The whole, or at least a large portion of the transmission costs of power from Bonneville should be calculated in relation to the entire region served, and a prorata share of such costs may be fairly ascribed to all power sold."

Various alumni figured among the officers chosen by the groups, and many more were present as speakers or visitors. For the League of Oregon

SPRING FILLED WITH BIG ALUMNI EVENTS

Portlanders Meet, Banquet On April 9

Last minute plans for the big alumni meeting and banquet of the Portland alumni association are being pushed ahead by various committee heads, according to General Chairman Robert C. Bishop, and everything will be in readiness for a record crowd on April 9.

The banquet has been called for 6:30 p.m. at the Congress hotel and advance ticket sales have indicated a larger attendance than for any such annual affair in the past.

Vieing for top spot on the program are such things as the announcement of the outstanding alum for the past year, the election of officers, and the sparkling variety of entertainment scheduled for the meeting.

Portland committees are still working on entertainment features from there, and Alumni Secretary Elmer C. Fansett reports a full slate of singers, magicians, jugglers, actors, and speakers on the bill from the University's offering. All will be limited to a five-minute presentation, he reports.

Such men as James Gilbert, Anse Cornell, George Hopkins, Hal Young, Dean H. C. Howe, and all the coaches are planning to be present for the meeting.

Unavoidable postponement of the affair from March 5 to April 9 has only heightened interest, according to President Paul D. Hunt, and has allowed time for a better and more adequate program to be arranged, as well as assuring contact of all members in the Portland area.

Hailed as a second homecoming by Chairman Bishop, the meeting has acted as an impulse for the scheduling of several impromptu class reunions, and many graduates from cities as far as Salem, Astoria, and Eugene will join the fun.

"This big meeting in Portland is going to set the pace for a program of similar meetings throughout the state," Mr. Fansett said. "In every way it ought to mark the initial step in a movement towards a revival of a greater alumni association and a greater University of Oregon."

Commencement Committees At Work


Saturday May 29 will be one of the big days of the year for interested alumni, when they return to the campus for class reunions and to attend Baccalaureate and Commencement exercises the two days following.

Committees are already starting to get underway in planning for Saturday's events, which include the six class reunions, the annual meeting of the alumni association, the University luncheon, the evening concert, and the flower and fern procession.

Extra copies of *Old Oregon* and notification letters of invitation are being sent out from the alumni office, so that all reunion class members will receive notice of their meetings before long. The class of 1887 heads the scheduled meetings, with its fifty-year anniversary gathering. Others are the forty-year meeting of the class of 1897; thirty-year, 1907; twenty-five-year, 1912; twenty-year, 1917; and ten-year, 1927.

Final examinations for undergraduates are the week following the exercises, so returning alumni will find the campus well-filled. This arrangement was established last year and was found to be very satisfactory.

of drugs. He discovered the fungicidal properties of certain volatile oils which proved to be an aid to fruit growers of the northwest.
