Prince G. Callison Leaves Oregon Football

"In the interest of the University of Oregon and Oregon football I hereby tender my resignation, my services to terminate at the end of the present fiscal year (June 30, 1938) in accordance with my notification of appointment." Thus on December 17 Prince Gary Callison severed his coaching relations of six years with the University.

Callison refused the request of the Athletic board to reconsider his action.

Callison's resignation followed the formation on the campus of a group which labeled themselves the CCCC (Can Coach Callison Club), and dissatisfaction expressed over showings of recent Callison coached football clubs. This movement was strongly resented by loyal supporters of Callison who realized his sound football knowledge. Callison supporters were particularly strong in Seattle, Astoria, Bend, Medford and other Oregon cities.

Callison's resignation was in line with his statement made when formation of the CCCC was first made public—that he would clear the way whenever he felt it would be to the best interests of the University.

Callison became head coach in 1932 when Dr. Clarence Spears departed for Wisconsin. During this six-year period Oregon tied for the Coast conference championship (in 1933) and won the northwest crown (1935). Callison's varsity elevens have won 33, lost 23 and tied two games including the current season which brought four victories and six losses.

The Webfoot mentor was a star Oregon gridder of no mean ability himself, playing sparkling ball at center after graduating from Eugene high school. He was a member of the 1919 Rose Bowl team that lost a 7-6 count to Harvard.

After receiving his degree in 1923, Callison went to Medford high school where he developed the state's most outstanding high school elevens in the history of state football. During his six years as coach of the "Black Tornadoes" his team won four state titles, winning 41 games, losing one and tying one.

In 1929 Callison came back to Eugene as freshman football coach, bringing with him such later stars as Bill Morgan, later voted an all-American pro tackle, and Bernie Hughes, another stellar lineman who rated all-conference honors.

The year Spears completed his final season, Callison produced his "wonder team," composed of Stan Kostka, Art Clarkson, George Pepelnjak—a team that registered such scores that comptometers were required to total the final tabulations. During that three-year period the Ducklings won 11, lost two and tied one.

The 1936 season was Callison's most disastrous in his coaching career—the Webfoots winning but two of nine games. The current season was more successful, what with his addition of

a sensational group of freshmen from a high-scoring 1936 Duckling squad. The Oregons this season cracked three records of long standing although they finished only above U. C. L. A. in the final conference standings. Oregon defeated Stanford for the first time in history, scored on U. S. C. for the first time in 17 years, and defeated Washington State for the first time in 15 years.

Callison has sent some fine gridgers into the coaching and professional football field, namely Mark Temple, Mike Mikulak, Leighton Gee, Bob Parke, "Butch" Morse, Alex Eagle, Bud Pozzo, Del Bjork, and a fine string of seniors this season.

Callison's coaching record for the 14 years shows 85 wins, 26 losses, and 4 ties.

Winter Registration Hits All-Time High

Winter term registration has reached a new high, incomplete figures released by Clifford Constance, '25, reveal. After the first week of registration 3011 students had signed for winter term, an eight per cent increase over the 1937 winter term's total of 2777.

Physical Education showed the greatest gain in majors with 43.7% more students than last year. Business Administration and Journalism showed the next greatest gains with 20.5% and 16.7% respectively.

Women students are outnumbered by the men by more than 50%. As usual, the Sophomores lead the classes in numerical strength of 1109, the Junior class is the smallest with 297 members.

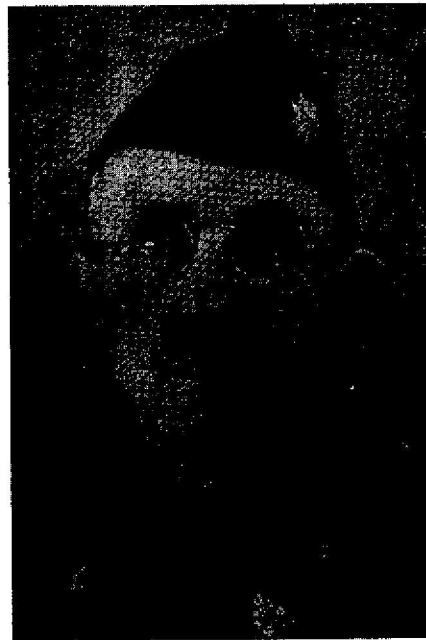

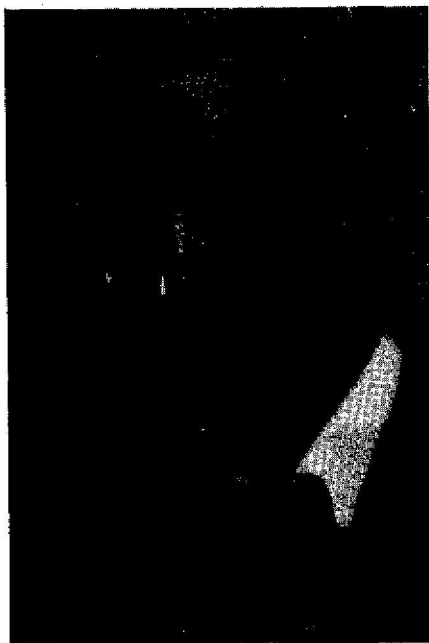

Dr. Solve to Go to Duke

Dr. Melvin T. Solve, '18, professor of English at the University of Arizona, will teach two summer session courses for graduate students this year at Duke university in Durham, N. C. Dr. Solve will teach "Shelley," and "Early 19th Century Literature."

During the 1937 summer Dr. Solve taught at the University of Oregon. He has been a member of the Arizona faculty since 1928, coming to the state university after a four-year term of teaching at the University of Michigan. Graduate of the University of Oregon in 1918, Dr. Solve took work for his Ph. D. degree which he received from the Michigan university. He was a member of the Oregon University resident faculty from 1919 to 1923.

Dr. Solve is the author of a volume on Shelley, published in 1927; essay reading, released in 1928, and two editions on college composition published in 1929 and in 1934 respectively.

River Exploration Told

Dr. Ian Campbell, B.A. '22 and M.A. '24, was a Eugene visitor during December when he lectured on his latest explorations of the Grand Canyon of the Colorado.

Dr. Campbell, who is now a member of the California Institute of Technology faculty, recently led a party of scientists through the dangerous gorge. The trip was the thirteenth recorded trip down the river canyon in the history of the area.

The purpose of the expedition was the exploration of rock formations of the Archaean era—the oldest geologic strata known and possibly a billion years old—which are exposed at the floor of the canyon.

De Busk Memorial

A memorial volume, "DeBusk Memorial Essays," has just been published by the University press. The book, edited by Henry D. Sheldon, now research professor of history and for many years dean of the school of education, is a tribute to the character and work of Dr. Burchard Woodson DeBusk.

Dr. Sheldon inscribes the book:

"To one who worked with Dr. DeBusk for more than 20 years, the lasting impression is of a man, sympathetic and fair-minded, avoiding strife, always creative in his efforts and loyal to his institutional responsibilities and to his own strong urge to

help those who were limited in their mental equipment. A man so single in his purposes, so free from petty jealousies and egotistic inhibitions is seldom found."

Dr. DeBusk was a leading figure in the establishment of the now nationally famous clinical for atypical children at the University, and the volume describes much of his work there.

Dr. DeBusk was particularly interested in students with reading difficulties, and many a student finding college work almost beyond his ability went to Dr. DeBusk and was immeasurably aided by his techniques and kindly guidance.

Articles by Dr. Elizabeth Montgomery, Miss Lillian Rayner, Wallace T. Wait, Max Barr, and Kenneth Shumaker are included in the volume.

Econ Group Names Hall

James K. Hall, B.A. '26 and M.A. '26, University of Washington professor, was elected president of the Pacific Coast Economic Association when it held its 16th annual conference on the Pomona college campus during the vacation.

Other officers elected included Robert D. Calkins, B.S. '25 and M.A. '28, now teaching at the University of California, who was named vice president. James H. Gilbert, '03, dean of the University of Oregon's College of Social Science, was named to the executive committee.

Coaching Choice Narrows to Four Men

Oregon's quest for a new football coach narrowed to four possibilities when the athletic board spent a five hour session on January 14 discussing 54 candidates and prospects for the job left vacant by "Prink" Callison's resignation in December.

The board went on record as favoring:

Ted Banks—head coach, University of Idaho.

James Bradshaw—head coach, Fresno State Teachers' college.

Tex Oliver—head coach, University of Arizona.

Gene Shields—line coach, University of Oregon.

Anson B. Cornell, graduate manager, announced that this does not mean that the field has been limited to these four, but that others might possibly be searched out. Out of state prospects have been invited to Eugene to confer with members of the board.

In a campus poll conducted by the Emerald, students gave Gene Shields, popular line coach, 300 of the 482 votes turned in. This poll was conducted at the dinner tables of various organizations to preclude any stuffing of the box. In the same poll Eric Waldorf received 43 votes, Jim Bradshaw 20, and Tex Oliver 10.

Shields has also been strongly backed by the 1937 football team and many former players.

No decision is expected until Banks, Bradshaw and Oliver have visited Eugene and conferred with members of the board.

Dr. Erb Likes Fishing

Oregon students will have an opportunity to meet the new president when Dr. Donald Erb addresses a general assembly on January 20.

Dr. Erb will come north for the Oregon Newspaper Publishers' association conference January 20, 21, and 22, and will take advantage of the trip to greet the student body for the first time since his election to the presidency was announced in November.

Students felt a little closer to their new president when stories of Erb's love of fishing appeared in the Emerald. "He is an incorrigible and inveterate fisherman. Some of his friends suspect that one reason for his being interested in the presidency of the University is that it brings him back to his familiar fishing grounds," said Dean Gilbert.

Dr. Moll, who has been Dr. Erb's fishing companion for the past ten years and who fished with the new president twice a week during the 1937 summer school, also revealed that Dr. Erb is so attached to his fishing boots that he has worn the same pair for the past seven years.

Klep Exhibit Successful

Rolf Klep, who came to the University from Astoria, and graduated with the class of 1927, has recently won high praise at the Book Fair, which is conducted each year by the New York Times. This is the result of an exhibition of his new book, "Album of the Great," published within the last few weeks by Knopf. The novel feature is the fact that he has both written the material and drawn the beautiful pictures which it contains. It deals with sixteen of the principal characters in all the fields of the arts from the eighth to the eighteenth century.

He is now working on the illustrations for a children's book to be issued soon. It concerns twelve plays of Shakespeare, and Mr. Klep is drawing the Shakespearian characters.

His water colors have been used often in recent months as the covers for the Literary Digest, Yachting Magazine, Colliers, and Life.

Oregon Press Conference

Oregon alumni are scheduled to play prominent parts in the twentieth annual Oregon Press Conference to be held in Eugene on the weekend of January 21.

Adelaide V. Lake, '20, editor of the Sheridan Sun, will speak on "Women in Oregon Journalism." "Freedom of the Press and Freedom of Speech" will be the subject of an address to be made by E. Palmer Hoyt, '24, managing editor of the Oregonian. The opening event of the conference is to be a banquet held on Thursday evening—toastmaster for the occasion will be Lucien P. Arant, ex-'18, now co-publisher of the Baker Democrat-Herald.

Harry S. Schenk, '33, advertising manager of the McMinnville Telephone-Register, will preside at the conference of the ONPA Advertising Managers. Schenk is president of the managers' group.

Featured speaker for the conference will be Dr. Donald M. Erb, newly elected president of the University. Dr. Erb is coming to Eugene from Palo Alto to address the group on the subject of "Professors and the Press."

The University of Oregon chapter of Sigma Delta Chi, national professional journalism fraternity, is celebrating the 25th anniversary of the founding of the local chapter and the completion of the 25th year of the University school of journalism by a Silver Jubilee luncheon to be held Saturday, January 22.

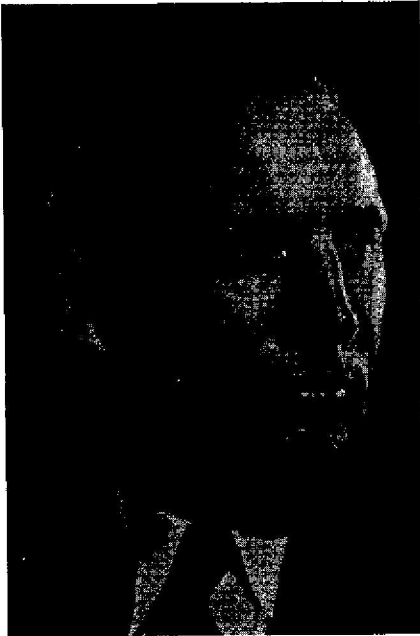

Robinson Is Gallup Aid

Dr. Claude E. Robinson, student body president 1923-1924, a graduate of the class of 1924, has recently been made Associate Director of the American Institute of Public Opinion, which was formed by Dr. George Gallup, with headquarters in New York City. He has been interested in this field for a number of years. While a student at Columbia University, from which institute he received his Doctor of Philosophy degree in 1934, he wrote the book called "Straw Votes," which was published by the Columbia University press. During the last national election, he conducted the straw vote poll for the New York Post. Numerous articles written by him have appeared in the New York Times, New Republic, Public Opinion Quarterly, and other publications.

After leaving Columbia in 1934, he became interested in financial research in Wall Street, where he remained until he received the offer concerning his present connection.

Immediately after graduation at Oregon, he went to New York, where he became intensely interested in sociology, and consequently spent a good deal of time gathering first-hand information as a member of the staff of the old "Sutton Place Settlement House." It was in this field that he took his doctorate.

He had not been in the East long before he enticed Elizabeth Manning, '27, to visit the "big town." No one has been able to learn whether the arrangements for their marriage were

made before or after she left Oregon. They live at 11 Willow Street, in Brooklyn Heights, when they are not commuting to their farm in Pennsylvania.

Like the President, he lists his vocation as "dirt farmer."

Milton A. Miller

Milton Armington Miller, ex-'88, United States collector of customs and ex-United States collector of internal revenue for Oregon, died January 8 in Portland, after an illness of several weeks' duration.

A son of pioneer parents, Milton A. Miller was born on a farm four miles south of Lebanon, Oregon, August 23, 1862. He made the farm his home until he moved to Lebanon to go into business. He then taught for several years and saved enough money to attend the University.

He attended the University during the academic years of 1884-85 and 1885-86. Mr. Miller was a regent of the University for 12 years from 1905 to 1917. In 1889 he moved to Lebanon where he established a drug store and book store. He served as mayor of Lebanon for ten years, and was a member of the school board there for 20 years.

Mr. Miller was elected a democratic member of the state house of representatives in 1890, serving four years in the lower house. In 1902 he was elected to the state senate, then re-elected, resigning when President Wilson appointed him collector of internal revenue in July 1913. He held the post throughout the Wilson administrations.

He was a delegate to the democratic national conventions of 1896, 1900,

1908, 1912 and 1932. In 1928 and 1932 he was the choice of Oregon democrats for vice-president. He served as national committeeman for Oregon, 1900-04 and 1908-12. In 1924 Senator Miller was his party's nominee for United States senator but was defeated by his cousin, Charles L. McNary. When George E. Chamberlain was governor, Mr. Miller served on the state textbook commission. Senator Miller also served as chairman of the Champoeg park commission for many years.

\$500 Grant Awarded

The Carnegie Institute of Washington, D. C., has granted \$500 to Dr. L. S. Cressman to continue his studies of prehistoric man at Catlow Caves in southeastern Oregon.

The grant comes as recognition of the valuable work which Dr. Cressman and his associates have done the past two summers. Evidence of early culture and artifacts uncovered at the caves may prove that Oregon had the oldest civilization of this part of the earth.

Skull Given Museum

The University of Oregon's anthropological museum is the recipient of a gift of the skull of an ancient medicine man, parts of six skeletons, and over three hundred stone specimens. These are the gift of Stanley B. Jewett, Portland regional director of the United States biological survey.

Webfeet Lead Conference in Basketball

The lanky dashing University of Oregon basketball team busted open their 1938 conference season with a double victory over the Washington State Cougars, defending northern division champs. First on January 10 by the score of 54 to 33, and then on the next night by the score of 50 to 46. Both games were played in McArthur court.

They were the twelfth and the thirteenth straight Oregon victories for the current season and the Webfoot average score has been well above 50 in every game.

It was their usual fast driving game that the Oregon quintet played but with a tendency toward raggedness. In the first game the Oregonians ran circles around the boys from eastern Washington, and in the second the visitors tried to match the fast-breaking of the Webfoot machine but couldn't quite make it. They did pile up enough points, when added to the Oregon score, to make one of the highest totals ever scored in a northern division game.

There were 36 personal fouls in the first game, 21 on W.S.C and 15 on Oregon. There were many bad passes and fumbled dribbles. Laddie Gale was high point man with 14 counters, but he did not overshadow the scrappy playing of Anet, Johansen, Wintermute, and Hardy. A whole team of reserves was carrying on the war toward the end.

Oregon 50—WSC 46

On the second night Gale was again high, this time with 19 of Oregon's 50 points. But it wasn't quite as simple as it was on the night before, for the Cougars had grabbed off an early lead and at intermission time the score was only 28 to 26 in favor of Oregon.

Again Washington State was number one on fouls with a total of 20, and the Ducks fouled 16 times. Oregon salted away 16 of the 22 free throws and W.S.C 10 out of 18.

Dave Silver was extremely valuable at the backboard, and the ball handling of Johansen and the driving fight of little Bobby Anet were features of the game.

Pre-Season Games

Averaging 56 points to their opponents 31, the 1938 edition of Oregon's basketball team whipped through 11 pre-season hoop games with an attack that placed them as one of the strong cup contenders in the present season's Northern division basketball race.

Leading the attack in the games were

Laddie Gale, Webfoot forward who made 127 points, Urgel "Slim" Wintermute, center, who cauned 91 points, and a newcomer from Southern Oregon normal, Bob Hardy, forward, who accounted for 84 tallies. The floor play was dominated by the Astoria Finns, Bobby Anet and Wally Johansen, however, whose efficient ball handling juggled the apple into position for many of the shots.

This pre-season warmup series had its bad medicine, however, when Dave Silver, senior forward, sustained a toe injury which was expected to handicap his early season playing.

In the first pre-season games, the Ducks took the University of Portland Pilots 68 to 24 and the ex-college stars of the Multnomah athletic club team 56 to 37 on two successive evenings at the University Igloo. Laddie Gale showed his possibilities in the first game by potting in 19 points, and in

the other game the high honors were divided among Anet, Johansen, and Wintermute.

Oregon 47—UCLA 26

On December 11 the UCLA Bruins came along on a barnstorming trip and the Webfooters paused in the pre-examination studying to take them 47 to 26, not without difficulty however, for both teams were ragged and committed 27 fouls. The Ducks made 14.

On the following Saturday several ex-Oregon basketeers invaded the McArthur court on the Union Oil company team of Portland, but were beaten 66 to 32 by the speed of the "younger generation." Johnny Lewis, last year's captain, canned the first shot for the Oilers, but Johansen, Hardy, and Sarpola, another Finn, a sophomore from Astoria, led an overwhelming attack with 16, 15, and 14 pointers respectively. Other

Oregon alums on the oiler team were the Jones boys, Willie and Budd, "Spook" Robertson, and Rollie Rourke.

Oregon 72—SONS 43

The SONS from Ashland fell next—it was 72 to 43. The SONS had the lead for the first seven minutes and Leavens their guard earned high point honors with 18 tallies, but they were swamped by the combined sharpshooting of Gale and Sarpola both of whom made 14 points and Johansen and Anet with 11 apiece.

By this time the Webfoots had won their fifth straight victory and left Eugene for a road trip into northern Oregon.

They beat the ex-Oregon State star Wally Palmberg's Astoria Easterns 43 to 28 easily enough, but ran into grave difficulties in their second game with the Multnomah club five, when they barely edged out a 38 to 36 victory over the clubmen. Oregon trailed 18 to 23 at the half time and didn't gain the advantage until 12 minutes had elapsed in the second half. Then the score see-sawed until the end of the game.

Oregon 43—Portland 24

The Webfoots were stronger the next evening against the Portland Pilots and won 43 to 24. Gale who totaled-14 points in the game made 12 of the counters within the first 10 minutes. The score was 23 to 9 for Oregon at the half. Hardy made 12 points.

At this time the boys disbanded for Christmas at home, but on the following Monday came back to win their ninth straight game by again beating Union Oil, this time 49 to 21.

Willamette University offered some opposition to the Webfoots at Salem, but were quelled 57 to 38. Gale canned 18 points and when he started to weaken, Wintermute carried on and made 13 of the counters.

Oregon won the 11th and final game of the pre-season series with a 78 to 34 victory over the Willamette Bearcats New Year's day at Eugene. The Webfoots had no trouble and led 34 to 14 at the half. Johansen sparkled again on his floor play but came out on fouls. Gale was high with 18 and Hardy made 12.

"Iron Man" Foskett

Bill Foskett, Oregon's 210-pound tackle and a weight man on the Webfoot track team was the "iron man" in last fall's football season. He had 440 minutes of playing time in at the end of the ten game season, an average of 44 minutes per game. In the Washington and W.S.C. games he played the full 60 minutes.

All-American Swimmers

Jim Hurd, free-style sprinter, and Bob Chilton, diver, two of last year's University of Oregon Northwest championship swimming team, have been named on the 1937 all-American swimming team recently chosen by the national intercollegiate swimming board.

This is the second successive year that two of coach Mike Hoyman's Webfoots are on the mythical squad and the second time for Hurd to be thus named. In 1936, Hurd, undefeated in two years of Pacific coast competition, and Jim Reed, backstroke champion, were on the team.

Chilton was the northern division diving champion in 1935 and 1937. He lost only once in three years. That was in the 1936 northern division meet when he lost to his teammate, Bert Myers by .4 of a point.

Hurd and Chilton finished their competition last spring and Jim Reed the year before.

Two University of Oregon freshmen, Jack Dallas, breast stroke, and Sherman Wetmore, backstroke, both of whom attended the Los Angeles Polytechnic high school, were chosen on the 1937 all-American interscholastic high school squad. Dallas was named as the nation's foremost high school performer in his event. Both are rated as definite 1940 Olympic prospects.

The University of Oregon varsity team has been undefeated in intercollegiate dual meet competition for four consecutive years and has won the

northern division championship in 1935, 1936, and 1937. In 1936, the Webfoots tied with USC for the Pacific coast title.

This year the Webfoots will defend their title in one of the heaviest schedules in many seasons. A possible meet with the University of British Columbia is also being negotiated. The complete schedule is as follows:

Graduation Takes Toll

Graduation and ineligibility have weakened this year's team somewhat. Hurd, Chilton, Sexton, and Chuck Reed were lost by graduation. Jack Levy, distances; Bert Myers, diving; and Jim Smith, sprints, are the lettermen returning.

The freshmen have an excellent team in the making. Besides the prep all-Americans, Dallas and Wetmore, the Frosh have two up and coming divers in Elmer Mallory of Junction City, and Al Sanders of Boise, Idaho, and a sturdy free-style speed boat from Hawaii, Jim Marne.

Frosh Hoop Team Potent

The Oregon Frosh basketball team was ready to start its 1938 season with two games against the Franklin High school team in Portland after several weeks of intensive practice in which the squad of 50 applicants dwindled to 25 or less. Ultimately coach John Warren hoped to retain but 15 of the first year men on his squad.

With the numerous all-star basketballers who have come under his tutelage from widely separate locations, among them three Oregon all-state high school stars, Don Mabee, of McMinnville, and Earl Sandness and Toivo Piipo from Astoria, the final squad should be an efficient crew of men.

Observers who have watched the squad scrimmage with the Oregon varsity have concluded that it is one of the best freshman hoop squads to wear the Oregon colors in years.

Paul Rowe, Oregon sophomore full-back, who had never played a game of football in his life before coming to Oregon, was given honorable mention among the Collier's 1937 all-American selections.

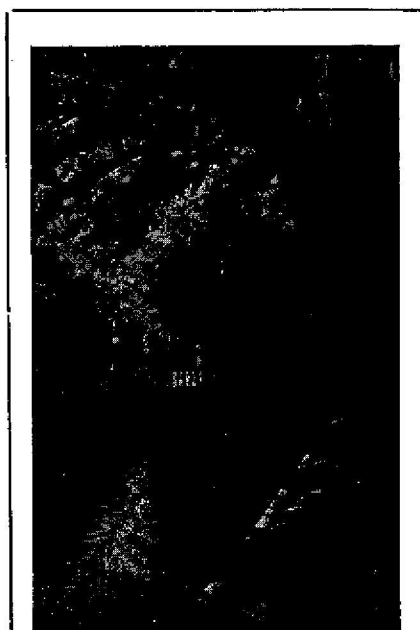
