Redmond, Ore., November 12, 1938

Dear Mr. Pease:

Enclosed you will find the only group picture of the hunt with Joe Gordon. We have several individual pictures, which have been published in the Oregonian and other newspapers, but for your purposes we believe you will want the group. Reading from left: Virgil H. Langtry, LL.B. '34, Joe Gordon on horse, the lynx in the Bruin's embrace, Joe C. Brown, Journal-ism '30, and Bill Kenna, Physical Ed. '35 or '36. Others on the hunt not in the picture are Robert Foley, LL.B. '35, and Chandler Noe, Journalism around '31, both of Bend. John Londahl, Phys. Ed. wasn't on the hunt because he couldn't get out of bed early enough. Our guides and owners of the hounds were Duffy Knorr and Cliff Ralston of Redmond as were all those in the picture.

The hunt occurred in the Metolius river country west of Redmond, the entire party stayed the entire period of the hunt at the summer homes of Joe C. Brown, '30, and Alice Foley, '06. The cabins are situated on the Metolius river. The first day the party was in the saddle about six hours, when the hounds hit a hot lynx trail.. Within a mile of hard riding through brush, over logs and fences, and through the forest the cat was treed. Gordon brought him down with his first shot.

On the second day, Sunday, November 6, 1938, we started at dawn in weather about 10 above zero. We rode for about seven hours without hitting a trail, but then the hounds hit the trail of what appeared to be a larger for the second seven hours. peared to be a large bear from the tracks in occasional patches of snow. The bear went up the side of a steep ridge, and together with the dogs and one of the

guides, left the party behind. The horses could not negotiate the steep slope as swiftly as the bounds, with the exception of the horse Ralston was on. At the top of the ridge we were able to follow the tracks in snow which was then six inches deep. After getting to the top we rode break-neck through dense thickets and over logs for approximately a mile, and came upon Ralston with the bear up a tree. The dogs had found the track of another bear and left in pursuit of him. Ralston had kept the bear treed while the rest were coming up. Gordon and Knorr shot almost simultaneously at the bear, a large brown one, perched on a limb 50 feet from the ground. He moved his head as the shots were fired, and both shots only grazed his neck and head. He started down, throwing the horses into a panic which was hard for us to quell, while Gordon and Knorr continued to pump lead into the bear. When he reached the earth he was content to dive into a thicket to die, although he looked very much alive. Knorr went in after him, followed by Gordon, and found him dead. Knorr discovered later that he had followed the bear with an empty gun.

The bear weighed out 463 pounds, being one of the largest ever bagged in this

section.

Gordon has the hide which will be made into a rug. The dogs got tired of waiting for us to catch up with the other bear toward morning of the next day and came



New York Alumni Meet With Dr. Erb

President Donald M. Erb was the guest of honor at a dinner given by the Oregon Alumni in New York City on Thursday, November 17, at the Town Hall club.

The President, upon being introduced by John M. MacGregor (1923) who acted as toastmaster, brought greetings from Chancellor Hunter and the University faculty. Apparently the Chancellor remembers the evening he spent with this group two years ago, at which time he and President Boyer were the guests.

Dr. Erb told the group about the present status of the University, its new buildings completed and projected, its student body and its faculty. He especially delighted some eighty alumni who were in attendance by telling them of the individual members of the faculty whom they remember. A strong tie has always existed between many of the New York alumni and the faculty.

The President was given a very enthusiastic reception. Dr. Oswald Garrison Villard (Hon. 1935) attended and delivered a gracious extemporaneous address. Dr. Harry S. Rogers, formerly the Dean of Engineering at Oregon State College and now President of the Brooklyn Polytechnic Institute, Dr. Edward S. Evenden, a member of the faculty at Columbia, at one time on the staff of the Oregon Normal School, and Dr. Donald P. Cottrell, an authority on college administration at Columbia, were present to extend greetings to President Erb. Will Grant, President of the University of Washington Alumni in New York, was a guest and advocated, while acknowledging greetings, a joint dinner by the Washington and Oregon groups in New York.

Virgil Johnson (class of 1896), a son of Oregon's first President, and Dr. Allen Eaton (class of 1902, Hon. 1937) gave some of the early history of the University. Both referred to the part played in the founding of the University by Henry Villard, whose son was present, and each mentioned President Johnson, Dr. Eaton described the first dress suits to make an appearance on the Oregon campus, and told the now famous story of Lash Applegate's subscription at the time the University was placed in Eugene. He then presented to President Erb some old documents pertaining to the early history. One was a letter from Mrs. Ellen McCormack, of the first graduating class, referring to her father, Dr. Thomas Condon's tribute to

Henry Villard. A second was a letter from President Johnson to members of the faculty, asking them to help pay off a judgment held against the University property. A third was a complete list of the first subscribers to the University Association, made in compliance with the demand by the Oregon legislature that a promise to raise a certain sum by a given time be redeemed. It is on this list that the signature of Lash Applegate shows that he subscribed to 251 shares, or a total of \$25,100. Another document was the second list of subscribers to this fund, bearing names of the citizens of Eugene who pledged not only cash but farm products, labor, merchandise, etc. These were accepted with thanks by Dr. Erb.

Paul Ager (class of 1925), now the budget director of the T.V.A. camps, and his wife, Marion Phy Ager, timed a business trip from Knoxville so that they could be present at the dinner. John Rae, who is a colleague of Dr. Erb's on the Economics faculty, came down from Bridgeport for the occa-

Employment Opportunity

The following memorandum has been received by the Alumni office from the placement division of the

University:

The University Employment Service operated by the University with the cooperation of alumni and Dads organizations is receiving an increasing number of calls for college graduates, both men and women, with a little experience after graduation. Many of these it is unable to fill for lack of available persons. It is altogether probable that there are alumni who would be both qualified and interested in these places, but they have not listed themselves and so are not known to the office and in consequence cannot be recommended for consideration

by prospective employers.

Very few University of Oregon alumni are unemployed and seeking work, but doubtless a great many, although employed and not seeking a change would be glad to be considered for a position which would constitute a worth-while promotion. It is this latter class which it is particularly desired to have Isited. In a number of instances during recent months positions carrying substantial salaries have gone begging, although we are morally certain that we have alumni who would fill them adequately and be mighty glad to have them. But it is urged that alumni, even though they are not at all dissatisfied with their present places and do not wish to suggest to their present employers that they are looking for work elsewhere, merelylist themselves not as applicants for jobs but as alumni with certain training and experience and professional or business interests. Then when employing concerns come to us looking for men for junior executive positions, for instance, or requiring maturity and experience beyond that possessed by most college graduates, we will be able to go over with them the alumni listed and help them to select one or two appropriate ones to whom to make their proposition.

The increasing activity of the Oregon Dads and of leaders among the alumni in the placement field is likely to increase substantially the number of such calls received at the University. It is accordingly appropriate for young graduates who, although not seeking employment, would be interested in propositions for promotion to list themselves promptly. One position for which we have had call for

a number of months but have not been able to fill is that for a man having had experience of- successful salesmanship and bookkeeping for an attractive position with a high-class employer.

SDX Chapter Best

The University of Oregon chapter of Sigma Delta Chi, national professional journalism fraternity, has been named the best in the nation according to word received by the local chapter. The award is a tribute to the professional standards of the school of journalism.

À score of 96—the highest ever given to any chapter—was given to the Oregon chapter in the annual competition. Activities of the local chapter have included: contests for the best weekly newspapers of the state, the best high school papers, best news stories in non-metropolitan papers, community service award, arranging for the campus appearance of nationally-known speakers. The high scholarship rating of the members and their journalism activities counted heavily in the contest.

At the national convention held in Milwaukie, Wis., Palmer Hoyt, '23, manager of *The Oregonian* was named national treasurer of the organization. Harry Schenk Named ONPA Manager

Harry S. Schenk, advertising manager of the McMinnville Telephone-Register, has been appointed manager of the Oregon Newspaper Publishers association to succeed Arne Rae, '22, whose resignation will be effective January 1. The appointment of Mr. Schenk, '33, as assistant professor of journalism to succeed Mr. Rae in that position in the University of Oregon has been recommended to Chancellor Hunter and the Oregon State Board of Higher Education by President Erb and Dean Eric W. Aflen.

Although Mr. Schenk will not officially assume his duties with the ONPA until January 1, he plans to get into Eugene on week-ends and to spend more time during December acquainting himself with the duties of the office.

Following his graduation from the U. of O. school of journalism in 1933 he joined the advertising staff of the Eugene Register - Guard. From there he went to McMinnville to become advertising manager of the T.R. Prior to his graduation he had been employed in advertising work on the Oregon Journal, Portland, and during his senior year at the University was business manager of the Oregon Daily Emerald, student publication. While in the University he was also active in Alpha Delta Sigma, professional advertising fraternity, of which he was a president.

Last spring Mr. Schenk completed a term as president of the ONPA Advertising Managers, and since the creation of that organization has been active in its affairs. He also served as chairman of the advertising promotion

entitled "Fresh Light on the Antiquity of Man in America."

Skeletal remains, basketry and other evidences of men who lived in Oregon approximately 10,000 or more years ago, were found in caves in the Catlow and other regions of southeastern Oregon, the article relates. Photographs of the objects, as well as maps and scenes of that section of the state, are used to illustrate the article.

The article states "In view of what has been found Dr. Crassman is confident that if the remains of early men are to be found anywhere in the northwest, such evidence exists in the Pleistocene caves of the Oregon area. The work that he has done strengthens this opinion and also the conviction of many scientists working on the subject that Man was actually present in America, if not actually during the glacial time, then surely during very early post-glacial time."

The Carnegie Institution has shown a great interest in Dr. Cressman's work, and has aided in sponsoring expeditions of exploration. A display

In conquest of the Pacific Coast conference basketball title with nine lettermen from last year's Northern division championship team, the Oregon Webfoots will barnstorm the east during the Christmas holiday season for a nine-game schedule.

Opening in New York December 17 agaist City college, the Hobson crew will attempt to take the measure of such first-rate quintets as Miami university, Cleveland, Wayne university, Detroit, Drake of Des Moines, and finally a revenge game against the Stanford Indians in San Francisco for the trouncing they gave the Ducks in last year's Coast play-off.

Four pre-schedule games with Portland industrial teams will reveal to Coach Hobson what wrinkles in team play need ironing out before the

scheduled eastern trip.

Lacking the form that carried them to the top of the division last year, the Webfoots are still fighting for their varsity posts—Gale, Wintermute, Anet and Johansen still being pressed by lettermen Hardy, Mullen, Pavalunas, Dick and Sarpola. Hobson indicated several non-lettermen from last year's freshman squad will get a tryout, Earl Sandness, Toivo Piippo, Evert McNeeley, and "Porky" Andrews considered as possible varsity material.

Oregon 0, OSC 14

The season-old habit of forgetting about the last quarter played havoc with Tex Oliver's Webfoots in the annual "civil war" battle with Ore-

gon State's Beavers. The tune was a pair of touchdowns, the music was furnished by Jim Kisselburgh, Orange fullback, and the finale was a fanfare of 14 points. Thus, for the third successive year, the Webfoots failed to cross the State goal.

For three quarters the two elevens played nip and tuck, the Oregon offense bogging down on the Orange 20, and the Staters going to the Webfoots' 22 in the third period. Suddenly Kisselburgh shot through a hole at center just as the third quarter ended for a 32-yard gain to the Oregon 7-yard line. With the last quarter

a minute old the sophomore State back had crashed for a touchdown that gave the Orangemen a lead.

The second touchdown followed quickly, after Oregon's desperate passes had carried them to the Orange 29, Hutchins intercepting a flat pass from Jimmy Nicholson and running it back to the 40-yard line. Higgins' punt return for 38 yards to the Oregon 28, was followed by line plays, Kisselburgh again going over from the one-yard mark.

Injuries to the first-string guards provided a weak spot in the Oregon line which OSC capitalized on.

Oregon 3, Washington 0

Washington's revamped Huskies who took the measure of the Coast conference champs, USC, the week before found the jinx of Oregon victories too much for them to handle and went down to a 3-0 defeat, the Webfoots scoring on a field goal by Nicholson. Hailed as a good passing outfit, and with Oregon having shown a decided weakness during previous games in pass defense, the Huskies threw the football all over the field, but succeeded in completing only one pass, that good for one yard. The Duck forward wall was stubborn and refused to yield to the pounding of the Washington backs, and Reginato, Lance, and Yerby, ends, kept Jimmy Johnston bottled up all afternoon.

Jimmy Nicholson, in addition to booting the necessary field goal for victory, passed and ran the Huskies dizzy, and was by far the outstanding back of the day. Donovan, Gebhardt, and Cadenasso also showed to advantage.

Oregon 0, California 20

The California Golden Bears of Berkeley, defending champs of the conference, found the Oregon eleven too strong to risk the second team against, after the Olivermen had marched half the length of the field in the first minutes of the game to place the ball on the 10-yard line, and rushed the regulars in to halt the drive. For two quarters the Webfoots tried gamely to score, taking the ball within scoring distance twice, but the big California line aided by Oregon penalties, held and with the aid of a long forward pass from Vic Bottari to Louis Smith scored twice in the last two minutes of the second period.

Again the Bears came back and marched 61 yards to scoring ground in the opening minutes of the second period, but Oregon stiffened and held the score down from then on, with offensive thrusts of their own going to the 15, and the 6.

Stenstrom was the shining light of the day, carrying the ball for 81 yards in one series of offensive threats, but the Webfoots were unable to push a touchdown across.

Oregon 19, Idaho 6

The Homecoming game at Eugene brought the favored Vandals from Moscow to the lair of the Webfoots. After Ray Smith, fleet Idaho end, had crossed Oregon's goal in the second period, on a pass from Hal Roise, the Webfoots came from behind and tied the count on a brilliant 92-yard run by Bob Smith. Nicholson put the Ducks ahead with a try-for-point.

In the third period the Webfoots scored on a long run as Ted Gebhardt sped through a hole in the center of the line for 34 yards. Gebhardt scored again shortly after, from the one-yard mark following Nicholson's 65-yard runback of a punt.

Oregon 7, USC 31

The Coast conference winners, USC's Trojans, ran rough-shod over the Webfoots on Portland's Multnomah field, 31-7, with Lansdell occupying the role of the unstoppable back.

The defeat was the third for the Webfoots since they entrained on their 7000-mile cross-country jaunt.


Lansdell's pass to Stanley set up the first score on the Oregon 13, where an interference penalty put the ball. Another pass to Morgan was good for the score.

Lansdell himself scored a few minutes later from the 4-yard mark, after a series of line plays and end runs.

Ollie Day, another quarterback, shot a pass over Gebhardt's head just before the half-time for the third touchdown, to give the Trojans an 18-0 lead.

Oregon came back stronger in the second half, but the Trojans scored twice more. Banta bucked over for a score, after a 34-yard ground attack, and Boyle Nave picked up a rolling punt to gallop 66 yards behind perfect interference.

Oregon's score came in the final quarter. Hank Nilsen intercepted Nave's pass on the Trojan 48 and dashed to the 24. Gammon made three yards, and then Jimmy Nicholson romped 18 around left end before lateralling to Bill Rach, the Oregon fullback, who went to the Trojan 9. Rach went to the 4, and then Nicholson passed to Bob Blenkinsop for the touchdown. Nicholson kicked the goal.

It occurs to me that there is a noticeable lack of cooperation of the latent power and strength of the great mass of former Oregon students. Is it possible that we have a small group who form alumni poli-cies without asking for comment or suggestion or who disregard them when offered, or is it a case of everyone not giving a whoop—except the small minority who prefer a "status quo" for some reason or other? If it is the latter then we have no one to blame but ourselves for not exercising our prerogative-alumni voting.

I attended class reunion and homecoming this year and since have been forced to make comparisons. If the several examples of alumni organizing which I have seen recently are typical of other work, then I believe there is a bad case of "dry rot" in the timber structure of the good ship "Old Oregon" and it is about time we do some dry-docking and see what is wrong.

To assist in bettering our organization

I recommend this:

1. Ask and allow constructive criticism through OLD OREGON and the Oregon

2. See that the paid secretariat organizes and follows up on local alumni chapters. (If such is being done I find no comment on it either in the alumni publication or from inquiries.)

Let's ouit "joking" and hear what others have to say—we might get a few surprises that have been long delayed and badly

needed.
