Homecoming to Be November 10, 11, 12

Home to honor Oregon has again been named the Homecoming slogan. With advance ticket sales the biggest in history, attendance at this year's Homecoming is expected to top them all.

Six big events have been scheduled to fill the Armistice day weekend. Due to the fact that Saturday, November 11, is a holiday, many people will come to the campus on Friday and make a three-day holiday of the annual event.

Starting Friday afternoon with the construction of Homecoming signs which will carry out the motif of "remember when" and work on the floats for the noise parade, the undergraduates will carry through a weekend of work to stage the "biggest celebration ever."

The noise parade, as in past years, will form at the Southern Pacific depot and proceed to the site of the Frosh bonfire. The route of the parade has been set as follows: Form at the depot, proceed up Willamette to Broadway, follow Broadway to High, across High to Nineteenth where the bonfire will form the center of a real rally.

Torchlight Parade

The noise parade will be led by a torchlight parade of freshmen and will have every conceivable noise making device. Last year the winning float had a chassis of a model T Ford mounted on a truck, chains were tied to the rear wheels. When the motor was raced, the chains hit against huge circular saws. In addition to this, the float had a trailer on which saws were mounted, and the boys drove compressed-air hammers against them. Richard Werschkul, '40, is in charge of the parade.

The bonfire will be on the same site as last year, out on the Amazon flats. The rally will be held on Nineteenth street. Yell King Bob Elliot, '40, and rally committee chairman, Bob Hochuli, '40, have promised the noisiest send-off any team ever had. Les Anderson,

'43, president of the Freshman class, has appointed Len Baliff, '43, and Bob McGill, '43, as co-chairmen for the Frosh Bonfire.

The Homecoming signs to be constructed by every living organization will also carry out the motif of "remember when." Bob Corby, '40, has announced that the signs will be ready on Friday afternoon at five o'clock and will remain illuminated until midnight.

Mojica to Play





Faculty Changes Announced

Dr. Hugh B. Wood, specialist in curriculum development, has been added to the faculty of the school of education. Dr. Wood has had much practical experience in the field of curriculum building and assisted in revising the courses at Chester, Pennsylvania; Hamilton county and Chattanooga, Tennessee; and Ridgefield, Connecticut.

For the past year Dr. Wood has been associate professor of education at the Alabama Polytechnic Institute, and before that was associated in curriculum at Columbia university. Dr. Wood took his doctorate at Columbia university.

Dr. Harold Merriam

Dr. Harold G. Merriam comes to the University to join the faculty of the college of arts and letters from the University of Montana. Dr. Merriam has been the outstanding leader in the field of northwest regional literature for the past twenty years.

Dr. Merriam was the founder of the literary magazine, *The Frontier*, at the University of Montana, in 1920. Later it was merged with another regional publication. Since 1933 Dr. Merriam has been owner, editor, and publisher of the *Frontier* and *Midland*. The publication of the periodical has been temporarily suspended.

Dr. Merriam was chairman of the department of English and of the department of humanities at Montana, and served on the state and district Rhodes scholar selection committee.

Dr. Merriam was the first Rhodes scholar from the state of Wyoming and received the B.A. and M.A. degrees at Oxford. He later attended Columbia university, where he was awarded the Ph.D. He has been a member of the faculties of Whitman, Beloit, and Reed colleges. His daughter, Allison, is now attending the University, where she is enrolled in the psychology department.

Dr. Harold R. Crosland, associate professor of psychology, will go to Palo Alto during winter term where he will be acting professor of psychology for the Stanford winter quarter.

Paul R. Washke, professor of physical education, is attending the New York university center for safety education this year. Mr. Washke was awarded a scholarship to the center. Objectives of the safety center are the

training of teachers, supervisors, and engineers to become specialists in the various fields of safety, and the conduct of research that will help provide answers to safety problems.

R. Harrison Mast

Dr. R. Harrison Mast, M.D. '24, was killed in Portland, Oregon, on October 8 as the result of an accidental fall from the eighth floor of the Congress hotel. Dr. Mast was believed to have fallen from the window while opening it prior to going to bed.

Dr. Mast was one of the most prominent physicians and surgeons in southwestern Oregon and had a large practice in the Coos Bay area, where he made his home at Myrtle Point. He was forty-three years old.

"Bucky" Mast was one of the most outstanding freshmen football prospects ever enrolled at the University. While a member of the Freshman squad he was hurt in scrimmage practice and was never able to play again.

Dr. Mast was a member of the Knights Templar and the American Legion. He is survived by his widow and stepdaughter, and his son, R. Harrison Mast, Jr., '39, who is now attending the University.

Arthur James Collier

Arthur J. Collier, B.A. '88, M.A. '93, who at one time was professor of geology at Oregon, died October 12 at his home in Coronado, California. Mr. Collier was the son of George H. Collier, who was a member of the first faculty of the University.

Mr. Collier for many years was with the United States geological survey of Washington, D. C., but retired two years ago because of poor health.

He is survived by his widow, a brother, David R. Collier, ex-'98; a sister, Mrs. Mary Collier Johnson, '94; and a niece, Dr. Dorothy Collier, '18.

Lloyd O. Harding

Lloyd O. (Ben) Harding, B.A. '12, died suddenly on October 20. Mr. Harding was mayor of Oregon City at the time of his death and operated a drug store founded by his father.

Mr. Harding was a member of the American Legion, Elks, Rotary club and Beta Theta Pi. He is survived by his brother and three sisters, Mrs.

Nieta Harding McKinney, '09; Mrs. Evelyn Harding Laxton, ex-'16, and Mrs. Edward E. Brodie.

To Appear in Portland

Arno Dosch-Fleurot, I.L.B. '00, will appear in the Town Hall series in Portland on December 4. Mr. Dosch-Fleurot has lived for many years in Cannes, France, where he was with the International News Service. At the outbreak of the war he was in Salsburg. He and Mrs. Dosch-Fleurot arrived in New York in the middle of October. His book, "Through War to Revolution," was published in England in 1931.

Portland Duck Club

The Portland Duck club has been meeting all fall every Monday noon at the Imperial hotel. Among the activities sponsored by the group was the Oregon Frosh vs. Oregon State Rook game played in Portland on October 13. Attendance at the game exceeded 7,000.

The Duck club serves as a booster group for Oregon athletics and meets to do a little "quarterbacking" on Mondays. Omar "Slug" Palmer, ex-'32, is president of the club and Don B. McCormick, ex-'32, is secretary.

The 1939 University of Oregon yearbook, the *Oregana*, has been judged one of the six best in the United States.

In scoring the high position among similar college publications the yearbook won 915 of a possible 1,000 points. The book was edited by Don Root, '39, and managed by Dick Williams, '41.

Webfoots Beat California, Drop Two

Oregon 6, California 0

When the Webfoot grid warriors trotted off the California Memorial Stadium greensward, they had just made a football dream come true.

Six points, looming large on the scoreboard, told a tale of a wild struggle which had taken place that afternoon, October 14. And they told a story of a great Oregon victory, although the score favored the Webfoots only 6 to 0.

But that wasn't all. That Cal victory was the climax of an Oregon football chapter that will live for years.

In three short weeks, the Olivermen tied Southern California, 7 to 7; whipped Stanford, 10 to 0; and dropped the Bears by one touchdown.

No other Oregon team had ever done this. Sports writers all up and down the coast said it couldn't be done this year. But the Ducks made it good.

Not since 1926 had the Webfoots beaten the Bears, and not since 1915 had they so much as even tied the mighty Trojans of Southern California.

The lone touchdown of the desperately battled Cal game came in the second quarter. Marshall Stenstrom put the finishing touches to a 62-yard drive as, on the second play from the California three-yard mark, he drove over guard for the score.

The march had started five minutes before on the Oregon 24-yard line. Twelve plays the Webfoots took to sink their cleats into scoring territory.

Jay Graybeal missed the extra point, but it really didn't matter. Those Oregon boys were marching, and they set out to score again with only 3 minutes and 50 seconds left of the half.

They almost did, too. They traveled from the California 48 as far as the 9, only to lose the ball to the Bears on a pass interception.

In the wild last half, California came back, and with Orr Hatcher leading a second-string charge, they threatened the Oregon goal line. Each time they moved into Webfoot territory, a determined defense cut them down, short of pay dirt. And as the game wore on, the Webfoots battled back to keep their lead.

Gonzaga 12, Oregon 7

Oregon's conquering Webfoots certainly should have taken out a big slice of "Upset Insurance" prior to their

Gonzaga game on Hayward field, October 21.

For if ever they needed it, it was against the aroused Bulldogs from Spokane. Alert and efficient, the Bulldog machine whopped the Webfoots, 12 to 7, and the echo of this upset sounded from coast to coast.

The effect of that "gigantic" was terrific. It blasted Oregon football hopes of an undefeated season, sent Rose Bowl dreams skimming, and spoiled a triumphant Webfoot homecoming that had gained momentum with the success of the OREGONS against the California "big three" on successive Saturdays.

Bleacherites are prone to term the Webfoot showing a "natural letdown," but even this cannot take away the Gonzaga glory. The Bulldogs presented a team that knew what it was doing all the time, and it made few mistakes.

Hero of the Gonzaga victory was a lithe, gray-haired young man named Tony (Spook) Canadeo. Canadeo kept the Oregon secondary jittery all afternoon with his thrusts and passes. And it was two of his rifle-like heaves that counted both Bulldog touchdowns.

Oregon's touchdown came early in the third period when Jackrabbit Jay Graybeal uncorked a 20-yard pass to End Vic Reginato, who gathered the pigskin to his bosom across the Gonzaga goal line. This score gave the Webfoots a 7-to-0 jump on the visitors.

This lead was short-lived, however, as the Bulldogs hit pay dirt just before the third quarter ended.

The Gonzaga thrust that netted six points came with the Bulldogs on their own 34. Bulldog maneuvers, never complex until here, suddenly unfolded a criss-cross, lateral, and forward pass all on the same play and there was the Gonzaga touchdown.

Cecil Hare took the ball from center, tossed it to Derr, who lateralled it out to Canadeo, who then tossed 46 yards to End Jones on the Oregon 20. Jones caught the ball behind the Oregon secondary and galloped across.

Canadeo's second touchdown heave was for eight yards, this time to Jacobson, who fell across the line.

Trailing, 12 to 7, and with 10 minutes of the game left to play, the Webfoots began marching again, but three Webfoot aeriels deep in Gonzaga territory went awry, and the OREGONS were done for.

UCLA 16, Oregon 6

The breaks of the game and a couple of dusky flashes, Jackie Robinson and Kenny Washington, combined to slap Oregon coast championship hopes all over Los Angeles' huge Memorial Coliseum and give the UCLA Bruins a 16-to-6 verdict over an Oregon team that showed superiority in everything but touchdowns.

The defeat, before 50,000 fans, was the first for Oregon in conference competition.

The story of the Webfoot loss was a sad one, not only from the standpoint of Rose Bowl dreams and conference honors, but from the statistics angle.

Driving hard, the big Webfoot eleven pushed the Bruins continually backward all afternoon, rolling up 17 first downs to the Uclans' four. More than this, the Ducks made a total of 221 yards from rushing and 77 more on nine completed passes in 24 attempts for a grand total of 298 yards. All this against UCLA's 183 yards from rushing and one completed forward pass.

Three times, the Olivermen were on the verge of touchdowns, only to have a fumble or mistake ruin their chances. Once they reached the six-inch mark and fumbled. Another time they were halted on the UCLA 2.

What's more, the Webfoot line blocked three UCLA punts, and continually outrushed the Uclans.

All this driving play of the Webfoots went for naught, however, as Jackie Robinson scored twice on two plays. His first score came on a pass from Negro Teammate Ken (the General) Washington, Robinson taking the 40-yard heave on the Oregon 16 and crossing the goal line. This score gave the Bruins a 9-to-6 halftime advantage.

Robinson's second touchdown play, a beautiful 82-yard run down the sidelines, came in the third period and was the game "clincher."

UCLA scored a field goal after recovering Jay Graybeal's fumble on the Oregon 20 early in the game. Jack Sommers kicked the goal from the 30-yard line.

Oregon's only touchdown came in the second period after a 64-yard march. Bob Smith plunged over from the 2 for the tally.

DUCK TALK

Football fans throughout the state of Oregon have long been hoping for just such a year as this one—a year in which both of their college football teams are at or near the top of the coast conference standings.

So far this has been Old Man Oregon's biggest football year in two decades. Oregon State, at this writing, is undefeated and boasts victories over Stanford, Portland university, Idaho, Washington, and Washington State. And Oregon, though beaten by Gonzaga and UCLA, nevertheless is definitely one of the coast's top grid teams.

That's what makes this fall's Oregon Homecoming celebration such a natural. Headline feature of this celebration is the clash between the football powers of Oregon and Oregon State, and this contest may have a definite bearing on Rose Bowl and conference honors.

If Oregon State whips the Trojans of Southern California in Portland November 4, the big Beavers will bring to Eugene the rating of the coast's No. 1 football threat. And although the Webfoots would be tickled to see Oregon State play in the Rose Bowl, their biggest aim would be to knock those Beavers off their high horses. What's more, Tex Oliver's 1939 Webfoots may have the stuff to do it.

Short shots . . . Puzzling mystery to campus grid bugs is the showing of John Warren's frosh team this year. The Frosh have been beaten by the OSC Rooks, 19 to 0, and by the Washington Babe in an identical score. The opinion prevails that the Frosh have material but just can't get a team to click.

Joe Gordon, Yankee second baseman, has announced that he will take graduate work at the University of Oregon winter term. Gordon is hunting in eastern Oregon this fall.

Other professional and ex-Oregon diamond stars at Oregon this fall are Bob Hardy, Ford Mullen, and John Linde.

Oregon's varsity basketball players started practice November 1. Coach Hobby Hobson has his largest turnout in several years (transfers, varsity men, reserves, and holdovers virtually overrun McArthur Court).

Fifteen contests are slated on the Ducks' transcontinental barnstorming trip this winter. Highlight of the trip, of course, is Oregon's Madison Square Garden appearance against Long Island University.
