EDUCATIONAL NEWS DIGEST

1. About one year ago a Corporate Alumnus Program was established by the General Electric Educational and Charitable Fund. Through this new program, the Fund agreed to match, under certain conditions, contributions up to \$1,000 by employees of General Electric to the colleges and universities from which they held degrees.

We know now that CAP will continue in 1956. A new provision interprets *alumnus* as most colleges do: the Fund will match gifts made to any college at which an employee was *in attendance* one year or more. An employee may now contribute to a college at which he did not complete requirements for a degree.

Wide range of participation in the Program is shown by the fact that gifts have ranged all the way from \$1 to the limit of \$1,000. On October 1, there were 3,113 contributions to 285 colleges, totaling \$116,877; any alumnus who reads his mail knows that the modest gifts count as they never counted before.

2. A fifth university will start offering the G-E Fellowship Program for high-school teachers in the summer of 1956; Syracuse University will conduct a program in science for 50 high-school teachers. This particular program—like those in science and math, in Union, RPI, Case, and Purdue—will be underwritten by General Electric from the time the teacher leaves home till he returns six weeks later. These five challenging programs are at graduate levels. Our participation also includes scheduled lectures and trips to plants and laboratories to hear and observe how mathematics and science are used in modern business.

The Teacher Fellowships Program began in 1945 at Union, and that summer there was but one session of 50 teachers. By now, approximately 1,350 teachers have had the benefit of these special programs, have themselves been taught by distinguished professors, and have in turn brought to their several hundred

thousand students the undebatable truth that the well-grounded student will soon find the pages of his textbook coming to life in his chosen career.

3. We attempt in our various plant locations to help our people help themselves. Here's a variation of a plan, now in effect at Schenectady: 35 young men, who might otherwise have foregone going to college and earning a technical degree, are now at work as apprentices at General Electric and in attendance at Union College. These young men were graduated in the top half of their high-school class, came out well on the College Board tests, had an academic diploma with 16 full credits (almost half of them in English and math), and demonstrated a genuine desire for a college education.

These men are full-time apprentices in drafting, machining, pattern making, and metal founding. At the end of 8,000 hours of apprenticeship, they will have completed, after business hours, and with tuition paid by the Company, two full years of college. They may then apply for a leave of absence to work for a degree on a full-time basis, or continue their educations at night, still working full time for G.E.

4. A new booklet, GROWING WITH GENERAL ELECTRIC, is designed to do two things: to introduce General Electric's 10 Programs for college graduates to potential employees and to serve generally as a guidance tool in the hands of alumnus, parent, and instructor. Each Program is presented on a single page in such a way that the reader can determine immediately what "majors" must show on the student's record if he wishes to be considered for admission to that Program. Since the matter of prerequisites looms up as a mighty problem to youth, and since the stated requirements are, with minor variations, generally applicable in industry, such information should help the alumnus in his important function of youth guidance.

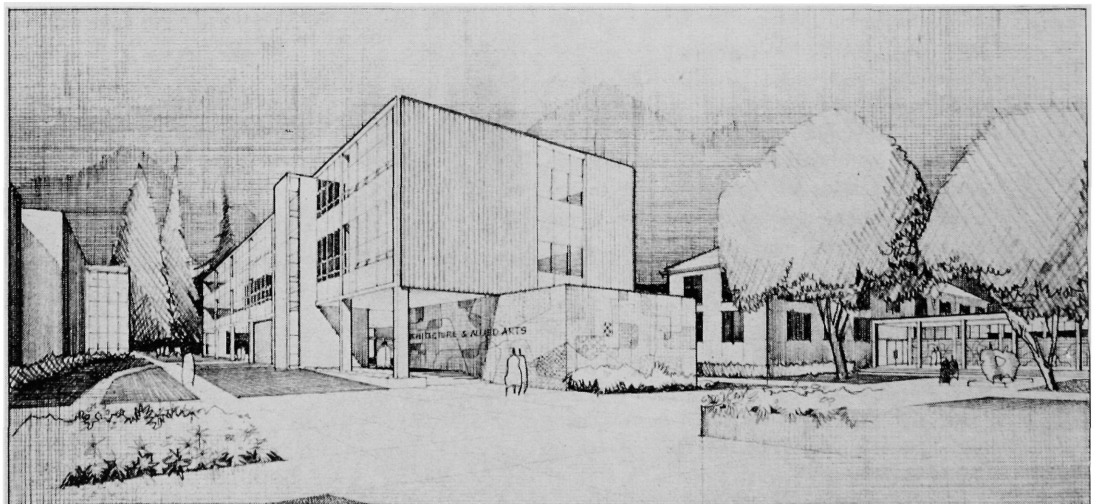

Architecture and All Will Be Modern, C

Now scattered about the campus in six buildings, including temporary quonsets, Oregon's 40-year-old Architecture and Allied Arts school will soon be located in one integrated, functional structure—and named the Ellis F Lawrence Hall in honor of its founder and first dean.

THE UNIVERSITY of Oregon School of Architecture and Allied Arts will have completely remodeled and modernized quarters by Fall term, 1957—including a new three-story concrete and glass south wing.

Demolition began in November on one third of the old building, that portion facing Allen Hall to the south, known as the gallery wing. Construction of the new wing on this site, and remodeling of the old building is scheduled to start in February.

Overall plans call for renovating part of the old building, rebuilding other parts and adding connecting galleries to the separate buildings, which now house the several areas of the school. The completed structure will consolidate into one building the full operation of the School's nine areas—architecture, interior architecture, landscape architecture, urban planning, drawing and painting, sculpture, applied design, art history, and art education—an important point in the administration of a creative arts curriculum.

The building, when finished, will provide more than 60,000 square feet, of which 31,585 square feet will be new. The 1955 Oregon Legislature appropriated \$550,000 for the project. Architects are Annand, Boone and Lei of Portland. It will be named Lawrence Hall in honor of the late Dean Ellis F. Lawrence, who organized the School in 1916, and served as its first head until 1945. Dean Lawrence was a practicing architect, and many buildings on the campus today are examples of his work.

Among the unique features in the new

wing will be a 200-seat classroom-auditorium, a large library, and four seminar rooms. In acoustic and audio-visual facilities the auditorium will be one of the best of its kind in the west. It will serve primarily as a lecture room for undergraduate classes in basic design, graphics and survey of visual arts, and for visiting lecturers. The library will have twice the capacity of the one now in use in the old building. Special provision has been made for the storage and protection of the School's valuable collection of 40,000 lantern slides—one of the largest on the coast.

One of the four seminar rooms will be a memorial to the late Professor W. R. B. Willcox, who was director of the curriculum for architecture for many years. The Willcox Memorial Room will be furnished by former students and alumni who studied under his direction. The room's interior is designed to create a general relaxing atmosphere in order that it can also be used as a student lounge. It will contain a bronze bust of Professor Willcox.

The old patio will be retained, but will be slightly enlarged. The familiar old Hawthorne tree will be returned to the patio area. The exterior of the new wing will provide large wall areas for experimental student work, such as the patio walls have in the past. Altogether 15 separate areas will be available for frescos, mural designs, mosaics and ceramics to be completed by students. Photographs have been made of all wall designs which have had to be destroyed to accommodate the additions.

Most of the remodeling of the old build-

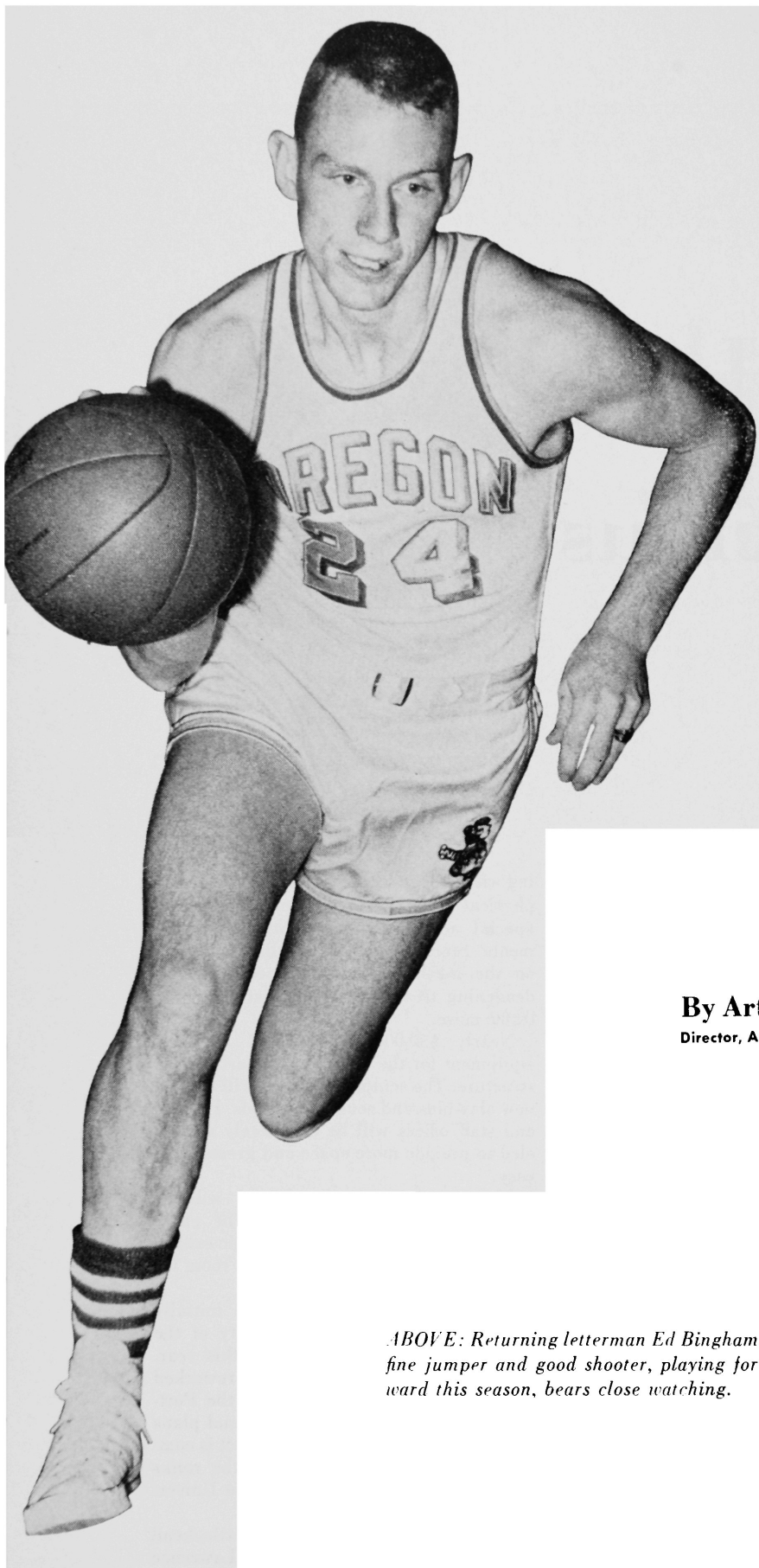
ing will be done by the University of Oregon physical plant. Modernization will include special acoustical and lighting improvements. Studios facing Franklin Boulevard on the north will receive special sound-deadening treatment to eliminate highway traffic noise.

Nearly \$50,000 is allocated for new equipment for the old and new parts of the structure. The sculpture section will receive new clay-bins and sculpture stands. Faculty and staff offices will be completely remodeled to provide more space and greater privacy.

Main entrance to the School will be through the new south wing. The entry foyer will be combined with a public exhibition space equipped with a special room for exhibits which must be protected.

Plans for Lawrence Hall were initially drawn up by students and faculty of the School during summer sessions this year. Subsequently, they were studied, reworked and modified by the faculty and the Portland architects in order that the final plans could be prepared. When the project is completed Lawrence Hall will join the ranks of other "guest attractions" on the University of Oregon campus.

According to Dean Sidney W. Little, head of the School since 1946, the new Lawrence Hall facilities should meet most anticipated teaching and working space needs over the next 10 to 20 years. The School's peak enrollment of 850 students was reached in 1949, and it is believed that this peak will not be exceeded within the next 10-year period.

Oregon enters the first round robin schedule in basketball history against California January 13 with five lettermen and a bunch of promising

Basketball Preview For the Oregon Ducks

A NEW OFFENSE. five lettermen and a large group of rookies hold the key to the possible success of the University of Oregon basketball team in the first round robin schedule in the history of the Pacific Coast Conference.

The new system of attack, which Coach Bill Borchert aptly tabs a "motion offense," is devised to use the number of medium sized Webfoots who have a reasonable amount of speed and to offset the lack of a "big man" on the 1955-56 roster. The Webfoot coach, who is starting his fifth season, will all but eliminate the standard post play in the 1956 system and use four "forwards" and one "guard," with the four "forwards" alternating in the center position.

The Ducks appear to be slightly improved over a year ago in the matter of speed, but may have trouble matching the rebounding power they showed in capturing second place in the final Northern Division standings. The key losses from a year ago were Co-Captain Jim Loscutt, who led the league in scoring and set a new PCC rebounding record as well as being named a unanimous selection on the all-division team, and Co-Captain Howard Page, a steady guard who surprised most fans with his steady performances.

The five lettermen are led by Max Anderson. Ray Bell and Jerry Ross, all two-year veterans, and Phil McHugh and Ed Bingham, who earned awards as sophomores a year ago. Anderson, who has been the regular center for the past two years, will probably be the key to the new offense and a good year by the ex-Portland prep star may make the Webfoots more dangerous than expected.

Bell, a fine defensive man and a better than average rebounder, also could add a considerable amount of punch to the attack if he finds his shooting eye. Ross, who operated at forward last year despite the fact he is but 6-1, has amazing jumping ability and can hit well from outside. His great speed, agility and ball handling should also stand him in good stead as he moves back to guard, although he will be in the post at times in the new attack. McHugh, the fine football end, is the third regular returning and Oregon fans learned a year ago to count on his fine floor play and defense and now hope that his shooting will improve with a year's experience.

Ed Bingham, another fine jumper and improving shooter, has moved back to guard after lettering at forward and should be of considerable help in the new attack. The

other returnees from last year's squad, forwards Frank Werner and Bill Moore and guards Rich Costi and Johnny Lundell, were non-lettermen as sophomores and are now taking their second crack at working their way into steady competition.

Costi, however, broke his arm in pre-season practice and may be lost for the season. His speed and shooting ability in the back court would help if he gets back. Moore, an improving shooter, may be held out this season, but the final decision has not yet been made. Werner rates as the most improved player on the squad and may be a help as the year goes along. Lundell, like Costi, has good speed and does well on defense, a factor which may assure him of considerable work.

The rookies are the question mark in the Webfoot plans and if they should develop rapidly, Oregon might become more of a factor in the league race than it appears in pre-season evaluations.

Charlie Franklin, a Los Angeles CC transfer who comes in as a sophomore, appears to be the outstanding new man on the basis of his shooting, speed and rebounding and it may be that he will take a place in the starting lineup early in the season.

The other new forwards include Quincy

Powers, a former Coos Bay star who was at Stanford as a freshman, and sophomores Paul Tuchardt, Larry Barnes and Marvin Swan. Powers, Tuchardt and Barnes have the best chance of getting into fairly regular action this season.

At center two sophomores, Hal Duffy and Eli Morgan, are the reserves for Anderson. Both need more experience and this particularly holds true in the case of Morgan, who missed his freshman season with an injured knee. It is likely that he will be held out this season.

Four sophomores, Wimp Hastings, Don Delbon, Roger Diddock and Bill Service, and a Menlo JC transfer, Nick Utt, are the new guards. Hastings, a fine floor man and defensive expert, has the best chance of breaking in while Delbon and Utt, both fine shooters, could see action at times.

One of Oregon's major problems in the first nine-team PCC race will be its schedule. The Webfoots are one of the four teams playing but seven of the 16 conference games at home and also have the misfortune to catch the teams with the strongest ratings on the road.

The Ducks will play two-game series with California, Southern California and Washington State at McArthur Court and have a

single game with Oregon State. Away from home Coach Bill Borcher's crew must face Idaho's promising sophomores, the talented Washington Huskies, UCLA's fine team, and the sharpshooting Stanford Indians in two games each and also go to Corvallis for a single contest.

A summary of the Oregon Ducks 1955-56 basketball prospects by position follows:

FORWARDS (fair — lack experienced depth) Losses — **Jim Loscutoff and **Gary McManus. Improved shooting by Ray Bell (6-5) and a good sophomore year by Charlie Franklin (6-3) would help considerably. Help may be forthcoming from Frank Werner (6-6), Bill Moore (6-4), if he isn't held out of competition, Quincy Powers (6-2) and Paul Tucharadt, the leading scorer on the freshman team a year ago.

CENTER (fair—lack depth). Losses—none. Max Anderson (6-7) holds the key here and the two-year regular appears to be ready for his best season. He does a fine job of shooting from outside, rebounds well, is dangerous with a hook with either hand and does a fine job on defense. Hal Duffy (6-6) and Eli Morgan (6-5) are both sophomores and will back up the veteran. Morgan, out last year with a bad knee, may be withheld from competition.

GUARDS (good). Losses — **Howard Page. Jerry Ross (6-1) and Phil McHugh (6-1) are both excellent basketball players with Ross perhaps having the better scoring touch and their presence gives the Ducks good strength in the backcourt. Ed Bingham (6-2), a converted forward, is also a fine prospect, and non-letterman Johnny Lundell and sophomore Wimp Hastings should help.

Fifth Year For Coach

Bill Borcher, '42, head basketball coach, is in his fifth season at Oregon this year. He came to Oregon from North Bend high school by way of Sacramento JC to play forward for Coach Howard Hobson in 1940 and 1941.

After four years in the Navy, Borcher became head basketball coach at Marshfield high school where for six consecutive seasons he compiled the top post-war coaching record in the state.

In four years at Oregon he has guided the Ducks to one undisputed second place, two shared runnerup finishes, and one third place—each being above the pre-season prediction.

1st and 3rd in Meet

Oregon's brilliant distance runners, Jim Bailey of Sidney, Australia, and Bill Dellinger of Springfield, again distinguished themselves and brought new athletic prestige to the Ducks as the result of their running in the annual Sugar Bowl Mile at New Orleans on Saturday, January 7.

Bailey, who passed Kansas State Teachers' College Bill Tidwell and Joe Villareal of Texas in the home stretch, won the 1500-meter event, establishing a new meet record of 3:25:1. Dellinger, in the last ten yards, spurred ahead of Villareal, to place third. Tidwell came in second.

The two Webfoot stars were the first Oregon track men to be invited to the week of athletic festivities which was climaxed by the Sugar Bowl football game.

Bailey, who won the NCAA mile championship as a sophomore last year, and Dellinger, who was the champion in his sophomore year (1954) and finished second last spring, were invited to take part in the meet by the Sugar Bowl Association last October and were in training for the race through some of the worst fall weather in Eugene history.

The runners were invited to come to New Orleans a week ahead of the race and they had ample time to get in their final workouts at the site of the race as well as see the many programs highlighting the holiday season.

Dick Near, a former Oregon letterman, who is now a resident of New Orleans, hosted Dellinger and Bailey and helped them outline a series of tours during their week long visit. The two runners stayed an extra day for the football game between Georgia Tech and Pittsburgh, flying back to Eugene in time to register for Winter term.

This is the story of Oregon's Brigadier General Don Z. Zimmerman—now shaping the minds of tomorrow's Air Force leaders.

He Educates Air Cadets

FEW GENERALS in this nation's military establishment finish high school at the age of 15, receive a Master of Arts degree at 21, and graduate from the U. S. Military Academy at West Point as a second lieutenant in the U. S. Army Corps of Engineers. Still fewer air force generals can claim the state of Oregon as their birthplace—and, in particular, the University of Oregon as their alma mater.

Such is the distinguished record of Brigadier General Don Z. Zimmerman, '23, U. S. Air Force, now Dean of Faculty at the new United States Air Force Academy, Lowry Air Force Base, Denver.

Don Z. Zimmerman, born November 25, 1903 in Eugene, Oregon, graduated from high school at the age of 15. He entered the University of Oregon, receiving his Bachelor of Arts degree in 1923 and his Master of Arts degree in 1924. Upon graduation from the University he received a Reserve commission in the Infantry, having completed four years of Infantry ROTC training.

In July, 1925, he entered the U. S. Military Academy, relinquishing his Reserve commission, and was graduated and commissioned a second lieutenant in the Corps of Engineers June 13, 1929.

Bent upon a career in military aviation he began flight training—studying at the Air Corps Primary Flying School at March Field, California and the Air Corps Advanced Flying School at Kelly Field, Texas. Receiving a pilot's rating, he was transferred to the Air Corps in October, 1930.

General Zimmerman's first assignment was as assistant commandant of cadets at Kelly Field. In December, 1930, he was transferred to the 65th Service Squadron at Luke Field, Hawaii, where he subsequently served with the Fourth Observation Squadron, the 72nd Bombardment Squad-

ron, the Fifth Composite Wing, and the 50th Observation Squadron. In February, 1934, he joined the 91st Observation Squadron at Crissy Field, California.

General Zimmerman studied for one year at the California Institute of Technology, completing a meteorological course in June, 1936. And in September he was assigned to the Department of Ground Training as an instructor and post weather officer at Randolph Field, Texas. During the last three months of 1939 he was assigned for special training at the Air Corps Tactical School at Maxwell Field, Alabama. During this period he wrote the text, "Weather Manual for Pilots," which was used at Air Corps Flying Schools throughout the country.

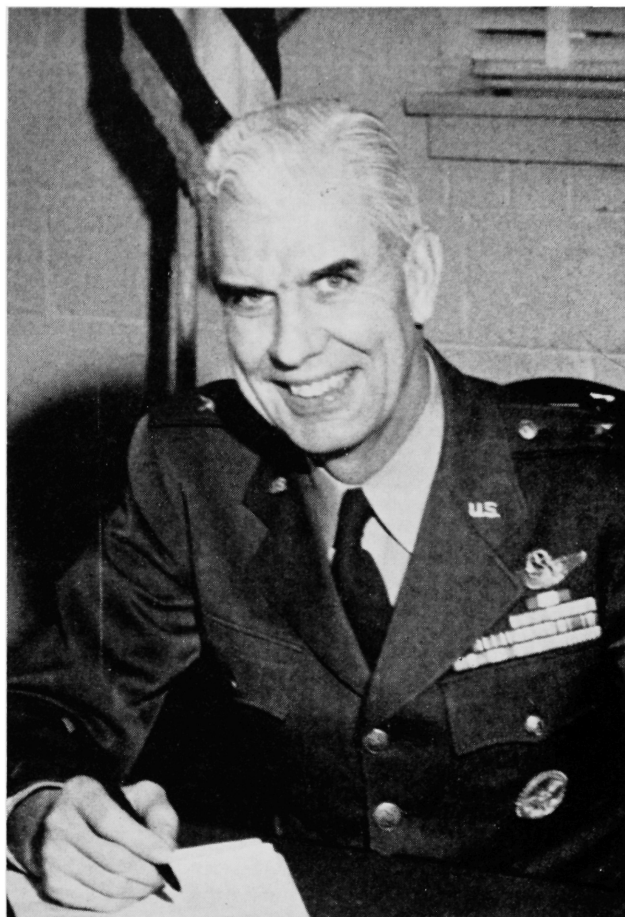
In July, 1940, General Zimmerman became an instructor at the U. S. Military Academy, which was followed by another period of study at the California Institute of

Technology. Shortly after the entry of the United States into World War II, he was named Director of Weather at the Army Air Force Headquarters, Washington, D. C. One year later he was assigned to the Third Bomber Command, MacDill Field, Florida, and in April became commanding officer of the 21st Bombardment Group there.

General Zimmerman was sent to the Central Pacific Area in September, 1943, to become assistant war plans officer of the Fifth Amphibious Force. The following May he was assigned to the Strategy and Policy Group of the War Department General Staff in Washington, and one month later was back again in the Pacific for duty with the U. S. Strategic Air Forces.

In November, 1945, following the end of World War II, General Zimmerman returned to the War Department General Staff

FROM EUGENE and the University of Oregon to become one of the nation's general officers—Dean of Faculty at the new U. S. Air Force Academy, Lowry Air Force Base, Denver, Colorado—Brigadier General Don Z. Zimmerman, '23, USAF.

New Men's Dormitory—Earl Hall—Dedicated December 2

The University's new dormitory for men—Virgil D. Earl Hall—occupied for the first time this Fall, was formally dedicated Friday evening, December 2.

Named in honor of the late Virgil D. Earl, Dean of Men from 1931 to 1945, the building cost \$1,250,000 and embodies the latest design innovations for modern campus living. The hall, located on Emerald Street between 14th and 15th Streets, is divided into five separate units, each with its individual living, dining and recreation rooms. Housing 330 freshman men—Earl Hall is an important link in the University's deferred living program.

Virgil D. Earl, born in 1880, died in 1949, just two years after retiring from a career of 24 years of service with the University. A graduate of 1906 from the University, he was a charter member of Oregon's Kappa Sigma fraternity. In 1923 he returned to the campus as Director of Athletics, and in 1931 became Dean of Men.

Earl Hall's five residential units are each named to permanently honor five other distinguished former faculty members—McClure, Morton, Young, Stafford and Sheldon.

Edgar McClure, the earliest of the faculty men, was Oregon's first teacher of modern chemistry. Born in 1861, he was educated both here and at Harvard. In 1887 he was tragically killed in a mountaineering accident at the age of 38. The old McClure Hall, long the chemistry department's quarters, was torn down in 1952, to make way for the new Allen Hall, which houses the School of Journalism and the University

Davis Walter Morton was Oregon's first Dean of the School of Business Administration. He came to the campus in 1915, and under his guidance developed the University's largest professional school. He died in 1941 at the age of 61.

Frederick George Young, the University's first Dean of the Graduate School, also headed the Department of Sociology, when it was formed in 1920. Dean Young came to Oregon from Albany College.

Known to countless former Oregon students is the late Orin Fletcher Stafford, who headed the Department of Chemistry from 1906 to the time of his death in 1941. From 1932 to 1941 he also served as Dean of the Lower Division and Science Departments. Dean Stafford was a member of the faculty for more than 40 years.

Founder of the Oregon State Teachers' Association, the School of Education's first dean, Harry Davidson Sheldon, taught at Oregon for nearly 48 years. He joined the faculty in 1900 and taught continuously until shortly before his death in 1948. Dr. Sheldon founded the University High School (adjacent to the School of Education, fac-

ing Alder Street), and made it a distinguished experimental training school.

Among the hundreds of guests attending the dedication of Earl Hall was Mrs. Virgil D. Earl, widow of the late dean.

Among the many prominent guests attending the Earl Hall dedication was Mrs. Virgil D. Earl, of Eugene, who presented a portrait of her late husband to President O. Mere-

dith Wilson for the University. The large oil-etched photograph will hang in the central lobby of the dormitory.

The five unit presidents were each presented plaques honoring the former faculty members for whom the units are named. One of the high points of the dedication was the presentation of the Sheldon unit plaque by Mrs. Harry Davidson Sheldon to her grandson, Duncan Ferguson, president of Sheldon unit.

The Stafford unit president, Ned Mackey, received the plaque honoring the late Dr. Safford from Mrs. Orin Fletcher Stafford of Eugene.

Dorm for 328 To Be Built On 15th Street

ANOTHER NEW five-unit dormitory, housing 328 students, will be built on the University of Oregon campus within the next two years, with construction scheduled to begin in October, 1956, according to an announcement made recently by University Business Manager J. Orville Lindstrom.

The new dormitory, similar in features and basic layout to the recently completed Earl Hall, will cost \$1,200,000. It will be the south half of a projected larger building, and will front on 15th Street between Emerald and Agate Streets—facing Hayward Field. Most of the 14 tennis courts now in this area will be removed to make room for the new building.

A portion of the proposed structure will be ready for occupancy by Fall Term, 1957, and will be entirely completed by January 1, 1958. Like Earl Hall, each of the five residential units will accommodate 66 students and will have separate dining, living and recreation rooms. The center unit will house a central food service area, connected to each of the other four units through the dining areas. The dormitory will be a Class A, fire-proof structure of reinforced concrete. Ends will be finished in brick similar to Carson and Earl halls. The exterior sides will be finished in steel.

Because the average height of college men has increased two and one-half inches in the last 50 years, the beds in the new dormitory will be built five inches longer than were those in Earl Hall. Two persons will be accommodated in each room. Equipment and furnishings will be similar to Earl Hall with the exception of a larger study desk. Depending on housing needs at the time of completion, the structure will be designed for occupancy by either men only, or both men and women.

Location of a dormitory in this area indicates the University's decision to construct dormitories eastward towards Moss Street from Emerald—men's dormitories being built between 14th and 15th Streets, and women's between 13th and 14th. It also appears likely that still more dormitories and even permanent units for married students will be constructed during the next decade to accommodate the greatly increased student enrollment expected at Oregon by the mid-1960s.

Journalism Assemblies Begin Jan. 5

Four professional leaders of journalism will address University of Oregon School of Journalism students and faculty during Winter term, 1956. Speakers for the new series of Journalism Assemblies were announced recently by Charles T. Duncan, Acting Dean.

The assemblies, scheduled for 11 a.m. on alternate Thursdays in the Allen hall auditorium, are designed to interest all Journalism majors and pre-majors. According to Dean Duncan the assembly program will give students the opportunity to meet and talk with men and women who are shaping the character and charting the direction of contemporary journalism in all its many ramifications.

Speakers will represent the major areas of the broad field of journalism—newspapers, broadcasting and advertising, with the exception of University of Oregon President O. Meredith Wilson, who opens the series on January 5, 1956, with a discussion on journalism for journalism students. Other speakers are—Malcolm Bauer, editorial writer, *The Oregonian*, January 19; Carroll O'Rourke, account executive, Cole & Weber Advertising Agency, Portland, February 2; Bernard Kilgore, president, *The Wall Street Journal*, New York, February 16; and Paul Walden, manager, KODL, The Dalles, and president, Oregon State Broadcasters Association, March 1.

Broadcast Describes Campus of 1894

A description of the University of Oregon campus as it appeared when Oregon played its first football game in March, 1894, was broadcast Sunday, December 18, 1955, on radio station KERG, Eugene. It was the second broadcast of a new radio series, "Portrait of the Past", prepared a year ago by Judge Lawrence Harris, now 82, a member of the Class of 1893, and former editor of the *Eugene Register-Guard* William Tugman.

According to Judge Harris the game took place at what was then the southwest corner of the campus, now occupied for the most part by Commonwealth Hall. The fir trees

which today tower over the campus were about the height of a grown man in that day. Thirteenth Avenue and Kincaid Streets were seldom-used dirt roads, and University of Oregon's small campus of 1894 had a fence around it to keep out cattle.

Judge Harris, one of Eugene's senior citizens, who has spent his entire life in the Willamette Valley, is interviewed by Mr. Tugman on these tape recordings. The tapes, numbering 26 different programs, will be presented to the Oregon Collection of the University of Oregon Library upon completion of their broadcast.

Bodoni Books Begin Hall Collection

The University of Oregon Library has received a gift of imprints and photostats illustrating the work of the 18th century Italian printer Bodoni in honor of the former Director of the University Press, and member of the School of Journalism faculty, Robert C. Hall.

The gift is designated as the Robert C. Hall collection. Its donor is Dr. Robert F. Lane, now in Italy on a Fulbright fellowship making a study of Bodoni. Dr. Lane received both his Bachelor of Science degree (1926) and his Master of Science degree (1931) from the University of Oregon. He received his Ph.D. from the University of Chicago in 1939.

Hall, a Eugene resident, is an associate professor emeritus of journalism, and was active on the staff of the University from 1917 until his retirement in 1948.

The collection includes 26 examples of printing by Bodoni, ranging in dates from 1792 to 1809. It is designed to form the nucleus of a collection for use of students in printing. Giambattista Bodoni is generally considered as the great printer of the

eighteenth century. Bodoni was known as the "King of Printers, Printer of the Kings."

Formal presentation of the Robert C. Hall collection was made at an open meeting of the Association of Patrons and Friends of the University of Oregon Library, December 9, 1955. Professors emeritus W. F. G. Thacher and George Turnbull, also former members of the School of Journalism faculty, participated in the presentation. Dr. Carl W. Hintz, University Librarian, received the Hall collection for the Library.

The Hall collection will be placed in the Library's third floor rare book room, and will be under the supervision of the Special Collections Division. It is the hope of the donor that other useful and rare books, imprints and manuscripts about printing, typography and publishing will be added to the Hall collection by others in future years.

Dr. Hintz, in accepting the Bodoni books, stated that many of the country's leading libraries have increased their collections of useful and valuable rare books by gifts like Dr. Lane's.

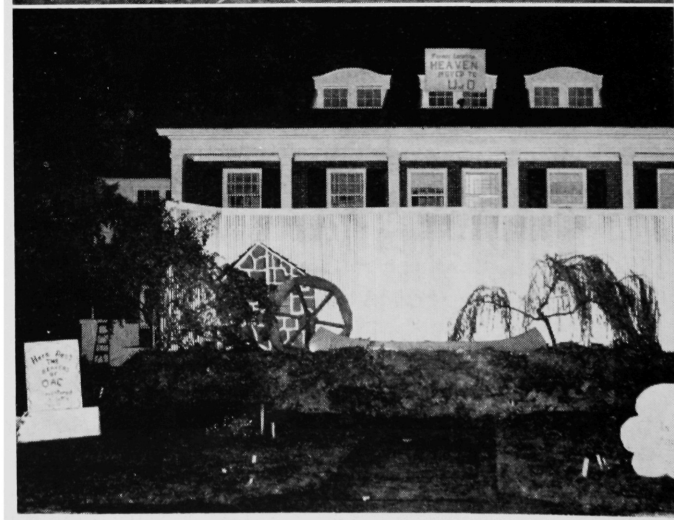

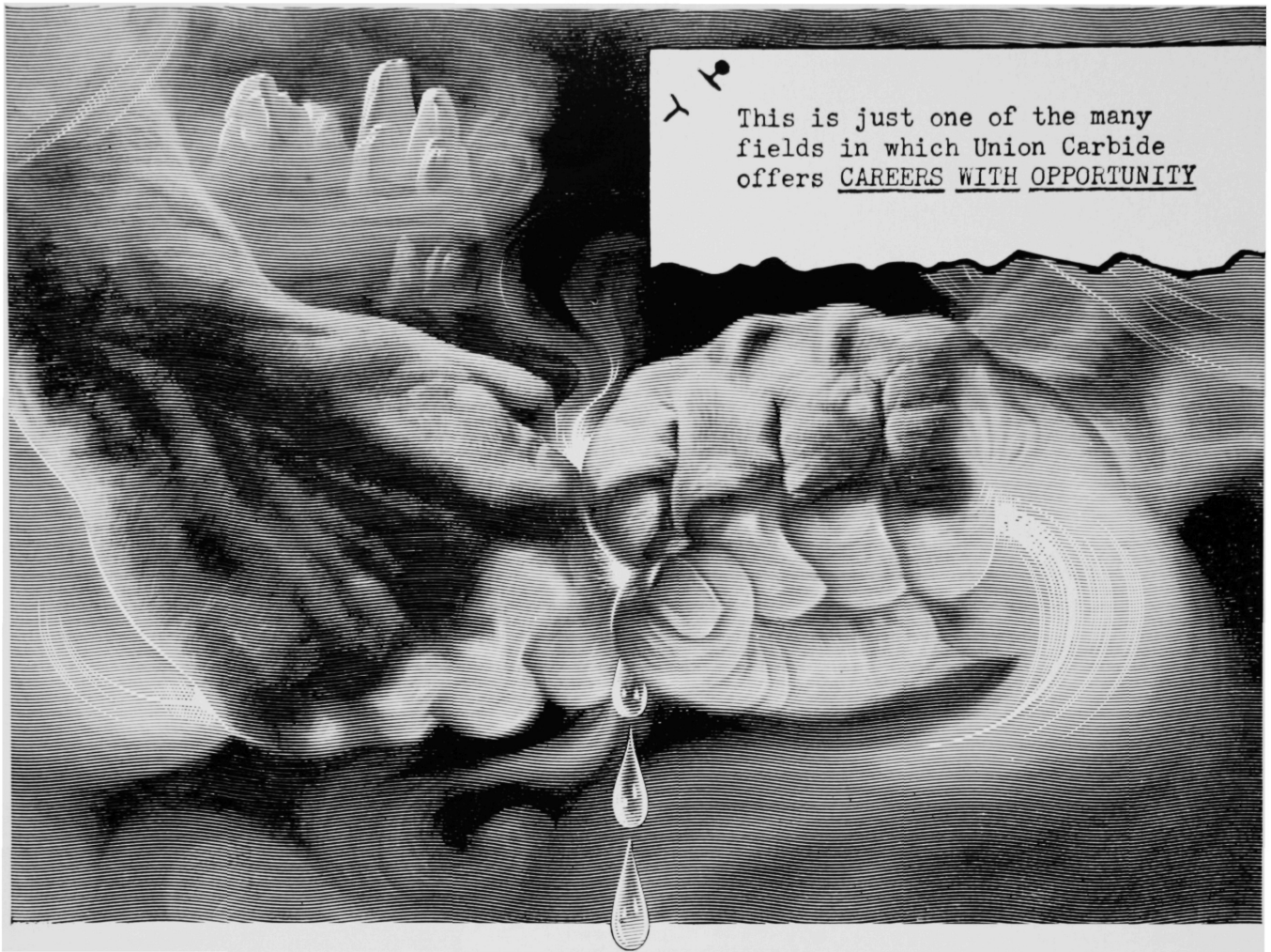

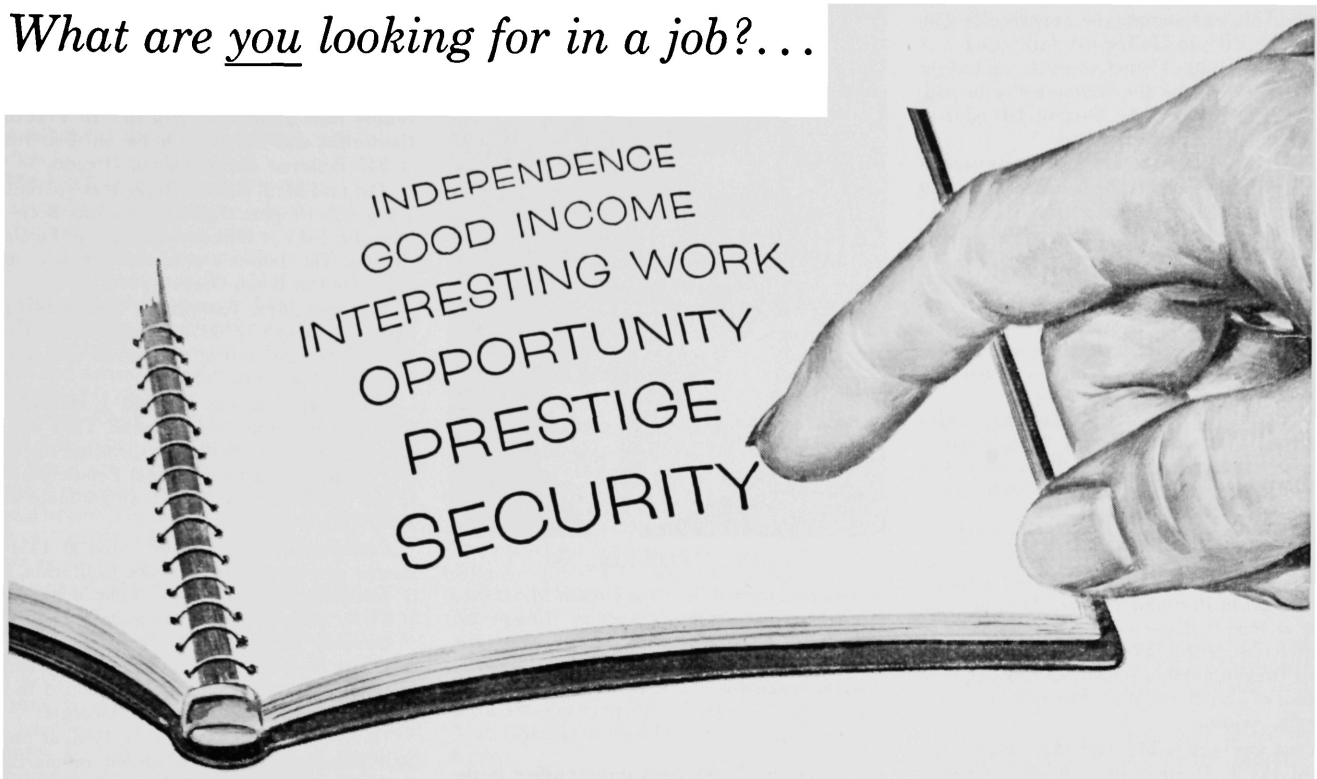

Elizabeth Jones Day '39 died June 1 in Los Angeles, Calif. She received a B.S. degree in journalism from the University and a J.C. degree from Sacramento Jr. college. Mrs. Day had been employed as a secretary. In 1947 she married Ralph C. Day. While on campus Mrs. Day was a member of Alpha Omicron Pi, Theta Sigma Phi, and was very active in working with the *Emerald*.

James B. Gilbertson '50 of Eugene, Oregon, died recently at Sacred Heart hospital. Mr. Gilbertson, furniture representative for the western states, was born in Salem, Oregon, on April 29, 1925, and attended public schools in Salem.

During World War II he served in the United States army. He graduated from the University and was a member of the Sigma Phi Epsilon fraternity. He was employed as a representative for a number of furniture firms.

Miss Hinds grew up in Eugene and her address was 2801 Emerald. She attended the University of Oregon for two years and majored in liberal arts.

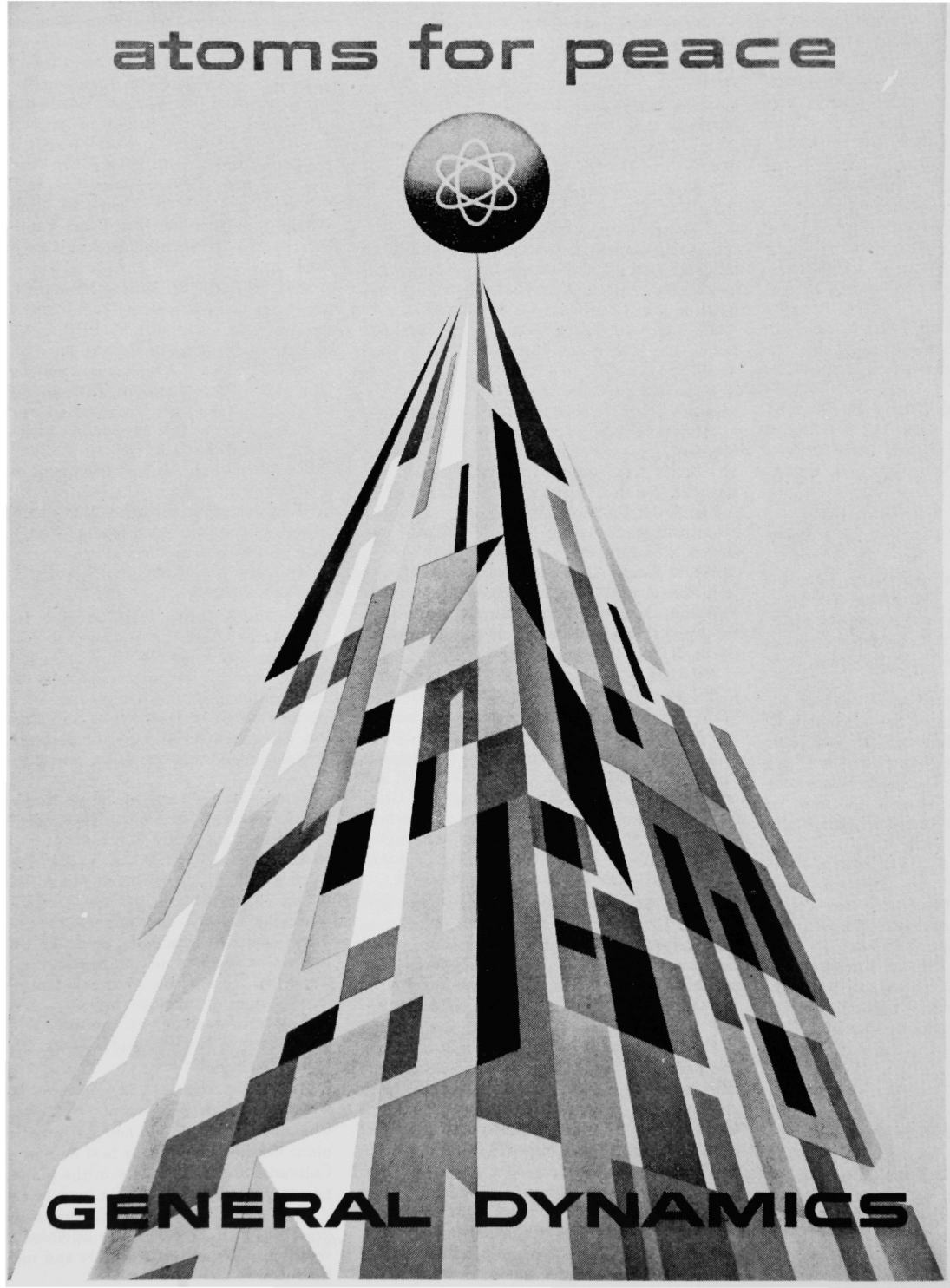
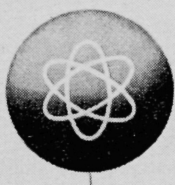

Writes on Fosdick

Dr. Robert D. Clark, Acting Dean of the University of Oregon College of Liberal Arts, has contributed a study on the life and philosophy of Harry Emerson Fosdick, outstanding Protestant minister, to a new book, "A History and Criticism of American Public Address."

Published by Longmans, Green & Co., the volume is one of a series on American public speakers. The new edition contains

studies of 14 of the nation's leading men by researchers who have made special studies.

Fosdick, known to millions throughout the English-speaking world, gained wide recognition for his ability as a speaker during his years at Colgate college and Union Theological seminary in New York City. His real fame came with his appointment to the pulpit of the Park Avenue Baptist church in 1925. His Sunday services drew such large crowds that the Park Avenue congregation built the magnificent 13th century French Gothic styled Riverside church on Morningside Heights, adjacent to Columbia University.

His sermons were broadcast coast to coast for many years through the Sunday NBC radio series, National Vespers, which started in 1927.

Dr. Clark's study of the great preacher includes some interpretation of the struggle between fundamentalism and modernism in religion, a struggle in which Fosdick played a prominent role.

Staples and Bray Co-Author Paper

Dr. Lloyd W. Staples, Professor of Geology in the College of Liberal Arts, has co-authored with Richard A. Bray, a graduate student in geology, a paper appearing in the fall issue of the *Journal of Geological Education*.

Entitled, "A Demonstration Conscope," the article describes a technique for adapting a microscope to show interference phenomena with convergent polarized light. The technique permits a large number of people to view the procedure at one time and is easier to make certain measurements than using a microscope in the standard manner.

Attends Conference

Assistant Professor of Psychology, Dr. John Pierce-Jones is one of the participants in an invitational conference for writers in psychology, psychiatry and philosophy in Santa Barbara, California, December 27-30.

Dr. Pierce-Jones will present a paper on "Some Contributions of Psychology to Understanding Human Needs," at a conference session on December 28, which is sponsored by the Religion in Education Foundation. He will also participate on a panel on research for clarification of relationships of religion to personality formation on December 30.

Keynote address of the four day conference will be on religious trends in psychiatry and psychotherapy by Professor Theodore M. Grene of Yale University.

Turnbull Writes About Crusading Newspaper Editor

Professor emeritus George Turnbull, former dean of the School of Journalism, has written a new book, "An Oregon Crusader," in which the history of one of Oregon's most crusading newspaper editors, George Putnam, now retired editor and publisher of the Salem *Capital Journal*, is told.

Published by Binfords and Mort, Portland, the book describes the battle of this fighting editor who fought hard for principle and the right of the press to defend the rights of the people. The volume covers the high points of Mr. Putnam's half-century editorship of two Oregon daily newspapers—The *Medford Tribune* (now the *Mail Tribune*) from 1907 to 1919, and the Salem *Capital Journal* from 1919 to 1953. Three great editorial battles waged by editor Putnam are described—one for press freedom against official arrogance in southern Oregon, one against the well-nigh successful effort of the Ku Klux Klan to take over control of government in Oregon, and the third against labor leaders who sought to rule the business and industry of the state.

According to Professor Turnbull these difficult editorial positions were undertaken at considerable personal risk to Putnam, but were motivated by his underlying philosophy—"to expose everything that is crooked and to support everything that is sincere and right."

Writer Turnbull became interested in George Putnam's career while writing an earlier book, "History of Oregon Newspapers." For Putnam's performance as a courageous editor impressed him as that of a man who had fought the good fight because of his recognition of the obligations of a newspaper to its readers and the people of its community and state.

Oswald West, Governor of Oregon from 1911 to 1915, and lifelong friend of Mr. Putnam, has written a foreword for Mr. Turnbull's new book.

Professor Turnbull served the University of Oregon for 31 years as a member of the School of Journalism faculty, retiring as dean of school in 1948. Following retirement he taught at Stanford University Institute for Journalistic Studies, and one year in the School of Journalism at the University of Nebraska. He spent a year of copy editing and editorial writing on *The Oregonian*, and in 1951 became associate editor of the *Albany Democrat-Herald*.

In October of this year he resigned from his position with the *Democrat-Herald* to return to the University of Oregon School of Journalism, where he is now engaged in research and writing.

Writes on Balzac

A book by Dr. Maurice Lecuyer, new assistant professor of romance languages, will be published next year in France. The book, "Balzac et Rabelais," is a study of Honore de Balzac, a famed 19th century French novelist. Lecuyer discusses the influence of Rabelais, French wit and satirist, on the novelist and his works.

Lecuyer, born in France, was educated at the University of Paris. He received his doctorate at Yale University.

Conducts Symphony

George Boughton, associate professor of music, is conductor of the Eugene-Springfield Symphony Orchestra. At Oregon since 1945, Boughton has concentrated largely on chamber music and violin. The Eugene-Springfield Symphony season opened November 10, with three additional concerts scheduled for January 10, April 5 and May 3.

Breen Authors Study

Dr. Quirinus Breen, professor of history, is the author of an article entitled, "Marius Nizolius: Ciceronian Lexicographer and Philosopher," which appeared in the September issue of a German journal. This article is part of the introduction to Dr. Breen's forthcoming book on Nizolius to be published soon in Rome.

Alumni Tours

University of Oregon Alumni Secretary Bass Dyer recently outlined plans for alumni tours during the six months period from January through June, 1956. Teams making alumni tours consist of selected faculty and staff members of the University, along with University of Oregon Alumni Association officers and leaders.

Cities to be visited by alumni tour teams will include Los Angeles, San Francisco, San Diego, Grants Pass, Medford, Bend, Prineville, Coos Bay, Albany, Salem, Longview-Kelso, and Seattle.

Bank Minutes Given

H. L. Edmunds, of Eugene, and ex-president of the Eugene Loan and Savings Bank, has given a board of directors' minutes book, representing banking history in Eugene from 1887 to 1913, to the University of Oregon Library.

The first record in the book describes the establishment of the Bank of Oregon in September, 1887. Later, in 1889, it became a National Bank, then the Eugene Loan and Savings Bank, and finally, in 1892, was absorbed by the U. S. National Bank.

In addition to giving a graphic history of the area's financial progress, the book describes the ways of Eugene and Oregon residents of that day.

At one point the minutes describe a would-be banker's approach to secure a position with the bank in which he asked for "a situation in the Eugene National Bank for the purpose of learning banking, without compensation." The offer was declined.

Research Grant

The National Science Foundation has awarded a \$7,000 research grant to Associate Professor Walter T. Martin and Research Fellow Jack P. Gibbs, both members of the sociology department of the College of Liberal Arts, for a 15-month study to commence in June, 1956.

The study, entitled, "A Unifying Empirical Principle in the Analysis of Variations in Selected Mortality Rates," will deal primarily with suicide and homicide data for New Zealand, American cities and other selected areas. Original data and findings of earlier studies, will be integrated within a single theoretical framework in order to provide a basis for predicting suicide and homicide rates for given categories of people.

in Washington, D. C., for duty with the Legislative and Liaison Division, and in April, 1946 was appointed assistant military air attache in London, England.

By January, 1947 he returned to Washington to the War Department General Staff for duty in the Plans and Operations Division, later to become chief of its Advanced Study Group. In December, 1949 General Zimmerman was appointed chairman of the Joint Advanced Study Center in the Office of the Joint Chiefs of Staff.

Transferred to Tokyo, Japan, in August, 1950, he was named Director of Plans in the Office of the Deputy for Operations, Far East Air Forces (FEAF), during the height of the Korean Campaign. Two years later he became Deputy for Intelligence, FEAF.

In August, 1954 General Zimmerman was ordered back to the United States and designated Dean of Faculty at the United States Air Force Academy, Lowry Air Force Base, Denver, which officially opened July 11, 1955.

Starting with an initial class of cadets numbering 306, a faculty of 100, and a staff of 500, General Zimmerman is in full charge of the academic program of USAFA. According to the Republic Aviation News, a publication of the Republic Aviation Corporation, all academic courses will be functional in nature—"that is, related to aircraft equipment and aviation problems... chemistry courses will be related to rockets, fuels, gas turbines, turbojet engines and nuclear weapons... The social studies and humanities are designed to give the cadet a knowledge of the world about him and skill in dealing with the people who inhabit that world... (in) the second semester... the course in 20th century world history will be devoted to study of... the great issue of the day... in their junior year the cadets will study comparative governments and in their senior year, international relations."

This is the scope of General Zimmerman's responsibility. By 1957 the permanent facilities of the U. S. Air Force Academy will be completed at Colorado Springs, Colorado, covering an area of 17,500 square miles. Ultimately the Corps of Cadets which General Zimmerman will educate will build up to a full strength of 2,496, sharing with West Point and Annapolis the responsibility for developing American military leaders of the future.

General Zimmerman's decorations include the Distinguished Service Medal, and the Legion of Merit with three Oak Leaf Clusters. He is rated a command pilot, combat observer, and aircraft observer. General and Mrs. Zimmerman are the parents of one daughter and two sons.

A member of Oregon's famous Class of '23, General Zimmerman is well known by alumni from coast to coast. He was among the returning alumni for Homecoming 1955.

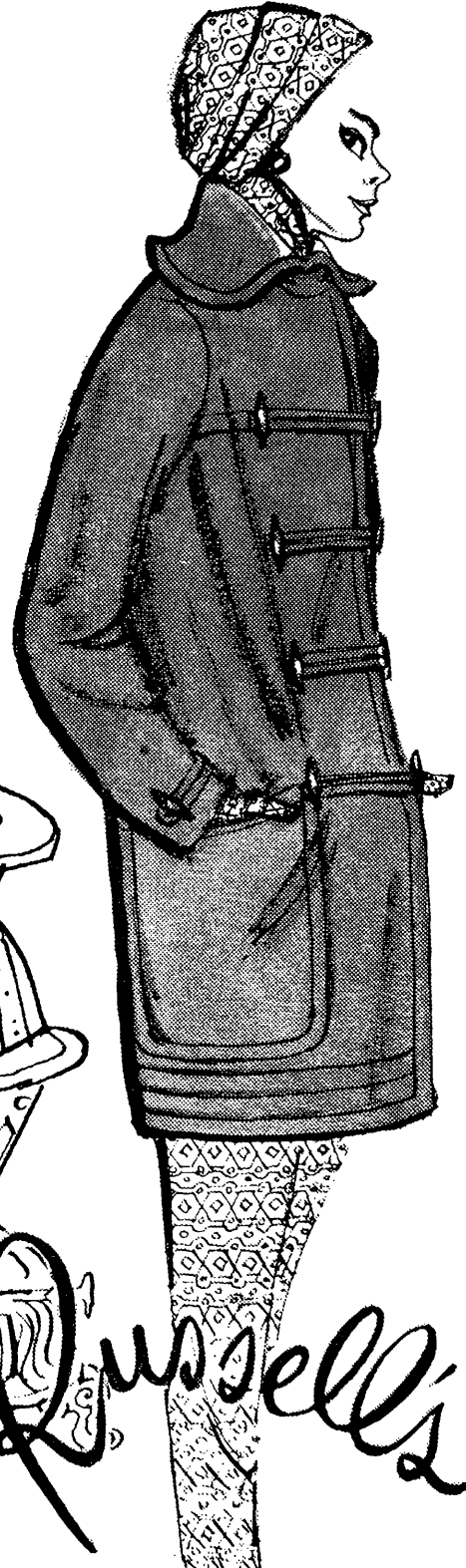
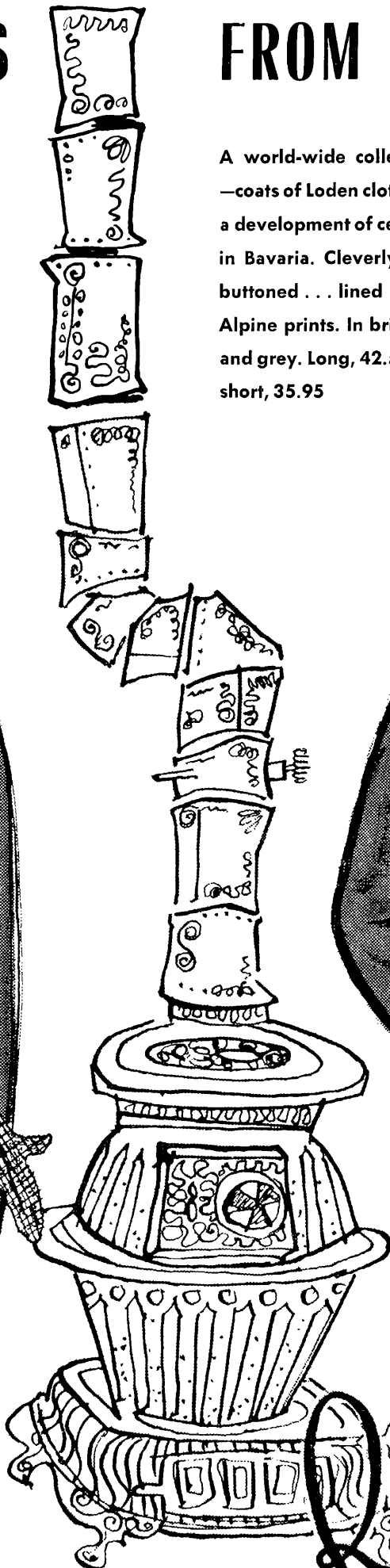
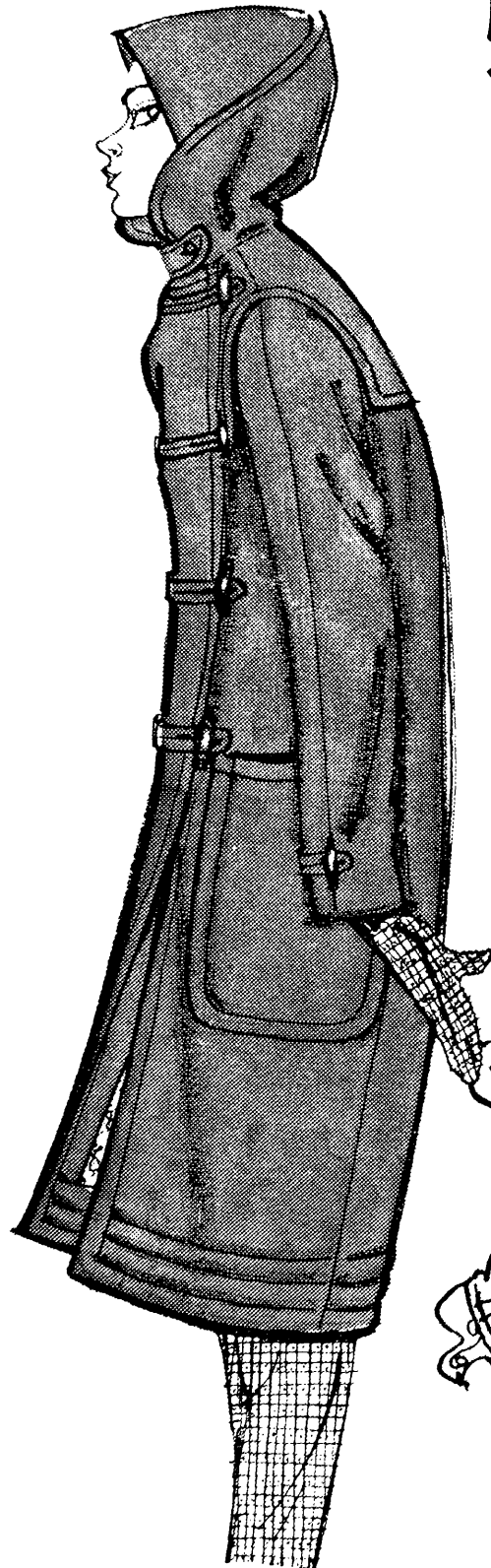
