

**RECORD OF PLAN CONFORMANCE AND

A. Background

Description of Proposed Action:

Burlington-Northern Railway wants to replace the existing building on the communication site with a new prefabricated concrete structure. The new construction will be within the footprint of the Burlington Right-of-way grant – ORE 15790. See attached map and pictures.

Purpose and Need for the Project:

Burlington-Northern found leaks in the building that houses the radio equipment for Burlington-Northern Railway. Due to the age and structure of the existing building, it is not feasible to repair. Burlington-Northern wishes to replace it with a new prefab, concrete structure that will tolerate the severe winter snow storms that occur on Hamaker Mountain.

Remarks:

1. During construction of the new building, any archeological findings will be reported immediately and all construction will stop until site can be properly examined by BLM archeologist.
2. All trucks and equipment used during construction will be washed before entering construction areas, and will comply with BLM weed prevention standards.
3. Operator shall comply with Oregon Department of Forestry Fire Restrictions. No welding equipment will be used without waiver from ODF Fire. BNSF must have proper fire fighting equipment on site during construction.

E. Decision

I considered design features and standard operating procedures (above and in Appendix A). The proposed action is consistent with the specific requirements of the published CX and in conformance with the Klamath Falls Resource Area Record of Decision and Resource Management Plan and Rangeland Program Summary.

The proposed action would not create adverse environmental impacts or require the preparation of an environmental assessment (EA) or environmental impact statement (EIS). The proposed action has been reviewed against the criteria for extraordinary circumstances (listed above) as identified in 516 DM 2, Appendix 2. The application of this categorical exclusion is appropriate, as there are no extraordinary circumstances potentially having effects that may significantly affect the environment. The proposed action is, therefore, categorically excluded from additional NEPA documentation.

It is my decision to proceed with the Proposed Action.

Figure 1 – Location Map

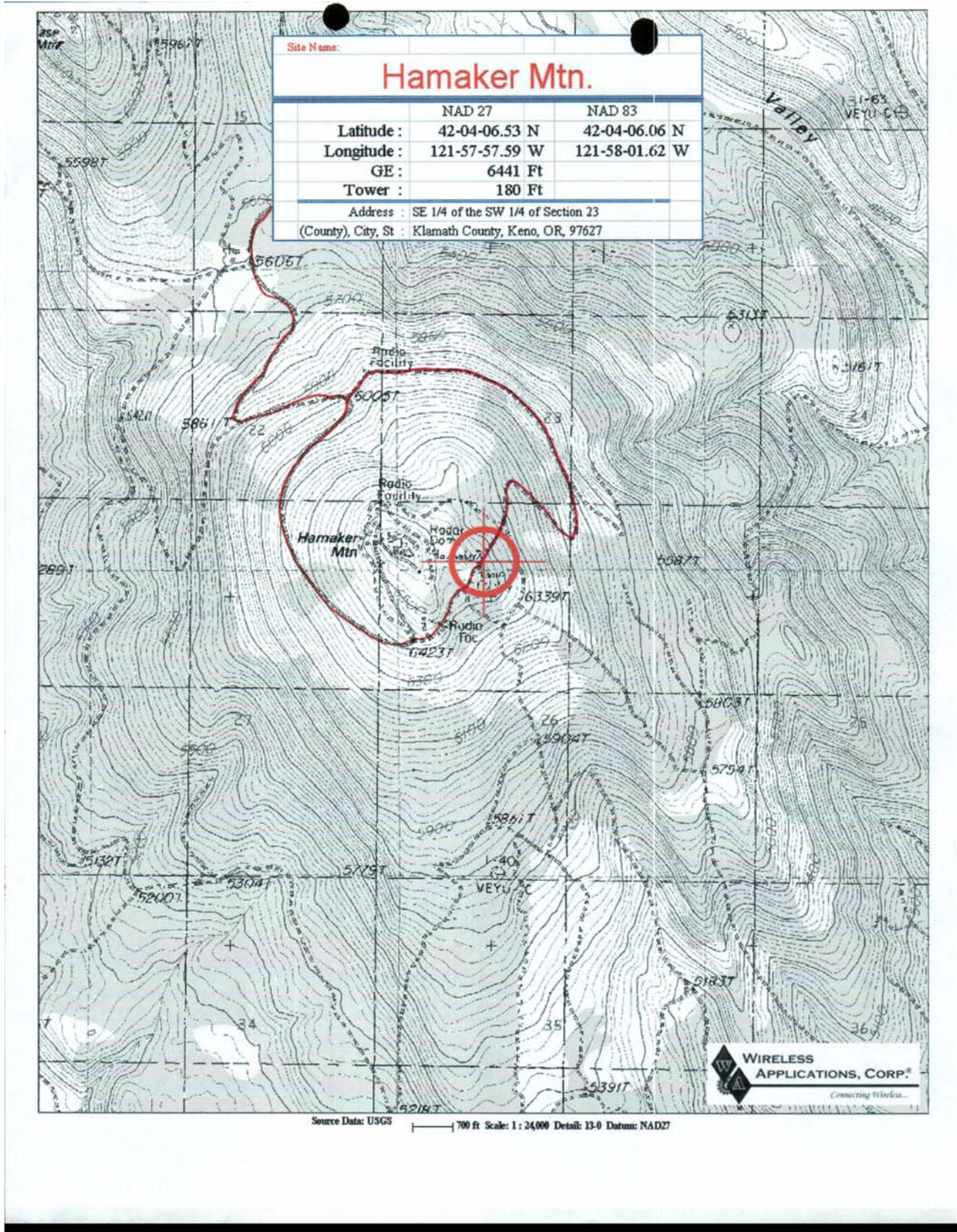
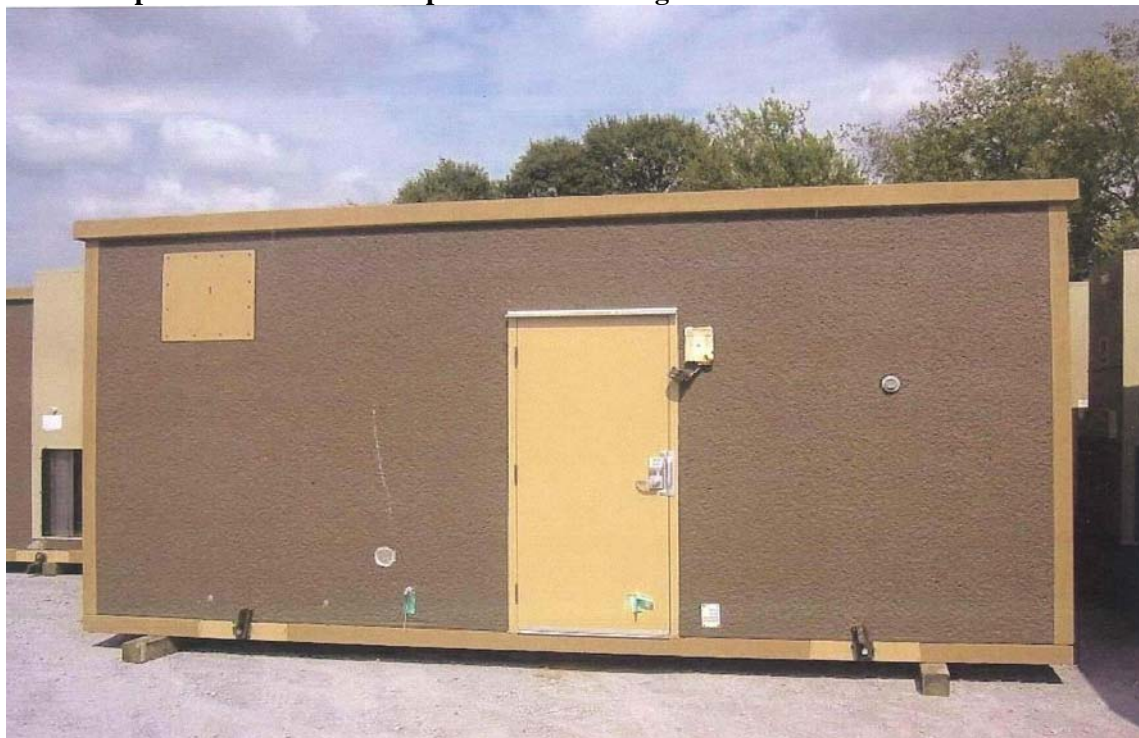


Figure 2 – Existing Building

Appendix A – Weed Mitigation Measures

All vehicles and equipment will be cleaned off prior to operating on BLM lands. Removal of all dirt, grease, and plant parts that may carry noxious weed seeds or vegetative parts is required and may be accomplished with a pressure hose.

High concentrations of noxious weeds in the immediate area of mechanical operations shall be mowed to ground level prior to the start of project activities.

All equipment and vehicles operating off of main roads shall be cleaned off prior to leaving the job site when the job site includes noxious weed populations. Removal of all dirt, grease, and plant parts that may carry noxious weed seeds or vegetative parts is required and may be accomplished with a pressure hose.
