Qualitative Report for the Association of Research Libraries¹

Introduction, Mission, Vision

The University of Oregon, founded in 1876, is a leading public research university and a member of the Association of American Universities. The research enterprise at the UO spans the arts, the humanities, the sciences, and the professions and addresses the full cycle of innovation, from basic discoveries to technology transfer and societal application. There are over sixty interdisciplinary research institutes and centers. The teaching mission is very much grounded in the liberal arts with an increasing emphasis on undergraduate research. Current enrollment is 21,500, including approximately 4,000 graduate students.

The UO Libraries' mission is to "enrich the student learning experience, encourage exploration and research at all levels, and contribute to advancements in access to scholarly resources." Our current strategic objectives emphasize collaborative endeavors; flexible physical environments to enhance learning and research; timely and convenient access to information resources; and transparent, easy-to-use systems and services—with the ultimate goal of maximizing the use of our resources.

Services and Facilities

The UO Libraries is relatively centralized, compared to many research library systems. Knight Library is the main facility and serves the humanities and social sciences. It was constructed as a Works Progress Administration project in 1936, and it has been expanded and renovated several times. Campus branch libraries include the John E. Jaqua Law Library, the Architecture and Allied Arts Library, and the Science/Mathematics Library. There are two off-campus libraries: the Loyd & Dorothy Rippey Library at the Oregon Institute of Marine Biology and the Portland Library and Learning Commons. All of the library facilities have been either renovated or newly constructed in the last seventeen years. Each week during the academic year, there are nearly 8,000 visits to the UO libraries—an indication that the physical library is still very central to campus life. Last year, the students voted to use their own resources to keep the Knight Library open 24x5 during the academic term. This action is further evidence of the importance of the library as the intellectual center of the university.

The UO Libraries is perhaps more service based than collection based. A high demand for scholarly resources has been addressed through robust and successful resource sharing programs, for example, the Orbis Cascade Alliance shared catalog, RAPID, and ArticleReach. The UO has consistently ranked among the top ten ARL libraries in terms of interlibrary lending and borrowing. Efficient ILL, liberal lending policies, and convenient campus document delivery programs have reduced many barriers to access. The UO Libraries also

places a heavy emphasis on instruction. Nearly half the student population participates in some library literacy class or program during the year. Information literacy skills are a key component in the university's freshman programs. Subject specialists teach credit courses (within the library's curriculum and occasionally in the schools and colleges). Over the past few years, a significant increase in demand for instruction using primary source materials has resulted in the construction of a new, state-of-the-art classroom within Special Collections and University Archives.

Collections and Scholarly Communications

This year, the library's collection is expected to reach three million volumes. Like most research libraries, the UO has engaged in a rapid and comprehensive shift to e-resources. Over 90% of our journal collection is now online, and the library has acquired many core collections such as *Eighteenth Century Collections Online*, *Early English Books Online*, *ARTstor*, *Web of Science* (1865-), and the *Historical New York Times*. The UO's collection has many areas of prominence, including East Asian vernacular materials; aerial photographs (one of the largest depositories in the United States); twentieth-century political, economic, and labor history; medieval studies; art and architectural history; environmental sciences; and music.

Special Collections and University Archives is especially strong in several collecting areas: Oregon history and politics, Oregon pioneer collections, labor and environmental history, intentional communities, Northwest literature, photographs of the Northwest, missionaries to East Asia, and authors and illustrators of children's books. Significant additions have been made recently to the Ursula Le Guin Papers, the James Ivory Papers, the Ken Kesey Papers, and the collections of Northwest photographers Dan Powell, Grayson Mathews, and Allen deLay. Among new acquisitions are the papers of Tee Corinne, writer, artist, and lesbian activist; records of the Hoedads, a Northwest forest-worker cooperative; and, en route, the papers of Ismail Merchant, of Merchant-Ivory Productions.

The creation of digital resources and images has focused on enhancing access to unique collections to support teaching and research. There are twenty-two distinct collections including historical photographs, historical state maps, local and regional documents, the Historic Sheet Music Collection, and Building Oregon: Architecture of Oregon and the Pacific Northwest. Scholars' Bank, the university's institutional repository, currently houses some 7,500 items and provides a digital home for several journals, deposited theses and dissertations, and faculty and student research.

Under the leadership of the director of scholarly communications, the UO Libraries has made significant strides in raising faculty awareness regarding the changing economics of scholarly communication, author's rights, and open access. The University Senate has passed two resolutions related to author's rights, and the library has recently set aside funds to assist faculty who wish to publish in open access peer-reviewed journals.

Educational Technology and Media

In addition to the traditional library services, the UO Libraries provides support for campus classroom technology, video production services, broadcasting and teleconferencing capabilities, and streaming media as well as management and support for the campus Blackboard™ course management system. These services are integrated into our larger instructional and outreach roles. The library's facilities include two broadcast studios, single-camera and multi-camera field production units, a computerized video editing suite, digital video effects, complete audio mixing and processing, sophisticated computer graphic arts, and a video duplication facility. For the past decade, the library's Center for Educational Technologies and Media Services unit have worked collaboratively with the Teaching Effectiveness Program to provide instruction and consultation for faculty who wish to incorporate technology and media into their teaching. This consultation ranges from helping faculty use the more advanced features of the course management system to advising faculty on web and multimedia design and development for specific courses.

Collaborations and Grants

The University of Oregon was the founding partner of Orbis, now the Orbis Cascade Alliance. The Alliance is a highly successful consortium serving thirty-five institutions in the Pacific Northwest. Its services include a unified discovery and delivery system, group licenses for digital content, and hosting services for the Northwest Digital Archives. The UO continues to serve as the fiscal agent for the Alliance. The UO Libraries is also a member of the Greater Western Library Alliance, which focuses on expedited resource sharing and creation of collaborative web portals, for example, the Western Waters Digital Library. Additional memberships include the Center for Research Libraries, Scholarly Publishing and Academic Resources Coalition, Coalition for Networked Information, Council on Library and Information Resources, and Pacific Rim Digital Library Alliance.

Grant activity over the last several years has largely focused on building digital collections in collaboration with on- and off-campus entities. The "Percent for Art Digital Collection and Database," funded by the Institute of Museum and Library Services/Library Services and Technology Act (IMLS/LSTA), provides a permanent archive and enhanced public access to documentation of the Oregon Art Commission's Percent for Art public program. Other IMLS/LSTA—funded projects include the "Local and Regional Documents Archive"; planning for a collaborative statewide collection management program for Oregon historical and special collections; and the first phase of the Oregon Digital Newspapers Project. The UO Libraries also partnered with the UO Art History and Geography Departments on a National Endowment for the Humanities—funded project documenting the archaeology and landscape of the Altai Mountains of Mongolia. In the last three years the UO Libraries has received \$453,255 in grant funding.

Planning and Assessment

Since 2000, the library has engaged in a strategic planning process that has resulted in several service enhancements, including the creation of the Learning Commons at Knight Library, improved web pages for faculty, free borrowing privileges for all Oregon residents, a program to advance scholarly communications, the creation of the UO Channel (streaming video of campus lectures and events), enhancement of videoconferencing, an on-campus document delivery service, and implementation of federated searching. Recently, the library has adopted a portfolio management system to assist in evaluating project proposals (scoring them against a set of strategic directions) and managing projects and resources.

The library has participated in two LibQual surveys (in 2001 and 2005). In most cases users of the UO Libraries reported higher satisfaction levels than the mean of the ARL survey cohort. This was particularly true for the "Library as Place" dimension. Following the lead of ARL on the correlation between a healthy internal organizational climate and excellent customer service, the UO Libraries conducted a diversity and organizational climate survey in 2006. This was followed by a series of internal focus group discussions and then a number of changes, including enhanced internal communication and an active training and organizational development team.

Horizon Issues


The focus for the near term will be on new services aligned with emerging programs on campus, particularly integrative science and a collaboration among three colleges and the library to offer a cinema studies major. A newly endowed position for data services will be working with researchers and peer institutions on assessing our needs related to the curation and preservation of data. The library is also engaged in planning discussions for an expanded visualization and teaching laboratory, which will be part of a new research center on campus. Planning for a Regional Library Services Center (RLSC) continues, in collaboration with the Orbis Cascade Alliance. The RLSC would incorporate advances in commercial warehouse technologies and the latest standards in environmental conditions to ensure the long-term preservation of books and film, and to provide opportunities to repurpose precious space on our respective campuses to meet emerging needs related to teaching, learning, and collaborative research. The UO Libraries will be even more engaged in collaborations with our sister institution, Oregon State University, and the Orbis Cascade Alliance as we redefine ourselves more as a multi-institutional entity, as opposed to a standalone service provider to one university (as recommended in the Council on Library and Information Resources report, No Brief Candle).²



Reference and Instruction

Total reference queries are down, which follows the ARL trend. However, the decline has not been as steep at the UO.



At the UO, the number of participants (students) in library instruction sessions held steady over the last year, reversing the declining trend.



Support for Distance Education


Course Delivery

The Media Services Instructional Television (Educational Video Group) continues to support UO distance education efforts by producing telecourses. A total of thirty-two courses were supported with 441 individual teleclasses produced. Disciplines supported include Human Physiology, Anatomy, Psychology, Education Leadership, Architecture, History, American English Institute, and Communication Disorders and Science.

Information Resources Expenditures

The materials budgets of the UO Libraries (Knight Library, branch libraries, and John E. Jaqua Law Library) have remained flat for much of the last ten years, although we did receive non-recurring funds in FY 2008 to help with inflation. Overall inflation on information content—print and electronic—averages 5% to 6% per year.






Circulation and Collection Use

UO and ARL Trends

The median ARL initial circulation³ decreased by 32% in the past decade. FY 2006-07 saw a 12% decline from the year before. Oregon dropped by 11% in the same time period.





³ The ARL definition of initial circulation excludes interlibrary loan borrowing and lending (and therefore Summit) as well as in-house checkouts such as items being sent for repairs. It excludes reserves, renewals, and any technical services processes. Prior to FY 2005, the UO data reported to ARL included all of these categories of lending, with the results appearing that UO circulation was higher than the ARL median. It also appears that the UO suffered a larger drop in circulation than actually occurred.

Comparison with Peers

After normalizing for student FTE, UO is slightly below the median for our peer group for the number of initial circulations per FTE.

Patrons

While total checkouts are down, more patrons are borrowing materials. The chart below shows the percentage of patrons, broken down by class level, who checked out an item, returned an item, or placed a hold on an item in the timeframe shown. Almost 60% of

freshmen had borrowing activity in the past year; 87% of seniors and 91% of graduate students had some sort of checkout or hold this past year. These numbers are increasing yearly. Perhaps the variety of resources (laptops, video cameras, room keys, and other non-traditional collections) now being circulated in the library accounts for these increases.

Electronic Reserves

Electronic reserves are course materials placed on the web so students can use them at any time. Access to these materials is restricted to students in the courses.


The number of items on electronic reserve has declined significantly. In FY 2007-08 there were 32% fewer e-reserve courses and 23% fewer files. E-reserve files were accessed 85,424 times. This reduction is due in part to the ease with which faculty can link to digital content themselves through Blackboard.

Resource Sharing

UO and ARL Trends

Interlibrary borrowing and lending includes the Interlibrary Loan Service and the Summit catalog-based service of the Orbis Cascade Alliance. At the UO, borrowing slightly decreased; lending increased by 6%. Resource sharing is a signature service of the UO Libraries—one of our biggest success stories. It is a highly efficient service that our faculty and students use heavily, increasing the amount of materials available for their research tenfold. This is paired with a reciprocal lending service that balances the relationship with our partners and adds to the research capacity of our state and region. As with most research libraries, we are a net lender.

Although the resource sharing numbers demonstrate a quality, highly valued service, there is a troubling aspect to this story. We rank 7th out of 113 ARL libraries in what we borrow from other institutions, and we rank 106th in our expenditures on journals and databases. This demonstrates a significant gap between the demand for content and what we are able to purchase.



Comparison with Selected Peers


When looking at our defined peer group, the UO has the smallest enrollment but is significantly higher than the median for both borrowing and lending. Our borrowing and lending numbers actually look much like the University of Washington's numbers, but our enrollment is less than half. After normalizing for student FTE, the UO borrows and lends more than double the median of our peer group.


Library Expenditures

UO Libraries total expenditures are up 6.8% in FY 2007-08. The greatest growth was for access to information content, a reflection of the shift away from print ownership. Mandated and negotiated salary, wage, and benefits increases continue to fuel increases in staff costs. However, staffing costs remain at 56% of the total while information content expenditures (print and electronic) are up slightly, from 34% to 35% of the libraries' total.


In terms of overall expenditure, in FY 2007-08 UO's position relative to ARL peers held steady after a sharp decline in FY 2004-05. (Note: ARL-reported expenditures exclude OPE.)



Our major areas of expenditure are similar to those of other ARL libraries. (Note: ARL-reported expenditures exclude OPE.) However, the UO distribution reflects the pattern of increases to salaries and wages being funded, while collections have not received inflationary increases. Over time this creates divergence from our peers.

Facilities

Portland Library and Learning Commons

The Portland Library and Learning Commons is the central community space for the UO Portland program. Located in the beautifully renovated White Stag Block in the historic Old Town neighborhood, the facility was ready for occupancy for Spring Term 2008 with a soft opening (only a few courses were offered). Expansion of the staffing, collections, and services continues.

Safety

The Knight Safety Staff continued to conduct patrols of the Knight Library. These students walked around the building and discussed safety with library users when they found personal belongings left unsupervised. This program ran for its second year in FY 2007-08 and continued to have an impact on the number of reported thefts. In FY 2005-06, there were eighteen theft reports; in FY 2006-07, there were seven; and in FY 2007-08, there were nine. The staff kept track of the conversations they had with building users and the number of warnings (small slips of paper) left.

Study Rooms

There were 12,230 key checkouts for twelve locked study rooms in the Knight Library. These rooms were booked a total of 5,120 times by 1,876 patrons.


Building Use Observational Study

During winter term 2008, staff in the Knight Library undertook a use survey of the public rooms in the Knight Library. Safety Staff from the Circulation/Reserves work unit recorded the number of users in each room during most hours of inspection from the middle of week three to the end of finals week. This resulted in 279 recorded usage counts.⁴




Highlights

- The ITC classroom was in use 97% of the time. This space is an unlocked "classroom," so when classes are not in session, it is heavily used. Opening the Edmiston Classroom when not scheduled for classes (as proposed by the Learning Commons group) would likely result in higher use of Edmiston as well.
- Unlocked study rooms were in use 85% of the time. These rooms are not part of the reservation system and are first come, first serve. Clearly they are very popular, but note that the overall number of users in the unlocked rooms (4,119) is lower than in the locked rooms (6,101). This is perhaps due to the fact that the locked rooms are bookable and groups can depend on a meeting time and space. While a total of 4,119 users were counted in the unlocked rooms, in 36.5% of the inspections only one person was in the room.
- Locked study rooms were also heavily used, with 6,101 patrons counted. These rooms are self-bookable via the online catalog and were booked 3,758 times during winter term. The keys were checked out 3,905 times. In 17% of the inspections, only one person was in the room. The locks and reservation system have been in place since fall 2006.
- The Collaboration Center was in use 81% of the time, while the Presentation Practice Room was in use 42% of the time.
- Faculty studies were in use only 5% of the time. Nineteen faculty studies were never in use during this survey period.

Locally Developed Digital Collections

The UO Libraries reports annually on its locally developed digital collections in the ARL supplementary statistics, under "Library Digitization Activities." These collections contain materials born digital, materials converted from different formats, and locally held digital materials that are not purchased. The collections are stored on a number of different servers and platforms, which creates a challenge for gathering comprehensive and comparable statistics.

At the close of FY 2007-08, the UO Libraries had twenty-two locally developed digital collections, up from sixteen the year before.





FY 2007-08 saw the addition of seven new collections: Building Oregon, Dissociation and Trauma Archives, Historic Sheet Music, Japanese American Student Relocation, the Tanberg Content Server, University Archives & Electronic Records (hosted in Scholars' Bank), and UO Stock Photos. A pilot collection in Natural History, included in the count for FY 2006-07, is no longer live.


The other collections at UO are Digital Audio Reserves, Doris Ulmann Photographs, e-Asia, Historical Photographs, Manuscripts, the Master Video Repository for Educational Television, Percent for Art, Picturing the Cayuse, Leadership and Legacy: Athletics and the University of Oregon, Scholars' Bank (including local government documents), the Streaming Media Repository, UO Office of the President, the Visual Resources Collection, and the Western Waters Digital Library.

Growth of Digital Collections

Total collection size (as measured in gigabytes) grew by nearly 17% in FY 2007-08. This is a more moderate increase than was seen the prior year, when size increased sevenfold. The number of items (unique files) more than doubled during FY 2007-08.



Use of Digital Collections

Number of Times Items Accessed

The number of times digital items were accessed in FY 2007-08 increased by 29% over the previous year. While still an upward trend, this is not as dramatic a rise as the doubling that occurred in FY 2006-07. It should be noted that the figures below include only Scholars' Bank (including local government documents and University Archives & Electronic Records), e-Asia, the Streaming Media Repository, Digital Audio Reserves, the Master Video Repository for Educational Television, and the Tanberg Content Server. Data is unavailable for the Visual Resources Collection and thirteen other collections.

Number of Queries Conducted





Scholars' Bank


Use of Scholars' Bank (UO's open access repository), when measured as the number of times items were accessed, increased by 33% in FY 2007-08. However, the number of queries was down by nearly 29% in FY 2007-08.






e-Asia Collection

For the e-Asia collection, both size and use continued their upward trajectories in FY 2007-08. The size of the collection (in gigabytes) increased by over a third (35%); the number of items grew by 15%. Collection use, measured as the number of times items were accessed, grew by 23%, which is considerably less than the prior year's increase of nearly 80%.


Virtual Visits

Web Visitors

ARL supplementary statistics request the following data: "Virtual visits include a user's request of the library web site or catalog from outside the library building, excluding the number of pages or gratuitous elements (images, style sheets) viewed. Exclude, if possible, virtual visits from within the library, from robot or spider crawls and from page reloads." ⁵

The chart below shows the relationship between pages viewed (17,067,745), unique visitors⁶ (113,879 in the highest month), and total visits⁷ (4,592,453) in FY 2007-08. The number of pages viewed is 73% higher than two years before and total visits are up by 60%.



Initiatives and Projects

ArticleReach

Team members: Margaret Bean, Sara Brownmiller, Shirien Chappell (lead), Mary Grenci

Charge: (1) Full implementation of ArticleReach, i.e., summary holdings completed; and (2) Cost/benefit analysis of ArticleReach and RAPID document delivery services.

Holdings

Between January and November 2007, the library increased its summary holdings data in ArticleReach by 224% by creating new summary holdings records and cleaning data in some bibliographic records to allow contribution to ArticleReach. With these additional summary holdings, the library increased its ability to fill lending requests by 184%. The summary holdings information now in the library catalog also enhances our participation in RAPID and enables our patrons to more easily identify the library's holdings for a specific journal.

Cost/Benefit Analysis of ArticleReach and RAPID

We recommend continuing both ArticleReach and RAPID.

Analysis:

ArticleReach: While the vendor cost per request is greater for ArticleReach than for RAPID, ArticleReach offers real savings in staff time for the requests it fills.

RAPID: Even though the labor cost per request for RAPID is greater than for ArticleReach, we recommend continuing with RAPID since RAPID fills the requests that ArticleReach cannot. Without RAPID, the unfilled requests from ArticleReach would go to OCLC, and mediated OCLC requests cost substantially more than either RAPID or ArticleReach.

^{*} The cost of paging print journals or finding electronic articles, scanning, sending, reshelving, etc. is the same for ArticleReach and RAPID. RAPID requires one extra step (updating RAPID).

If membership increases in the ArticleReach consortium, so that ArticleReach meets 90+% of our requests for articles, we should revisit our decision to continue with RAPID. Meeting 90% of our article requests through ArticleReach would make the per-request cost decrease for ArticleReach and increase for RAPID.

Blackboard Upgrade

Team members: JQ Johnson (lead), Tim Boshart, Information Services staff

Charge: Implement upgrade to Blackboard system. Coordinate with Information Services on equipment replacement.

Summary

Beginning spring of 2007, UO Libraries and UO Information Services collaborated on planning upgrades to the database component of the UO Blackboard system. Information Services developed a plan that replaced the aging stand-alone "ebony" database server with a dual redundant server and redundant data storage on a storage area network (SAN). The UO Ed Tech Committee approved a proposal and in May 2007 forwarded it to Provost Brady. The proposal was funded with a total cost of \$151,000. Implementation began during summer of 2007 and was originally scheduled for completion during winter break 2007. Due to hardware delivery problems, implementation was deferred until February 9, 2008. The upgrade was completed smoothly on the revised schedule.

After the successful upgrade of the database component, we identified the application servers as the next major hardware component that needed replacement. Two new servers were acquired in spring of 2008 and placed in production on August 16, 2008.

In parallel with the hardware upgrades, the Blackboard system was upgraded to Blackboard 7.3 on August 18, 2007. The UO was one of the first major Blackboard customers to adopt the new release. In addition to introducing the SafeAssign anti-plagiarism system, this upgrade included a "Voiceboard" feature collaboratively developed with the UO Yamada Language Center. In a December 21, 2007, upgrade, the system migrated from Oracle version 9i to 10g and became the first major non–Information Services UO system to use the new Information Services "LDAP" service for user authentication. A further major upgrade on August 16, 2008, installed Blackboard version 8.0, again positioning the UO as one of the early adopters of the latest Blackboard software.

The series of major Blackboard upgrades during 2007-08 was completed on schedule and within budget, without substantial downtime. More importantly, the upgrades provided a reliable platform for rapidly growing use of the course management system in instruction. During this period Blackboard experienced a year-to-year growth of 16% in number of CRN coursesites. The table below compares spring term usage in 2007 and 2008.

Blackboard is currently used as a component of more than three-quarters of all UO student credit hours and for more than 5,000 courses each year, with 90% of students enrolled in at least one Blackboard site.

Center for Educational Technologies and Media Services

Team members: Library Administration, Center for Educational Technologies (CET) staff, Media Services staff

Charge: Implement the CET/Media Services plan based on the consultant's report.

Summary

It was difficult to make progress on this initiative with the director of Media Services position still open. There is a need for stronger leadership in technologies, classroom support, etc. It is important to have a strong voice in the technologies being used on campus. Library Administration needs to determine what will happen with the director position before full implementation of the consultant's plan can proceed.

Consult on Technology Requirements for New Buildings

Team members: Andrew Bonamici (lead), Media Services staff

Charge: Consult on technology requirements for major building projects on campus, i.e., School of Music and Dance, College of Education.

Summary

Under a Memorandum of Understanding being reviewed for campus planning, when new classrooms are being built, contractors and architects will involve library audiovisual technology staff early on in the planning process. The library will be substantially involved in audiovisual procurement for the College of Education building; not so much for the School of Music and Dance.

Digital Collections

Team members: Cara List (lead), Karen Estlund, Joshua Kielas, Kirsten Hierholzer

Charge: Improve the access and usability of the library's digital collections. Redesign the Digital Collections primary home page, individual collection home pages, and the overall CONTENTDm user interface, with user access a primary objective. Provide better integration with the library's catalog.

Summary

Two new pages to improve access to the digital collections were developed or substantially revised: http://boundless.uoregon.edu/ and http://libweb.uoregon.edu/digilib/digcol_a-z.html.

Digital Images for Teaching

Team members: Ed Teague (lead), Cara List, Julia Simic, Lesli Larson

Charge: Expand access to digital images to meet current teaching needs. Determine standards, procedures, and infrastructure requirements for all aspects of the service, including image acquisition, description, data storage, training and development for library staff and end users, and assessment of contribution to student learning (continued from 2005 plan).

Summary

This initiative was completed and is now an ongoing library service. Content was developed for thirty-five image-intensive courses. There are now local databases with 70,000 digital images with art and architecture content, which support instruction and research in these fields. We have also acquired a commercial product, ARTstor, with another 700,000 images, to support research, study, and instruction in a wide variety of disciplines.

Distributed Downloading

Team members: Mary Grenci (lead), Sara Brownmiller, Rosemary Nigro

Charge: Implement Innovative Interfaces distributed downloading software module to replace our home-grown solution. Redesign associated work flows as necessary.

Summary

Implementation was completed. Work flow changes were minimal.

Diversity Plan

Library Diversity Committee members: Elizabeth Peterson (chair), Rosemary Nigro, Julia Simic, Melissa Logan, Xiaotong Wang, Laine Stambaugh (ex officio), Mark Watson (ex officio)

Charge: Make substantial progress in the implementation of the Library Diversity Plan.

Summary

There was an ambitious agenda for the Library Diversity Committee this year. Unfortunately, economics had some effect on which goals should receive top priority, such as those related to recruitment and retention. We were more successful in presenting two diversity-related programs, "Creating a Respectful Work Environment" and "Cultural Conversations" with department heads.

The Library Diversity Committee continues to struggle with notions of which goals are measurable and how success will be determined once those goals are met.

In fall of 2007, the UO Libraries' organizational leadership and development team, GOLD, was formed. As we move into 2008-2009 activities, GOLD will be taking on the responsibility for diversity-themed programming, thus allowing the Library Diversity Committee time to focus on administering and monitoring our progress on various components of the Library Diversity Plan. Setting goals and establishing realistic timelines should become clearer as we move ahead.

Faculty Services Website

Team members: Barbara Jenkins (lead), Shirien Chappell, Linda Hodgin, Nargas Oskui-Tabrizi

Charge: Contribute to faculty productivity by improving the faculty services website.

Summary

Major work on this will be done in summer 2008, for roll-out prior to fall term 2008.

Folklore Archives

Team members: Nathan Georgitis (lead), Elizabeth Peterson, Erin O'Meara, Harriett Smith, Linda Long, James Fox.

Charge: Collaborate with the UO Folklore Program on enhancing the visibility and accessibility of the Randall V. Mills Archives of Northwest Folklore, a regional repository of multi-format, ethnographic collections.

Summary

Progress was made in developing the collaborative relationship with the faculty in the UO Folklore Program and deciding on the initial priority of having books in the collection represented in the UO Libraries' catalog.

Gateway to Organizational Learning and Development (GOLD)

Team members: Laine Stambaugh (lead), Betsy Kelly, Tom Stave, and Karen Bankole

Charge: GOLD, or Gateway to Organizational Learning and Development, was established in October 2007, superseding the Staff Development Committee.

Web site

The GOLD web site was reorganized into a simpler format, and a "feedback" box was added for convenient access for staff members. A recently added Google calendar regularly displays GOLD meetings and upcoming events. Links provide a clearinghouse of resources and suggestions for learning more about the concept of organizational learning and development and why it is important to the work we do to provide the best service. Also added were simplified procedures and guidelines for requesting certain types of leave or funding directly from Library Administration.

Programming

Building on the information compiled in the 2006 Organizational Climate Survey conducted by the Assessment Team and the spring 2007 Staff Development Committee's survey, GOLD began an ambitious year of program planning. GOLD offered a total of fourteen programs and workshops between November 2007 and September 2008, among them: E-Mail Management Series, Managing Stress with Humor, Project Management Workshop, Millennium Overview and Millennium Create Lists, and Helping Student Workers Navigate Personal Problems. For a complete listing of programs and their corresponding evaluation feedback, see the first annual report on GOLD's web site.

Programs fell into four categories: (1) personal development, (2) professional development, (3) technical training, and (4) conference reports. This allowed for a variety of presentation types (formal versus informal), formats, and venues (such as the Collaboration Center).

Attendance was recorded at all GOLD programs except the more informal discussion groups. Tabulation of the available sign-in sheets indicates a total attendance of 233 library employees (135 classified staff members and 98 faculty members). Of those 233 attendees,

81 are different individuals. This means that about 50% of all permanent library employees attended one or more events.

Participant evaluations of programs and workshops indicated a preponderance of "excellent" and "good" results. Those evaluations also provided helpful feedback and suggestions for future programs.

Future Plans

Based on feedback from this first year, GOLD anticipates another busy schedule for 2008-09, with plenty of topics to develop that will be of interest to a variety of employees at all levels of the organization. By encouraging our employees to attend events of interest to them, we can reinforce the concept of continuous learning that will keep our staff best prepared and feeling confident about the important service they provide.

Interface for the UO Libraries' Catalog

Team members: Sara Brownmiller (lead), Lara Nesselroad, Lori Robare, Ted Smith

Charge: The initiative team was charged with recommending a new interface for the library catalog that improves the discovery experience for patrons. A next generation catalog, as it is frequently called, should give the patron a simple search interface, allow the patron to easily drill down through a results set to increase the precision of the results, allow the most relevant items to appear at the top of the results list, provide spelling prompts to help patrons locate items, and provide intuitive links to other library resources and discovery tools. Changes to the interface for the Summit service contributed to the interest in investigating a new interface at this time.

Summary

During fiscal year 2008, the team reviewed the features and functionality of five software applications that would help the library improve both searching and delivery of materials to our patrons. The Orbis Cascade Alliance selected WorldCat Navigator, offered by OCLC, as the new interface for the Summit catalog. OCLC offers a companion product, WorldCat Local, for individual libraries. With the Summit decision, the initiative team identified Encore, written by Innovative Interfaces, the library's current catalog software vendor, and WorldCat Local as the strongest candidates for additional review and investigation.

Law Collection Analysis

Team members: Eliz Breakstone (lead), Dave Fowler, Paul Frantz, Joni Herbst, Stephanie Midkiff, Ilona Tsutsui Charge: To conduct a collection analysis of the Law Library collections.

Summary

The Law Collection Analysis Initiative includes a collection inventory, a print and electronic overlap analysis, and the use of WorldCat Collection Analysis (WCA) to compare our holdings to those of peer institutions. This will forward the UO Libraries' Strategic Direction #2 by exploring new avenues for streamlining access to information for research and scholarship. With the data gathered during this initiative, we will write a curriculum-and research-driven collection policy that will increase access to a diverse collection of information and ensure that our users are connecting to the materials they need. The project will enable us to contribute to the growth of the UO Libraries while continuing to strengthen the legal education program at the law school. We envision that the UO Libraries will be able to leverage the programs developed during this initiative for similar library-wide projects.

The group's initial analysis of the law collection (using WCA) provided a starting point for the physical inventory, which began in fall 2008. Once the inventory is complete, adjustments will be made to the online public access catalog and to our WorldCat holdings, based upon the results. A final analysis of the collection will be accomplished, again using WCA, and the beginning and ending results will be compared. In addition, an overlap analysis of print and electronic holdings of treatises and monographs, journals, and state and federal codes and law reporters will be done. This is intended to become the basis of a cooperative article by the initiative participants. Finally, strategies will be developed for adding large quantities of electronic resources to the library catalog that, thus far, have not been added for various technical reasons.

Learning Commons (Law Library)

Team members: Angus Nesbit (lead), Mary Ann Hyatt, Mary Clayton

Charge: To expand the Learning Commons concept to focus on Law Library needs.

Summary

The 2007-09 UO Libraries planning initiatives included an initiative to "expand the Learning Commons concept to focus on Law Library needs, the Special Collections and Archives classroom, and the integration of ITCs into primary functions/space of Knight and Science Libraries." As the result of key enhancements to existing Law Library study rooms and open commons spaces in FY 2007-08, students and faculty increased their use of the law learning commons space and varied their purposes within the library generally. Specifically, the Law Library initiative members worked with law school audiovisual (AV) staff to provide video production support for several classes in the learning commons. The school's negotiation class added a section and intensified its use of video. The Legal

Research and Writing (LRW) program, while still calling upon the library's partnership with tech support's video production staff, extended its use of library space to include self-videotaping in our basic collaborative spaces. Drop-in individuals and groups flocked to the study rooms and open spaces that we outfitted with white boards, comfortable furniture, and (limited) AV enhancements. Commons spaces also accommodated the majority of tutoring sessions for both the LRW and Academic Choice for Excellence programs. Our growing collaboration with the law school technology department made it possible to improve learning technology in the commons. We observed that basic learning amenities such as white boards, task chairs, lounge seating, and video viewing capacity were the features most in demand.

Learning Commons (Special Collections)

Team members: James Fox (lead), Mark Watson

Charge: To expand the Learning Commons concept to focus on the Special Collections and Archives classroom.

Summary

The 2007-09 UO Libraries planning initiatives included an initiative to "expand the Learning Commons concept to focus on Law Library needs, the Special Collections and Archives classroom, and the integration of ITCs into primary functions/space of Knight and Science Libraries." In the spring of 2008 gift funding was earmarked for the Special Collections project, planning was completed, and the remodeling began.

Percent for Art Statewide Digital Collection and Database

Team members: Jaye Barlous (lead), Karen Estlund, Meagan Atiyeh (Oregon Arts Commission)

Charge: The Oregon Percent for Art Digital Collection was created to present a free, publicly available digital collection of images representing works of art funded through the State of Oregon's Percent for Art Program; to provide sufficient contextual information for each creation to enable the study, comparison, and general enjoyment of these works; and to create a permanent record of the collection by replacing deteriorating source materials with fully searchable and categorized, high-quality digital files.

Summary

We have digitally captured and archived 2,361 unique artwork images, encompassing 654 artists and 313 individual building projects. We have structured vital resources for the collection by building a dynamic, searchable list of 750 Library of Congress subject headings

and 215 collection-specific descriptive terms taken from the *Art & Architecture Thesaurus*. The database may also be searched by artist, medium, location, and award year. Enhanced details about complex pieces, including artist statements, résumés, and documentation of installations, are accessible for selected works. Because this digital collection represents public artwork located in multiple public buildings, an interactive map page was created to illustrate the logistical relationship between sites. The collection is a great resource for art students, allowing them to discover how their own work fits into the program while learning about the real-world aspects of making a proposal and applying for a public art award. There are viewable examples of composition and media characteristics, techniques, and attributes to examine. Other students, researchers, and the general public are presented with paradigms illustrating the critical thinking skills that underscore design, problem solving, mechanical engineering, and the creative process.

The project was sponsored with a Library Services and Technology Act grant from the Oregon State Library. The relationship of the UO Libraries with the Oregon Arts Commission extends beyond the life of the grant. The collection will continue to grow on a quarterly basis with approximately ten new building projects each quarter.

Portland Library and Learning Commons

Team members: Library Administration (lead), Library Development, Library Systems, Library Personnel, Metadata Services and Digital Projects, Center for Educational Technologies, Media Services, etc.

Charge: To create an expanded library and learning commons in Portland, in the White Stag facility.

Summary

The development of this facility required substantial effort from many people in the library as well as others from across campus. The Portland Library and Learning Commons is the central community space for the UO Portland program. The facility was ready for occupancy for spring term 2008 with a soft opening (only a few courses were offered). Karen Munro was hired as the director. Furnishings were installed, collections were moved, and searches for additional staff were underway and, in some cases, completed. This operation will

expand substantially over the summer in anticipation of a full range of course offerings for fall term 2008.

Scholarly Communications Program

Team members: Mark Watson (lead), Heather Briston, Victoria Mitchell, JQ Johnson, Deb Carver

Charge: To launch a formal scholarly communications program; define a new position to lead this effort and complete the search and hiring process; develop the core aspects of the program; and define organizational (and individual) responsibilities.

Summary

By the end of fiscal year 2008, the position of Director of Scholarly Communications was defined and JQ Johnson was appointed.

Subject Specialist Portal

Team members: Katy Lenn (lead), Dave Fowler, Jeff Staiger, Dean Walton

Charge: To develop a communication portal for subject specialists, focused on best practices, experiences, and practical advice relating to instruction, collection development, and outreach.

Summary

The committee elicited comments and suggestions from subject specialists, then merged the existing Acquisitions blog with additional content including frequently used web sites, both internal and external. We recommended assigning the responsibility for maintenance of the site to a single point person. As the site serves the needs of subject specialists, this administrator should be a subject specialist. To provide some continuity, the position of site administrator should be a two-year appointment. Committee member Jeff Staiger agreed to serve as the first administrator.

Assessment Projects

Special Collections Pilot Project: Developing Standardized Metrics for Assessing Use and User Services for Primary Sources

Team members: Heather Briston (lead), James Fox, Special Collections staff

The University of Oregon Special Collections and University Archives, led by James Fox, has been one of the nine partner institutions helping to test and develop user evaluation tools. In the fall of 2007, the staff conducted a test of the Archival Metrics Reading Room Researcher Questionnaire. Other university archives and special collections departments that have also tested this questionnaire include the Bentley Historical Library at the University of Michigan, the Wilson Library at the University of North Carolina, Penn State's Department of Special Collections, the Yale University Department of Manuscripts and Archives, and the Arizona State University Archives. The staff revised the generic version of the researcher survey to customize it for the University of Oregon. The survey ran for a two-week period, ending November 7, 2007. Seventy-five individuals who visited the reading room were offered the survey, and thirty-five returned responses for a response rate of 46.66%.

South Reading Room Project

Team members: Matt Merriman (lead), Andrea Coffman, Nancy Slight-Gibney, Laura Willey

The goal of this project was to determine how the south reading room can be improved to better meet users' needs. The project had three steps: initial observations, focus groups, and a survey.

Students use the Knight Library as a work place. It is where they come to study, meet with a group, or use a computer. It is no surprise that their suggestions are largely practical in nature. The most common recommendations are things that would make their time at the library as efficient and effective as possible. Far and away, the two items students are asking for more than anything else are additional places to sit and greater availability of power outlets for their laptops. Almost half of survey respondents (47%) indicated that they rarely use the library's collections (books, periodicals, reserves, etc.). The library's greatest use is as a quiet place to study, whether it is individually or with a group. Almost 85% of respondents frequently study in the library by themselves and 58% bring their own computers. Without adequate places to work or enough outlets for their laptops, the library is less valuable to these students.

The lower priority recommendations are also practical in nature. These include adding more computers (primarily desktop) and printers and improving the lighting. The need for additional computers is much greater than a first glance at the survey results indicates. Excluding the 58% of library users who indicate that they use their own computer in the library, the second most popular recommendation is to add more computers. The fact that

many students work on a personal laptop hides the finding that those who use library computers believe the demand for library computers well exceeds their availability.

The ideas that generated the least amount of excitement with students are primarily the ones dealing with the aesthetics of library spaces. It is not that library users are particularly satisfied with the library's appearance; it's that adding artwork and display cases will not help students with their studies.

Recommendations

- 1. <u>Add more places to sit</u>. Lack of adequate study area is one of the greatest concerns of library users. Many have trouble finding seating during the library's peak times.
- 2. <u>Increase the availability of power outlets</u>. All new tables and workstations should have built-in power outlets. More students are bringing laptops to school each year.
- 3. Add a few desktop computers. Demand currently exceeds supply.
- 4. <u>Do not purchase display cases</u>. Only 3% of respondents listed display cases or additional exhibit areas as their top priority. Additionally, turning the south reading room into an exhibit space will increase traffic and distract those who choose to study there because of its designation as a quiet space.

Review of Public Rooms in the Knight Library

Team members: Laura Willey (lead), Michael Thompson, Circulation/Reserves student staff

During winter term 2008, staff in the Knight Library undertook a use survey of the public rooms in the Knight Library. Safety Staff from the Circulation/Reserves work unit recorded the number of users in each room during most hours of inspection from the middle of week three to the end of finals week. This resulted in 279 recorded usage counts.⁸ For further discussion of this project, see the "Facilities" section of this annual report.
